- 1. **CALL TO ORDER –** Chair Guardarrama called the meeting to order at 5:01 p.m.
 - A. Chair Guardarrama led the Pledge of Allegiance.
 - B. Roll Call:
 - PRESENT: Task Force Members: Ralston, Kanin, and Guardarrama.

 ALSO PRESENT: City Clerk Crowder and Assistant City Attorney Crosthwaite
 - C. Approval of the Minutes: The Task Force approved the minutes of January 6, 2020. Motion by Task Force Member Kanin, seconded by Ralston, and approved.
- 2. PUBLIC COMMENT: None.
- **3.** Discussion of Task Force Work Plan and Items for Task Force Consideration at Future Meetings:

City Clerk Crowder introduced Assistant City Attorney Crosthwaite to the Task Force.

City Clerk Crowder provided background information on the discussion topics. She noted that the "Consideration of Limitations on Co-Sponsorships with Organizations that Endorse Candidates in City Council Elections" is a priority item so that staff can bring an item to the City Council for formal consideration. She shared a document outlining the priorities for the Task Force:

- Co-Sponsorships
 - Organizations/Persons Endorsing City Council Candidates
 - Co-Sponsorship Policy Best Practices Conflicts of Interest
- Filing of Campaign Communications
- Adding the list of registered lobbyists to the City's website
- Consideration of Lobbyist Amendments (Continue Discussion from January 2020)
- Contract between the City and the Fair Political Practices Commission for Enforcement Services
- Exploration of a Public Financing System
- Consideration of Limitations on Campaign Contributions by Developers (We left off that until there was evidence of an issue that this would not be addressed.)

Chair Guardarrama inquired if the Task Force can conduct three (3) meetings and break the meetings up as follows:

- 1) Co-Sponsorships and the Fair Political Practices Commission Contract for Enforcement Services
- 2) Campaign Finance Filing of Campaign Communications, Exploration of a Public Financing System, and Consideration of Limitations on Campaign Contributions by Developers
- 3) Adding the List of Registered Lobbyists to the City's Website and Consideration of Amendments to the Municipal Code Regarding Lobbyist Amendments

Task Force Member Ralston asked which items were referred to the Task Force by the City Council. City Clerk Crowder indicated provided a list of the items that required further consideration based on the City Council discussion from February 3, 2020.

Task Force Member Kanin indicated his support for breaking the topics up as outlined above.

SUSAN MILROD, WEST HOLLYWOOD, spoke regarding the proposed development at 8850 Sunset. She further expressed concern with campaign contributions from individuals outside of West Hollywood.

DAVID GOLDSCHMID, WEST HOLLYWOOD, spoke regarding campaign finance reform.
