- 1). Board members received report from David Giugni, Social Services Manager and responded to the questions regarding social services priorities for the Russian-speaking community and made recommendations:
- I.What are the significant social services needs of the constituency your Board represents?
  - 1. Aging in Place more information regarding services and resources
  - 2. Affordable housing information for senior residents who do not have access to digital devices.
  - 3. Digital divide and language barrier is still an issue for many residents, so access to the information on tenants' rights, and other resources for "non-digital" users (flyers, TV announcements, etc).
  - 4. More education regarding not only vaccination but medical issues and safety as well as response to safety concerns.
  - 5. Discounted internet service and technology education
  - 6. Better communication between JFS and city staff (Recreation)
- II. What is the most accessible way for the community to receive information?
  - 1. Mailings in English and Russian language (both regular mailing and emailing)
  - 2. Flyers in the senior buildings in English and Russian. (There are about 17 buildings for seniors and people living with disabilities in the city-reach out to the residence managers)
  - 3. Reach out to the younger generation: children, grandchildren (caregivers...maybe)
- III. Which are other barriers for the Russian speaking community
  - 1. Prefer to come to City Hall and speak to the live person in Russian, seniors rarely leave messages.
  - 2. Many do not have internet and do not use smart phones or other electronic devices.
  - A newsletter in Russian and English that residents will be expecting a few times a year would be beneficial. (JFS publish a newsletter, but it goes out to their list)
