  - B. **Update on Dockless Mobility Pilot Program**

Recommendation: Direct staff to turn the Dockless Mobility Pilot Program into a regular city program with up to 5 total operators that include a variety of devices such as bicycles and scooters, as well as accessible devices. Staff also recommends the Transportation Commission recommend the City engage with a private contractor to manage the dockless mobility program, including procurement of operators through a new application process, day-to-day management as well as station construction.
