#### A. 8850 SUNSET BOULVARD:

The applicant requests demolition of four one-and two-story commercial buildings that span a full city block over seven parcels on the south side of Sunset Boulevard. This latest Alternative Project is proposed as an alternative to a previously reviewed mixed-use development.

This alternative now includes 12 stories/175 ft in height that accommodates 116 hotel guest rooms and one presidential suite, 26 condominiums and 8 income restricted units over ground floor and basement level commercial uses that include (i.e. restaurant, café, new Viper Room lobby entry, and hotel lounge) and an extensive basement area consisting of five subterranean levels, one level incorporating the new Viper Room night club and recording studio and sunken hotel lobby and wellness center, and three others are parking levels.
