# A. UPDATE ON THE LOS ANGELES COUNTY DEPARTMENT OF PUBLIC HEALTH AND CITY EXECUTIVE ORDERS AND ITEMS RELATED TO BUSINESSES.

Acting Director of Public Works, Danny Rivas, touched on the Health Officer Order update and encouraged the Comission to reach out for questions/concerns. He then provided a summary of logistics regarding the transition from telecommunication to inperson Business License Commission meetings at the Council Chambers.

Commissioner Yusupov, requested to know if all City Commissions would be meeting in-person. Acting Director of Public Works, Danny Rivas, responded.

Chair Saltzman, suggested that staff continue to provide a monthly update on the Health Officer Orders. Acting Director of Public Works, Danny Rivas, agreed.

Acting Director of Public Works, Danny Rivas, pointed to the Business Tax Certificate data provided in the staff report dated Apil 5, 2022. Commissioner Lo suggested this information be provided yearly.

Acting Director of Public Works, Danny Rivas, informed the Commission of the success the Bystander Intervention Training has had with the business community and thanked Staff for making the training a success.

Commission Eisenberg, inquired about the undercover program, provided by the West Hollywood Sheriff's Department, mentioned during the last City Council meeting. Acting Director of Public Works, Danny Rivas, responded.

Commissioner Alden, expressed her gratitude for the Bystander Intervention Training (BIT), shared her personal experience in having been targeted, and expressed concern with human trafficking. Commissioner Lo echoed Commissioner Alden concern. Acting Director of Public Works, Danny Rivas, thanked the Commissioners and informed them that UCLA Rape Treatment Center, host of the BIT, is the only Rape Treatment Center on the westside of Los Angeles County. He then stated that the City would be providing GHB testing strips to members of the public at City's upcoming special events.

Commissioner Eisenberg, suggested that, given the number of on-site alcohol serving businesses, the City of West Hollywood have its own Rape Crisis Center. Acting Director of Public Works, Danny Rivas, responded.

Vice Chair Matos, expressed his gratitude to Commissioner Alden for sharing her experience and to the city staff for their efforts.

Vice Chair Matos, suggested that the request to have random inspections conducted by Code Enforcement, ensuring cannabis businesses are abiding by all security operation conditions, be formalized. Commissioner Vulin agreed and expressed concern about implementing the patrol inspection for licenses that have already been approved. Acting Director of Public Works, Danny Rivas, responded.

Commissioner Lo, thanked City Council for rescinding the COVID-19 mandates and keeping the City safe.

Code Compliance Supervisor, Yessica Benitez, requested that the Commission contact Staff if an Official Business Parking permit is needed for the upcoming Commission meetings.

Commissioner Lo, requested to know when the West Hollywood Park pool would be open. Acting Director of Public Works, Danny Rivas, responded.
