

RESOLUTION NO. 22-5498

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD, CALIFORNIA, ESTABLISHING AN ANNUAL MINIMUM WAGE INCREASE BY THE CONSUMER PRICE INDEX FOR URBAN WAGE EARNERS AND CLERICAL WORKERS (CPI-W) PURSUANT TO WEST HOLLYWOOD MUNICIPAL CODE SECTION 5.130.020

THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. Recitals.

A. On November 15, 2021, the City Council adopted the Citywide Minimum Wage Ordinance (Ord. No. 21-1168), which is codified in West Hollywood Municipal Code Chapter 5.130 ("Ordinance").

B. The Ordinance provides that beginning on July 1, 2022, and each July 1 thereafter, the minimum wage shall increase based on the Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W).

C. The Ordinance further provides that by April 1 of each year, the City shall publish and make available to employers a bulletin announcing the adjusted minimum wage rate, to take effect July 1 of that year.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD DOES HEREBY FIND, DECLARE, RESOLVE, AND ORDER AS FOLLOWS:

Section 2. The annual minimum wage increase shall be based on the Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W), Los Angeles Metropolitan area, currently named "Los Angeles-Long Beach-Anaheim, CA".

Section 3. The annual minimum wage increase shall be no less than 1.00% and no more than 4.00%.

Section 4. The adjusted minimum wage rate for July 1, 2022, through June 30, 2023 ("FY23") is established at \$18.35 based on the calendar year 2021 annual change of the Non-Seasonally Adjusted, All Items Consumer Price Index for Urban Wage Earners and Clerical Workers for the Los Angeles-Long Beach-Anaheim, CA area.

Section 5. Hotel Employers shall pay Hotel Workers no less than the hourly minimum wage rate established in Section 4 of this Resolution for FY 2022-23.

Section 6. Employers with 50 Employees or more and Employers with less than 50 Employees shall pay Employees no less than the minimum wage rate as set forth in West Hollywood Municipal Code Section 5.130.020 for FY 2022-23.

Section 7. For purposes of this Resolution, capitalized terms including Hotel Employers, Hotel Workers, Employers, and Employees shall have the same definitions as set forth in West Hollywood Municipal Code Sections 5.130.010 and 5.130.020.
