HAYDEN ALEXANDER, WEST HOLLYWOOD, spoke about various topics.

YOLA DORE, WEST HOLLYWOOD, spoke in support of a Planning Commissioner.

RICCI SERGIENKO, UNKNOWN, spoke about deputy gangs in the Los Angeles County Sheriff's Department and in opposition to the proposed contract between the City and the Los Angeles County Sheriff's Department.

LAURA C., UNKNOWN, spoke in support of the Public Safety Commission's recommendation to reallocate funds from the contract between the City and the Los Angeles County Sheriff's Department to social services.

COUNCILMEMBER COMMENTS AND MEETING ATTENDANCE REPORTS:

Councilmember Erickson announced that there was a draft ruling released by the Supreme Court overturning Roe V. Wade. He expressed his commitment to fight for women's reproductive rights.

(7:22 p.m.- Councilmember Erickson indicated that due to the draft Supreme Court decision in the matter of Roe v. Wade, he needed to step away and will return as soon as possible.)

Mayor Pro Tempore Shyne commented on the potential overturning of Roe v. Wade by the Supreme Court. She remarked the City will partner with Los Angeles County and that the City has worked on an action plan in anticipation of this ruling. She wished her Muslim community a happy Eid al-Fitr which marks the end of Ramadan. She wished community members a happy Jewish American month, Asian American month, Senior month, and Historic Preservation Month. She thanked colleagues for bringing forward Items 5.A. and 5.B. Regarding Item 2.G., she requested that staff remove the word "cisgender" when referring to women or Transgender women because all women are women, and the City should be mindful about being exclusionary. She commented about Planning Commission Chair's Lynn Hoopingarner's comments about Iranian American weddings during the April 28 Planning Commission Design Review Subcommittee meeting which led to her resignation from the Planning Commission. She thanked Chair Hoopingarner for her written apology and for her service on the Planning Commission. She requested an update from the City Manager on the Code of Conduct for Elected and Appointed Officials. She requested further training on antisystemic racism for elected and appointed officials. She noted that she plans to bring an item at a future City Council meeting for a panel discussion on racism. She also requested that the City Manager provide an update on the Block by Block contract and the increase that was approved by the City Council.

Councilmember Horvath inquired if the property owner was notified regarding Item 5.A. She also inquired if a consultant is necessary as part of Item 5.C. She shared that the City is consulting with StrategyCorp for a community safety and wellbeing study. She responded to one of the public commenters regarding her previous comments about the treatment of Commissioner Soon-Shiong. She reported her attendance at Dance for Life to celebrate and raise money for the City's AIDS monument. She congratulated the Rainbow Bar and Grill on their 50-year celebration. She thanked City employees for their service to the City and noted her attendance at the Employee Recognition Luncheon on Thursday, April 28. She spoke about the Fundraising Musical Concert for Refugees from Ukraine this past Sunday. She spoke about the Supreme Court draft decision in the matter of Roe v. Wade. She shared that this is another opportunity for the City to show allyship. She is grateful to Planned Parenthood and spoke about the importance of keeping and protecting Planned Parenthood in our community.

Councilmember D'Amico spoke regarding Items 5.A. and 5.B. He also commented on the draft Supreme Court decision regarding Roe v. Wade, specifically that men need to support women's rights.

Mayor Meister commented on the draft Supreme Court decision on Roe v. Wade. She shared that the City is in the process of hiring a lobbyist and that the new lobbyist will advocate on behalf of the City at the federal level. She reported her attendance at the Sanitation District Personnel Committee meeting, Laurel House Subcommittee meeting, and the Homelessness Subcommittee meeting. She noted that she presented a Proclamation at the celebration of life event for Irene Soderberg. She attended the Rainbow Bar and Grill's 50th anniversary, and the Eastside Neighborhood Watch Group meeting. She also attended the City's Employee Recognition Event and congratulated Employee of the Year Tjader France. She attended the Lesbian & Queer Women's Visibility Event and judged the dog competition. She spoke about the Fundraising Musical Concert for Refugees from Ukraine on Sunday. She mentioned Item 2.M. noting that the event promotes dog adoption and advocates against the dog meat trade. She spoke about the City's Homeless Initiative. She briefly discussed the resignation of Planning Commissioner Lynn Hoopingarner and her comments made at the April 28 Design Review Subcommittee meeting.

CITY MANAGER'S REPORT:

City Manager Wilson responded to City Council inquiries made during Councilmember Comments. He shared that the City is continuing the Community Clean Up events. He noted that the Dockless Mobility Plan survey is open. He also shared that the WeHo Pride Arts Festival starts May 22, and more information can be found at www.weho.org/pride.

Events Services Manager Cleo Smith, Event Services Supervisor Megan Reath, and Jeff Consoletti provided a planning update on West Hollywood Pride.

Councilmember Horvath requested that Item 5.A. be Tabled to the May 16 City Council meeting to notify the property owner before the City Council takes action. The City Council indicated that the item can be on the Consent Calendar.

FISCAL IMPACT ON CONSENT CALENDAR:

City Clerk Crowder stated that the fiscal impact on the Consent Calendar with the addition of Items 4.A., 5.B., 5.C., and 6.A. is \$6,852,700 in expenditures, \$0 in revenues, and (\$3,710) in waived fees.

SUBJECT: The City Council will hold a public hearing to consider a Zone Text Amendment to amend the R1A and R1C zone district requirements to allow certain single family residentially zoned lots to be subdivided into two lots, and for two dwelling units to be built on each of those lots, in accordance with SB9, a recent change to state law that is already in effect.

6. LEGISLATIVE:

6.A. RESOLUTION AUTHORIZING THE CITY MANAGER TO ADOPT A RECOVERED ORGANIC WASTE PRODUCT PROCUREMENT POLICY TO COMPLY WITH THE REQUIREMENTS OF SB 1383 [J. ROCCO, D. RIVAS, Z. POLLARD, M. MAGENER, L. QUIJANO, C. CORRALES, B. ROSENI:

SUBJECT: The City Council shall consider adopting a resolution authorizing the City Manager to adopt a recovered organic waste product

procurement policy to comply with the requirements of Senate Bill ("SB") 1383.

ACTION: This Item was moved to the Consent Calendar.

6.B. AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD, CALIFORNIA, AMENDING SECTIONS 5.130.020, 5.130.030, AND 5.130.080 OF THE WEST HOLLYWOOD MUNICIPAL CODE REGARDING IMPLEMENTATION OF THE CITY-WIDE MINIMUM WAGE [D. WILSON, P. KESPRADIT, L. LANGER, J. LEONARD]: SUBJECT: The City Council will consider approving an Ordinance amending West Hollywood Municipal Code Chapter 5.130 Minimum Wage to revise the calculation of number of employees; provide a maximum cap for compensated leave; eliminate cash payment for compensated leave accrued over the maximum; and apply the one-year waiver to the compensated leave provisions.

Director of Economic Development John Leonard provided background information as outlined in the staff report dated May 2, 2022.

Councilmember Horvath inquired if her colleagues are amenable to implementing the leave provision portion of the ordinance to a later date.

Mayor Meister inquired if staff has a sense of the number of businesses that plan to request a waiver. Mr. Leonard responded.

Mayor Pro Tempore Shyne noted that she is open to discussing a later implementation date. She supports the recommended changes in Section 5.130.080 (A). For Section 5.130.080 (B), she supports a total of sixmonth for compliance broken up into three-month segments.

Councilmember D'Amico does not support changing the implementation date. He noted that if businesses are unable to implement the changes by July 1, 2022, they can request a waiver.

ZEKIAH WRIGHT, WEST HOLLYWOOD, spoke in support of the July 1 implementation date.

Mayor Pro Tempore Shyne made a motion to change part B to a total of six months with a three-month implementation period and if they need an additional three months, they can apply for a waiver with the City Manager.

City Manager Wilson suggested that the implementation date change to October 1 and if more time is needed by a business, they can apply for a waiver.

Mayor Meister agreed with the City Manager's recommendation.

She noted that incorporated businesses usually start their fiscal year on October 1; otherwise, January 1.

Councilmember D'Amico requested a friendly amendment to keep the July 1 implementation date; however, if by October 1 they have not implemented it then they need to apply for a three-month waiver.

(Councilmember Erickson returned to the dais at 8:43 p.m.)

STEVE MARTIN, WEST HOLLYWOOD, spoke in favor of Councilmember D'Amico's amended motion.

Councilmember Horvath commented that workers will be expecting to begin accruing on July 1 which may cause legal ramifications. She expressed concern about the penalty if businesses do not implement on July 1.

Councilmember Erickson commented on the Chamber of Commerce's Independent Expenditure committee to overturn this ordinance. He does not support extending past July 1; however, he supports the 3-month waiver. He stated the City Council compromised with the businesses on several of their concerns expressed since the City Council began discussing the implementation of this ordinance.

Mayor Pro Tempore Shyne amended her motion to:

- 1) Implement on July 1
- 2) Change Section 5.130.080 (B) to allow for a three-month extension by waiver with the City Manager
- 3) If after the three-month extension they cannot comply, they can apply for another three-month.

The motion was seconded by Councilmember D'Amico.

Mr. Leonard read the change to Section 5.130.080 (B) of the ordinance into the record:

"The City Manager or their designee may grant up to a one-year waiver based on the first hardship condition (financial hardships). The City Manager or their designee may grant up to two three-month waivers based on the second hardship condition (implementation hardships due to existing payroll and human resources processes and platforms), provided the second three-month waiver shall only be granted if implementation hardships remain and the Employer has made diligent progress towards implementing the provisions. Total waivers granted pursuant to this subsection shall not exceed one year."

ACTION: Introduce on First Reading Ordinance No. 22-1180: "AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF WEST

HOLLYWOOD, CALIFORNIA, AMENDING SECTIONS 5.130.020, 5.130.030, and 5.130.080 OF THE WEST HOLLYWOOD MUNICIPAL CODE REGARDING IMPLEMENTATION OF THE CITY-WIDE MINIMUM WAGE." Motion by Mayor Pro Tempore Shyne, seconded by Councilmember Erickson, and approved, noting the "no" vote of Mayor Meister.

PUBLIC COMMENT: None.

COUNCILMEMBER COMMENTS:

Councilmember Erickson clarified that the Supreme Court draft decision in the matter of Roe v. Wade that was reported on by Politico is a draft decision, and that the rights provided in Roe v. Wade continue to be current law.

Mayor Meister added an additional adjournment request for Naomi Judd.

ADJOURNMENT: The City Council adjourned at 9:03 P.M. in memory of Robbie Rutstein, Paul Rakos, Terrence Lee Jones, and Naomi Judd to its next regular meeting, which will be on Monday, May 16, 2022, at 6:00 P.M. at West Hollywood Park Public Meeting Room - Council Chambers.
