1. CALL TO ORDER

3. APPROVAL OF THE MEETING AGENDA FOR JANUARY 27, 2022, 2021

Lakeisha McGee, Founder of the Heal Her foundation, spoke about the non-profit organization. She shared that they organize exclusively for women's needs, including but not limited to economic security, freedom from violence, addiction, and enhancing access to health services and information and education. She expressed interest in partnership with the Board.

David Giugni provided an overview of the City's social services funding cycle and asked the Women's Advisory Board to input social services priorities. Joan Mithers, Social Services Program Administrator presented questions.

The Women's Advisory Board provided input to Social Services staff on the social service needs of Women community members.

Larissa Fooks, Staff Liaison, provided background information on the history of the annual Herstory Awards.

ACTION: Motion made by Boardmember Payton seconded by Boardmember Moore to endorse the annual Herstory Awards honoring a local women leader, presented by the Hollywood Chapter of the National Organization for Women during March as part of National Women's History Month.

Larissa Fooks, Staff Liaison, reported on the status of the events for the National Women's History Month.

Board members delignated the selection of the two Women's History Month selection to the subcommittee by consensus.

The Board agreed by consensus not to host a virtual event for the Women's Leadership Awards until the City can host an in-person event.
