3. PUBLIC HEARINGS:

3.A. ASSESSMENT OF DELINQUENT SOLID WASTE FEES OWED TO ATHENS SERVICES ONTO THE PROPERTY TAX BILL OF FOUR DELINQUENT ACCOUNT HOLDERS [O. DELGADO, S. PERLSTEIN]:

The City Council will consider whether or not to request the County Auditor to assess the property tax bills of four delinquent solid waste account holders.

City Clerk West stated that the Item was noticed as required by law.

Sharon Perlstein, City Engineer, provided background information as outlined in the staff report dated June 7, 2010.

Mayor Heilman opened the public hearing and no speakers came forward.

Mayor Heilman closed the public hearing.

ACTION: Direct the Director of Finance to submit the required information to the County Auditor for the purpose of assessing the delinquent solid waste amount, plus a \$120.00 administrative fee, onto the property tax bills of the delinquent account holders. **Motion by Councilmember Land, seconded by Councilmember Horvath and approved with Councilmember Prang being absent.**

3.B. REVIEW OF THE CITY SEWER SERVICE CHARGE FOR FISCAL YEAR 2010-11 [O. DELGADO, S. PERLSTEIN]:

The City Council will consider approving the City Sewer Service Charge rates for the FY 10-11 program.

City Clerk West stated that the Item was noticed as required by law.

Sharon Perlstein, City Engineer, provided background information as outlined in the staff report dated June 7, 2010.

Mayor Heilman requested clarification regarding the proposed rates in comparison to other neighboring cities.

Mayor Pro Tempore Duran requested clarification regarding infrastructure and possible health issues in relation to the City's sewer system. He requested clarification regarding past incidents in relation to the City's sewer system. Mayor Pro Tempore Duran requested clarification of the specifics of Proposition 218.

Councilmember Land requested clarification regarding the phase-in of pipe maintenance and prevention efforts in relation to the City's sewer system.

Councilmember Horvath requested clarification regarding the timeline for the proposed sewer improvements and whether they will occur during the next fiscal year.

Mayor Heilman opened the public hearing and the following speakers came forward:

PARVIZ EZHARI, WEST HOLLYWOOD, spoke in opposition to the Item.

ROB BERGSTEIN, WEST HOLLYWOOD, expressed concerns regarding the proposed rate increases.

JOEL LEVIN, LOS ANGELES, expressed concerns regarding the proposed sewer rate increases and the lack of an annual rental rate increase for the next year.

DONALD ELMBALD, WEST HOLLYWOOD, expressed concerns regarding the proposed sewer rate increases and the lack of an annual rental rate increase for the next year.

DANIELLE EREM spoke in opposition to the Item.

RITA ISAKOVA, WEST HOLLYWOOD, spoke in opposition to the Item, and spoke regarding a major sewer repair at her property.

ROXANNE MCBRYDE, WEST HOLLYWOOD, expressed concerns regarding the proposed rate increases for single family homes in relation to multi-unit buildings.

LAUREN MEISTER, WEST HOLLYWOOD, spoke in opposition to the Item.

ALAN BERNSTEIN, WEST HOLLYWOOD, spoke in opposition to the Item.

ART NASTA, NORTHRIDGE, spoke in opposition to the Item.

KIM SCHNEIDER, WEST HOLLYWOOD, spoke in opposition to the Item.

DAVID HILL, WEST HOLLYWOOD, spoke in opposition to the Item.

Mayor Heilman requested clarification regarding public comment surrounding placing sewer rate increases on the ballot during the City's General Municipal Election. Councilmember Land requested clarification regarding public comment surrounding the possibility of placing a sunset clause on the rate increases.

Councilmember Horvath requested clarification regarding public comment surrounding a major sewer repair at a property in the City. She requested clarification regarding the rates for single family homes in relation to multiunit buildings. She requested clarification regarding the proposed percentages of the rate increases.

Councilmember Land spoke in support of placing a sunset clause on the rate increases. She expressed concerns regarding the proposed percentages of the rate increases. She spoke in support of the need to continue to invest in the City's infrastructure, and the need for some rate increase. She spoke in support of the possibility of a gradual phased-in rate increase.

Mayor Pro Tempore Duran expressed concerns regarding an increase in rates at this time. He spoke regarding the need to continue to make improvements to the City's sewer system. He spoke in support of deferring the rate increase. He spoke in support of tabling the Item. He spoke regarding the possibility of creating a triage approach to sewer repairs in the City to extend the repairs over time.

Councilmember Horvath spoke in support of deferring the rate increase. She expressed concerns regarding the proposed percentage of the rate increases. She spoke in support of the possibility of a gradual phased-in rate increase.

Mayor Heilman spoke regarding the City's past efforts to maintain the infrastructure and the positive effects of that maintenance on property values in the City. He spoke in support of the need to maintain and repair the City's sewer system. He spoke regarding recent sewer repairs in his condominium building. He spoke regarding the possibility of higher costs in the future if the sewer system is not maintained. He spoke in support of the possibility of a gradual phased-in rate increase.

ACTION: 1) Continue the public hearing to the meeting of June 21, 2010; and 2) direct staff to return to Council with alternative proposals for possible sewer service charge increases and alternative funding for sewer repairs in the City. **Carried by Consensus of the Council.**

3.C. THE AVENUES – ART, FASHION & DESIGN DISTRICT - IMPLEMENTATION OF REQUIREMENTS OF THE PARKING AND BUSINESS IMPROVEMENT AREA LAW OF 1989 [J. HUFFER, M. LOUIE]:

The City Council will conduct a public hearing and consider adopting a resolution to establish The Avenues – Art, Fashion & Design District assessment for fiscal year 2010-2011 and approving an agreement with the West Hollywood Marketing and Visitors Bureau to administer the program.

City Clerk West stated that the Item was noticed as required by law.

Maribel Rios Louie, Economic Development Analyst, provided background information as outlined in the staff report dated June 7, 2010.

Mayor Heilman opened the public hearing and the following speakers came forward:

RYAN FARBER, LOS ANGELES, spoke in support of the Item.

DARRAN GOLD, LOS ANGELES, spoke in support of the Item.

Mayor Heilman closed the public hearing.

ACTION: 1) Adopt Resolution No. 10-4030, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD CONFIRMING THE REPORT OF THE ADVISORY BOARD, AND LEVYING AN ASSESSMENT FOR FISCAL YEAR 2010-2011 IN CONNECTION WITH THE AVENUES - ART, FASHION & DESIGN DISTRICT"; 2) Approve supplemental funding in the amount of \$15,000 from Economic Development budget, to be matched by the West Hollywood Marketing and Visitors Bureau toward supporting The Avenues FY 2010-2011 work program; and 3) Approve an Agreement for Services between the City and the West Hollywood Marketing and Visitors Bureau to administer the 2010-2011 Avenues of Art and Design BID work program and; authorize the City Manager to sign the agreement. Motion by Mayor Pro Tempore Duran, seconded by Councilmember Land and approved with Councilmember Prang being absent.

City Clerk West stated that the Item was noticed as required by law.

Jeffrey Huffer, Economic Development Manager, provided background information as outlined in the staff report dated June 7, 2010.

Mayor Heilman opened the public hearing and the following speakers came forward:

HUFFER, M. LOUIE]: The City Council will conduct a public hearing and consider adopting a resolution confirming a diagram and the levy of assessments for the Santa Monica Boulevard Maintenance District for fiscal year 2010-2011.

City Clerk West stated that the Item was noticed as required by law.

Maribel Rios Louie, Economic Development Analyst, provided background information as outlined in the staff report dated June 7, 2010.

Mayor Heilman opened the public hearing and no speakers came forward.
