Hi Joy,

The current funding for DCRC includes .75 full-time equivalent staff to provide Case Management services. The current scope of service has a goal for case management of 20 members per year.

The proposal included 1.1 full-time equivalent staff to provide the same level of service. Staff is not recommending a funding increase beyond the 2% cost of living.

Hi Joan,

Hope you had a nice weekend. I wanted to touch base with you regarding DCRC funding. Staff recommended keeping the current funding with a 2% COLA increase, including the \$8,000 Home Secure Funds totaling \$63,964.

The requested \$81,167 included a case manager, which staff didn't recommend funding - is that correct? Bringing it down to \$63,694.
