

ORDINANCE NO. 22-1186

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD, ADOPTING AMENDMENTS TO TITLE 19, ZONING ORDINANCE OF THE WEST HOLLYWOOD MUNICIPAL CODE, TO ALLOW RESTAURANTS TO SELL ALCOHOLIC BEVERAGES FOR ON- AND OFF-SITE CONSUMPTION INCLUDING OFF-SITE ALCOHOL CONSUMPTION FOR TAKEOUT VIA PICK UP IN ACCORDANCE WITH RECENTLY ADOPTED STATE LAW (SB 389) AND TO STREAMLINE THE REVIEW PROCESS FOR ALL ON- AND OFF-SITE SALES, SERVICE AND CONSUMPTION OF ALCOHOLIC BEVERAGES IN COMMERCIAL ZONES AND THE R3C-C ZONE IN THE CITY OF WEST HOLLYWOOD AND FINDING THE ACTION CATEGORICALLY EXEMPT FROM CEQA.
