SUBJECT: The West Hollywood Business License Commission shall conduct a public hearing to consider a variance request from Flore Flora, LLC to allow the transfer of a total of fifty-eight point seventy-three percent ownership in the Cannabis Consumption Area (Smoking, Vaping and Edibles) Business License to Hightimes Holding Corporation.
