INTRODUCTION BY MARK WINOGROND:

OVERVIEW BY MICHAEL PITTAS, COMPETITION ADVISOR:

Michael Pittas described the situation faced by the jury: over 292 entries from 22 nations, from Austria to Zimbabwe, representing 20 person-years of effort. The jury had spent 22 hours in the tent.

Mr. Pittas explained what the different awards meant. Honors awards were proposals that were close (to semi-finalist). Meritorious awards had some feature the jury wished to recognize. The semi-finalists will be given time to put together a team.

The jury will reconvene in October and at that time a solution will be recommended.
