Director of Public Works, Chuck Bergson, asked that the following amendments be made to the project: 1) A completion date of November, 1988 be added and 2) add, "The city shall not hold the County of Los Angeles accountable for the expense of relocation, alteration or modification to the project, once installed, necessitated by future street improvements, re-alignments, alterations or reconstruction. ACTION: 1) approve the plans and specifications, 2) authorize the County to proceed with construction of the project, and 3) grant the County permission to occupy and use the City public streets to construct, operate and maintain the installations, and adopt the amendments recommended by staff. Motion Land second Heilman. Hearing no objection it was so ordered.
- k. Painting Street Address Numbers on the Face of Curbs: The Sheriff's and Fire Departments have requested that the City paint street addresses on curb faces in front of all properties to assist in emergency response. ACTION: Accept the proposal from Hubbs Curb Addresses and direct that this work be accomplished.

- 1. Resignation from Human Services Commission: ACTION: Accept the resignation of Zigmund Vays from the Human Services Commission with regret, direct staff to prepare the proper commendation and direct the City Clerk to advertise the vacancy and solicit applications. - m. Architect Contract for Wm. S. Hart Park: REMOVED FOR SEPARATE DISCUSSION BUT LISTED HERE FOR CLARITY. Contract negotiations have been completed with Rios-Pearson and it is appropriate to approve the contract at this time. Councilmember Land requested that Exhibit A with a time-line for completion of the project be attached to the contract. ACTION: Approve the contract with Rios-Pearson as architect for the design of Hart Park improvements, with the addition of Exhibit A, with staff working out language allowing the city leeway on meeting dates, etc. Motion Schulte second Albert. Hearing no objection it was so ordered.
- n. Referral of Wall and Hedge Text Amendments back to the Planning Commission: The Zoning Ordinance requires that

the Commission report back to the Council within 40 days, but due to the upcoming holidays, the Commission will require additional time. ACTION: Extend the time within which the Planning Commission shall report back to the Council on the matter of the proposed text amendments for walls and hedges to a period of 90 days. ACTION: Approve the use of West Hollywood Park by CSW for the 1988 Gay and Lesbian Pride Celebration and authorize the City Manager to sign the agreement as amended. Motion Land second Schulte. Hearing no objection it was so ordered.

The City Attorney arrived at 7:45 P.M. The City Clerk reported that this hearing was noticed in the Post Newspaper and posted at City Hall, Plummer Park, the San Vicente Library and the Sheriff's Station. Mayor Viterbi opened the Public Hearing. Howard Zelefsky gave the staff report, and the following person came forward to speak in favor of the appeal:

No one else comming forward to speak, Mayor Viterbi closed the public hearing and returned this item to the Council for discussion.

ACTION: Deny the appeal of McDonald's Corporation and uphold the decision of the Planning Commission to approve Development Permit 87-66 and Demolition Permit 87-33 as conditioned, requiring removal of the pole sign. Motion Land second Schulte. Hearing no objection it was so

ordered.

No one else coming forward to speak, Mayor Viterbi closed the public hearing and returned this item to the Council for discussion.

The City Attorney, Mike Jenkins, made the following statement, for the record:

"This issue, unlike so many that come before you, has enlisted a good deal of legal briefing and argument. I thought it might be appropriate to make a few comments on this subject.

As you know, and as those who have been involved in historic preservation are aware, the concept of historic preservation

the regulation of private property for power preservation purposes is a well recognized municipalities; a power that has been upheld by the U.S. Supreme Court. Recently the Court did make a decision that, in a certain sense, narrowed the municipality's power in area of land use. It was by no means however, an end to land use regulation. If anything, it was simply as a signal that cities ought to be more cautious when dealing with private use of that property in assuring that the entire value or property is not removed by virtue of overzealous governmental In that decision what the Court simply made clear was that where there is a 'taking', and as recently as last year in the same term that 'taking' was reaffirmed to mean a complete and total removal of all value from the property; where there is a taking by virtue of a final decision of a government agency, that damages would be an available remedy even during the period from the decision until the matter was fully litigated in court.

want to point out that, number one, as Ms. indicated, demolition permits are discretionary and have been since the Zoning Ordinance was enacted by this Body consequently, there has never been an expectation on the part of buyers of property that they would automatically receive a demolition permit. Second, and importantly, the Ordinance provides for a mechanism for the exhaustion of administrative remedies in order for a person, who believes that their property is incorrectly on the inventory and is ready to something with the property, to come in and make an administrative application and have that application heard on a case by case basis. Now, this is precisely what the Supreme Court has said is both appropriate and fair in There is no taking dealing with Ordinances of this kind. where a property owner must simply come in for a permit before being given the opportunity to develop. After all, many property owners are required to come in for conditional use permits and other similar permits, before being permitted to develop properties.

In this particular case there are three exceptions to this Ordinance. Any property owner who wishes to apply for a demolition permit, that is, a property owner who is prepared to make some further development to his or her property, can come in and demonstrate that the structure was mistakenly included in the inventory due to a factual error regarding its historic, cultural or architectural significance. To the extent that there are property owners who believe that their property was mistakenly included on the inventory, they can demonstrate that before the Planning Commission and have a

demolition permit approved. Second, if they can demonstrate that the structure is in such poor physical and/or structural condition that it constitutes an immediate safety hazard, they can receive a demolition permit and property may be demolished. Third, if they can demonstrate that the structure cannot be used for any permitted purpose under this article, that is to say that the property truly has no value in its present condition, they can receive a demolition permit. Those three exceptions are, and have been, a part of this Ordinance and we wouldn't have drafted this Ordinance without those specific provisions.

In short, what you are doing if you choose to adopt this Ordinance is not to make a final decision with respect to any property, but to simply place the property on a list or inventory which is recognized as being a list of importance and giving ample opportunity to the property owners who wish to go ahead and demolish their property, and who believe they do not properly fall within the Ordinance, the avenue to come in and file for a permit to do so."

ACTION: Introduce on first reading, Ordinance No. 177, "AN ORDINANCE OF THE CITY OF WEST HOLLYWOOD REGULATING DEMOLITION OF HISTORIC STRUCTURES AND AMENDING THE WEST HOLLYWOOD MUNICIPAL CODE." Motion Land second Albert. Hearing no objection it was so ordered.

Mayor Viterbi called a recess at 8:55 P.M. Mayor Viterbi reconvened the meeting at 9:12 P.M.

## NEW BUSINESS

5. APPEAL OF TEMPORARY USE PERMIT 87-18 - 365 N. SAN VICENTE BOULEVARD: Tim Gawronski reported that on November 15, 1987, the Planning Commission approved the Temporary Use Permit for a temporary parking lot at 365 N. San Vicente Boulevard to accommodate employee parking for the Beverly Center, on-going construction projects in the area, and occasionally for film producers. That approval has been appealed to the City Council by Ron Shipton. At this point in time the following persons came forward to address the Council:

Rebuttals were then given by both Ron Shipton and Lorraine Howell and the item was returned to Council and staff for discussion.

ACTION: Uphold the permit with changes. Reduce the time to 3 months to be used for Holiday parking by the Beverly Center and for construction vehicles, day time only. Any other uses must apply under a different process than a tempory use permit such as a zone change. Motion Viterbi second Schulte. As clarification of the action the following changes were to be made in Resolution PC 87-54:

Item 5 - change to 3 months and delete all reference to extension.

Item 7 - delete "other establishments," change to "to employees of the Beverly Center through January 1, 1988, Public Works construction vehicles. After January 1 must procure permission from staff for any similar use of all day parking (not less than 5 Hours), within the 3 month envelope.

Item 9 - change to "enter & exit the lot from San Vicente

Boulevard only."

Item 16 - Delete.

Item 17 - That any use of the subject property after the holidays shall be subject to the approval of staff.

Item 18 - Change to 3 months and delete all reference to extensions.

Item 19 - Change to read "shall expire on February 19,
1988."

Direction was given to staff to return with a definition of what temporary use means and recommendations on appeals of TUP's.

- 6. MARCH ON SACRAMENTO: Councilmember Heilman reported that the May 7, 1988 March on Sacramento calls for the end of discrimination based on sexual orientation; additional funding and support for AIDS education and research; an enactment of legislation against prejudice; and a revision of the Gann limitation. ACTION: Adopt Resolution No. 390, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD SUPPORTING THE GOALS OF THE MAY 7, 1988 MARCH ON SACRAMENTO", and provide support and assistance wherever appropriate. Motion Heilman second Schulte. Hearing no objection it was so ordered.
- 7. PROLIFERATION OF ALCOHOL LICENSES: Mayor Viterbi requested an in-depth analysis of the entire area of alcohol licensing be undertaken by the Community Development Department working in conjunction with the City Attorney's Office, in their next 90-day work program, and they come back to the Council with recommendations for any appropriate changes in the process.

- 8. GOVERNMENT SPENDING LIMITATION AND ACCOUNTABILITY ACT INITIATIVE: Councilmember Albert reported that local public agencies and the State Government have found a need for greater flexibility with respect to the expenditure of tax monies now being collected. ACTION: Adopt Resolution No. 388, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD URGING WEST HOLLYWOOD VOTERS TO SUPPORT THE QUALIFICATION AND PASSAGE OF THE PROPOSED "GOVERNMENT SPENDING LIMITATION AND ACCOUNTABILITY ACT INITIATIVE", and direct staff to send copies to the County of Santa Cruz and Californians for Quality Government. Motion Albert second Heilman. Hearing no objection it was so ordered.
- 9. PLANNING COMMISSION APPOINTMENT MAYOR VITERBI: RECOMMENDED ACTION: Mayor Viterbi to make his appointment to the Planning Commission, for a term expiring June 1, 1988. TABLED TO THE MEETING OF JANUARY 4, 1988.
- REHABILITATION TASK FORCE: Councilmember reported that the primary purpose of the task force would be certain City laws to determine if discourage rehabilitation of residential properties, the kinds and size of properties affected, and what measures can be undertaken to mitigate the impact of these laws without diluting the protection of the Rent Control Ordinance. PROPOSED ACTION: Establish a 6 member task force of 4 staff members and 2 citizens at large that would report back to the Council with their findings in 90 days. Motion Schulte second Viterbi. Councilmember Heilman stated he wanted a coordinated effort on the part of staff but did not want a 6 member task force with 2 citizens to handle this item. Councilmember Schulte changed his motion to read "members of staff from Housing, Code Enforcement, Building and Safety and Rent Stabilization as a coordinated body to report back to Council with their findings in 90 days. This was accepted by the second. Hearing no objection it was so ordered.
- 11. AIDS HOUSING COALITION REPORT: In order to attempt to address Health and Housing issues of persons with AIDS and ARC, Councilmembers Land and Schulte convened an ad hoc coalition to analyze the situation and suggest ways that the City could further address this concern. This item is presented with various recommendations for discussion. The staff report was given by Dan Cohen and Jodi Curlee with Ron Rose, Tom West and Dr. Michael Weinstein adding supplemental information. Also coming forward to speak on this item were the following:

Ron Wolff, Executive Director of Hospice LA in Long Beach James Litz, West Hollywood

ACTION: Approve the concept including the Barlow concept. Instruct staff to come back with a time line and implementation of the plan at the first meeting in February. Staff to closely look at and analyze the numbers and look at where this fits into the budget. Motion Land second Heilman. Hearing no objection it was so ordered.

## **LEGISLATIVE**

13. TAXICAB LICENSING AND ENFORCEMENT - ORDINANCE NO. 176 FOR INTRODUCTION - ORDINANCE NO. 176U FOR ADOPTION ON AN URGENCY BASIS: Paul Self gave the staff report. Mr. Vincent de Caesar, owner, Celebrity Cab Co. addressed the Council on this item and requested some sort of decal system. ACTION: No new licenses for cabs to be issued until we have our Ordinance. Motion Viterbi second Schulte. Hearing no objection it was so ordered.

Motion Viterbi second Schulte. Hearing no objection it was so ordered.

- 14. PARK CLOSURE HOURS ORDINANCE NO. 174U FOR ADOPTION ON AN URGENCY BASIS: RECOMMENDED ACTIONS: 1) The recommendation by the Sheriff's Department is to adopt on an urgency basis, Ordinance No. 174U, "AN ORDINANCE OF THE CITY OF WEST HOLLYWOOD CHANGING PARK HOURS, AMENDING THE MUNICIPAL CODE AND DECLARING THE URGENCY THEREOF".
