2. Ordinance No. 98 - Adopting an Interim Zoning Ordinance: RECOMMENDED ACTION: To approve on first reading Ordinance No. 98, "AN ORDINANCE OF THE CITY OF WEST HOLLYWOOD ADOPTING AN INTERIM ZONING ORDINANCE AND AMENDING THE WEST HOLLYWOOD MUNICIPAL CODE."

ACTION: To keep the moratorium in place on demolition of single family homes in residential areas. Motion Schulte seconded Terrigno.

Ordinance No. 99 and 99U - Prohibiting Use of City Parks and City Park Parking Lots During Certain Hours.: RECOMMENDED ACTION: To approve and adopt Ordinance No. 99U, "AN ORDINANCE OF THE CITY OF WEST HOLLYWOOD PROHIBITING USE OF CITY PARKS AND CITY PARK PARKING LOTS DURING CERTAIN HOURS, AMENDING THE WEST HOLLYWOOD MUNICIPAL CODE AND DECLARING THE URGENCY THEREOF."

RECOMMENDED ACTION: To introduce on first reading Ordinance No. 99, "AN ORDINANCE OF THE CITY OF WEST HOLLYWOOD PROHIBITING USE OF CITY PARKS AND CITY PARK PARKING LOTS DURING CERTAIN HOURS AND AMENDING THE WEST HOLLYWOOD MUNICIPAL CODE."

ACTION: To change the time the parks would open to 5:30 a.m. Motion Viterbi seconded Terringo.

Ron Stone, 8722 3/4 Holloway Dr., W.H., C.A. - felt that parks should remain open. Mr. Stone mentioned that the ordinance would close parks at 12:00 a.m. however bars don't close until 2:00 a.m.

Commissioner Dobrin, 9000 Cynthia, W.H. - asked how would people get their cars out of parking lot if park was closed.
