# MEMORANDUM

RE: GOALS

DATE: December 29, 1985

Paul, I have read the draft on Goals and I think it is a very good document. I have reviewed it and I have some suggestions on how we can improve it in areas where we may have missed something. I would also like to discuss the document with some people in the community. Please let me know if you have any objections to me sharing my thoughts on the draft as it stands:

# GOAL #1

Add to Administrative Services the following:

1) Make sure notices from Clerk's office encourage involvement of affected parties and community, and adequately apprise public of potential agenda items.

Add to Administrative Services or PIO or both the following:

1) Train new Commission Members and staff so they are aware of City departments and services and so they respect and encourage citizen involvement.

Add to Community Development Department the following:

- 1) Hold public meetings and neighborhood meetings on proposed developments and public improvements.
- 2) Develop programs for on-going community of neighborhood planning committees to oversee implementation of the general plan.

Add to Sheriff's Department the following:

1) Train officers regarding City officers and departments so they know who to refer members of the public to for questions.

## GOAL #2

Add to Community Development Department the following:

- 1) Recruit and hire a handyman specialist.
- 2) Revise #1 on page 4 under Human Services. It is vague and needs to be made more concrete and specific.
- 3) Modify #3 under Rent Stabilization Department: It should read as follows: "keeping rents affordable for seniors, families, recent immigrants, and others in need."

Add to Sheriff's Department the following:

1) Train officers to recognize social service needs in community and know who to refer people to for social services.

## GOAL #3

Add to Administrative Services the following:

- 1) Develop and maintain effective agenda procedures so decisions are scheduled for maximum public input at a time when input is likely.
- 2) Modify #1 in Rent Stabilization Department so it is broken down into specific parts.

Add to Rent Stabilization Department the following:

1) Revise computer list so we can accurately correspond with those not in compliance with our law.

Add to Sheriff's Department the following:

1) Develop and maintain effective complaint investigation procedures and follow-up.

## GOAL #4

Add to Administrative Services the following:

- 1) Develop programs to allow City to take advantage of bulk rate discounts and prompt payment discounts.
- Develop programs to allow city to quickly recover debts owed by private parties.
- Train all staff to take advantage of available grant programs and investigate public-private cooperation when possible to save the City's resources. (As this is written now only under Human Services is there any discussion of applying for appropriate private and public grants. I think this should be expanded to include all Departments.)

# GOAL #4 (cont'd.)

Add to Community Development Department the following:

- 1)
- Develop programs for "exactions".

  Provide ( estimated income to City to decision-makers on 2) all major development projects.

Add to Administrative Services or Human Services or both the following:

1) Develop volunteer programs to take advantage of those in the community who want to donate their time to the City.

Add to the Sheriff's Department the following:

Develop programs to insure prompt collection of fines 1) and forfeitures from those who do not pay voluntarily.

## GOAL #5

Add to Administrative Services Department the following:

1) Develop in-house energy conservation and recycling programs.

Add to Community Development Department the following:

1) Insure that new developments provide adequate public infra structure improvements or contribute to a fund in amounts sufficient to cover the expenses of such imimprovements.

Add to Human Services Department the following:

- 1) Develop and implement a city-wide recycling and clean-up program.
- Remove #3 from the Human Services Department (develop-2) ment of prevention program and social services, etc.). This item seems out of place under this Goal or it is not being adequately expressed.

## GOAL #6

Add to Administrative Services Department the following:

1) Develop volunteer and internship programs to enable citizens to participate in the frunning of government.

# GOAL #7

Add to PIO or Human Services or both the following:

Develop programs to make sure residents are aware that programs sponsored by the City and social services provided by the City are available to all those who qualify, regardless of their race, religion, sexual orientation, etc.. (For your information, Paul, a number of people in the community think that the services provided by Jewish Family Services are available only to Jewish people.)

## GOAL #8

Under Public Information Office delete the first two items. These seem out of place with the role of the PIO.

Add to the Community Development Department the following:

- 1) Staff and implement the home security programs currently being provided by the handyman worker.
- 2) Add earthquake safety to the last item under the Community Development Department.

Add a section for the Rent Control Department including the following:

- 1) Develop programs to encourage security upgrading of existing housing stock.
- 2) Provide mechanisms that encourage building repairs and improvements for health and safety reasons.

## GOAL #9

Nothing.

# GOAL #10

Add to Administrative Services the following:

- 1) Develop programs to insure that staff morale is high and that staff maintains enthusiasm for the City, its residents, and its guests.
- 2) Work with PIO to make sure staff knows how to respond to media.

# GOAL #10 (cont'd.)

Add to PIO or Community Services or both the following:

1) Develop a visitor's guide for guests that promotes the City's diversity and excitement.

Under Rent Control the second item regarding the Tenant-Landlord Mediation Program seems out of place under this Goal. It also seems vague the way it is written.

Add to the Sheriff's Department the following:

1) Develop specialized programs to alert out-of-town visitors of potential risks to their safety or property. Also develop programs that assist out-of-town guests in recovering their property or pressing charges against those accused.
