The City Manager reported that there is a possibility of the City negotiating a purchase of Prop A funds for as little as \$.50 on the dollar. Due to the fact that the City does have substantial reserves, and there is a 3 year period in which to expend these funds, he would like to explore purchasing additional funds, over and above what we anticipate we will need this year. The City does project the possibility of using Prop A funds for transit services. The City Council agreed with the idea and felt it would be a good investment.
