**CALL TO ORDER:** Mayor Terrigno called the meeting to order at 7:05 p.m.

**APPROVAL OF AGENDA:** Action: To approve the agenda. Motion Heilman seconded by Mayor Terrigno. Hearing no objection and noting the absence of Councilmember Schulte, it was so ordered.

**ACTION:** To approve June 22nd as the official day of memory for persons with AIDS, their loved ones, and organizations related to AIDS, and to approve Resolution No. 80, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD COMMENDING LIEUTENANT QUINN OF THE SHERIFF'S DEPARTMENT FOR EXCELLENCE IN SERVICE TO THE COMMUNITY". Motion Heilman seconded by Albert. Hearing no objection and noting the absence of Councilmember Schulte, it was so ordered.

8. **CUL DE SAC - HUNTLEY DRIVE AND WESTBOURNE DR. BETWEEN BEVERLY PLACE AND ROSEWOOD AVE. AND WESTMOUNT DR. BETWEEN ROSEWOOD AND LA CIENEGA:** ACTION: To schedule a Public Hearing for July 25, 1985, with full reports from staff. Motion Heilman seconded by Viterbi. Hearing no objection and noting the absence of Councilmember Schulte, it was so ordered.
