WEST HOLLYWOOD CITY COUNCIL MEETING JUNE 27, 1985 12:00 P. M. PLUMMER PARK - FIESTA HALL

CALL TO ORDER: Mayor Terrigno called the meeting to order at 12:33 p.m.

PLEDGE OF ALLEGIANCE: The Pledge of Allegiance was led by Mayor Terrigno.

APPROVAL OF AGENDA: Add Item 12a - RTD Bus Pass Sales; add Item 17a, an amendment to modify the language on the Ordinance on filing and processing specific plans; Councilmember Viterbi requested that time be allowed for Cesar Chavez to address the Council at 1:30 p.m., and the City Manager stated there were several administrative items he would bring up on the City Manager's report. ACTION: To approve the agenda as amended. Motion Terrigno seconded by Schulte. Hearing no objection it was so ordered.

After further discussion on this item, Councilmember Heilman offered the following substitute motion: ACTION: Change the second sentence to read "regulations, policies and rules promulgated by the Board". Motion Heilman seconded by Terrigno.

WAIVERS - ACTION: To add the following at the beginning of Paragraph C on Page 32, "The requirements of sub-paragraphs 1 and 2 of paragraph A of this section may be waived at the time the maintenance is scheduled to be performed in writing by the tenant"---, and at the bottom of the paragraph add, "Such waiver shall be valid for a period not to exceed 1 year, but there

shall be no limit on the number of consecutive waivers that can be executed by a tenant. The waiver shall terminate upon the termination of the tenancy".

SEPHARDIC HEBREW ACADEMY: Rabbi Kupfer, Director of the Sephardic Hebrew Academy addressed the Council about the need of the Academy for new additions and a lunchroom, which requires additional parking. Sorin Alexanian explained the school parking requirements of K-6, 1 parking space per classroom and 8th grade, 1 parking place per 5 occupants and supported the change to 1 parking space per classroom until the 9th grade with a restriction that the room cannot be used as a meeting room unless there is adequate off site parking provided. The Council requested that appropriate language be brought back to the Council by the City Attorney.

12a. RTD BUS PASS SALES: ACTION: That Bus Passes be sold at Plummer Park as an additional site. By consensus of the Council.

The City is in receipt of a letter from Josh Workman, in reference to Huntley Drive, in which he states that 3,000 gallons of gas have leaked from Santa Palm in a major blow-up last week. The tank has been taken out of service and the flow is diminishing. The City and County are monitoring closely.
