MINUTES

WEST HOLLYWOOD CITY COUNCIL MEETING JUNE 6, 1985 7:00 P.M. WEST HOLLYWOOD PARK

CALL TO ORDER: Mayor Terrigno called the meeting to order at 7:30 p.m.

PLEDGE OF ALLEGIANCE: The pledge of allegiance was led by Captain Jim Cook.

APPROVAL OF AGENDA: ACTION: To remove items 14 and 15 from the agenda. To move items 16 and 23 to the consent calendar. To add item 3a, an Ordinance allowing exemptions to the building moratorium, and item 25a, Citizens Committees. To approve the agenda as amended. Motion Schulte seconded by Heilman. Hearing no objection it was so ordered.

FURTHER ACTION: To set 11:30 as the time certain for adjournment. Motion Viterbi seconded by Schulte. Noting the objection of Councilmember Heilman, it was so ordered.

TREASURER'S REPORT: Jonathan Ahearn, City Treasurer, reported that the General Revenue Balance on June 1, 1985 was \$1,323,080.63; The street improvement balance was \$370,001.72; and the Transit Tax balance was \$104,628.92.

PROCLAMATION: Proclaimed June 9, 1985 as Playboy Jazz Festival Day in West Hollywood.

3. RENT CONTROL CONCEPTS:

BOARD COMPOSITION AND METHOD OF APPOINTMENT: ACTION: That the Board be made up of 5 members who are residents of West Holly-wood appointed by Councilmembers in April for a one year renewable term and that the compensation be set by resolution. Motion Heilman seconded by Schulte.

Wally Siembab andf Laurie Lieberman, Consultants, addressed the Council on this matter. Councilmember Heilman requested that this matter be referred to the rent control consultants and the administrator for 4 months for a report. By consensus of the Council this item was tabled.

PROPOSED ACTION: That there be no grounds for evictions due to foreclosure for detached single family units, but yes for condos. Red lining not valid.

SUBSTITUTE MOTION: To have the data collected on the registration form on who provides floor and window coverings, etc. Add an additional provision that states that it will be presumed that these were last replaced 3 years from the affective date of the registration, but is rebuttable by the landlord demonstrating that it was done sooner.
