MINUTES

WEST HOLLYWOOD CITY COUNCIL MEETING MAY 16, 1985 7:00 P.M. WEST HOLLYWOOD PARK

CALL TO ORDER: Mayor Terrigno called the meeting to order at 7:25 p.m.

PLEDGE OF ALLEGIANCE: The Pledge of Allegiance was led by Mayor Terrigno.

ROLL CALL: Present: Albert, Schulte, Viterbi, Heilman

APPROVAL OF AGENDA: Remove items 4, 5, and 11 from the consent calendar for separate discussion. Move item 17 to the beginning of the agenda and add an additional proclamation and an announcement from Councilmember Heilman. ACTION: To approve the agenda as amended. Motion Heilman seconded by Schulte. Hearing no objection it was so ordered.

PROCLAMATIONS: 1. California Traffic Safety Week

- 2. Greg Hammond Memorial Day May 16, 1985
- 3. Hyman Bolotin Day May 15, 1985

Councilmember Heilman announced that Member Albert would be honored by the County on Older Americans Recognition Day, May 18, 1985 and the Council and the audience congratulated her.

17. FUNDING FOR GRAND PEOPLES' COMPANY: Councilmember Albert gave the staff report with further information supplied by the City Manager. William McClelland, Executive Director of the Grand Peoples' Company furnished further information on the use of Prop. A funds. ACTION: To approve \$2,500 funding for this quarter. Motion Heilman seconded by Albert. Hearing no objection it was so ordered.

PUBLIC HEARINGS

1. CONDO CONVERSION RELOCATION BENEFITS: Mayor Terrigno opened the public hearing and the following persons addressed the Council:

Scott Keisling, 900 Hammond Street: spoke to the problems in the apartment building where he has resided for 7 years, due to remodeling for a conversion.

Paul Metz, 900 Hammond Street: Anti conversion, also requested assistance in the situation already existing in the 900 Hammond Street Building.

J. Lawrence, 900 N. Hammond Street: Tenant for 8 years. Anti conversion.

Helen Sannet, 900 N. Hammond Street: Building going through a conversion for past 2 years. Noise, dirt, inconvenience, unsafe conditions and no privacy are only some of the problems. Still paying the same rent even with this situation. Have now been offered \$2500 to relocate.

Abbe Land: Do not believe in evictions for conversions. If allowed should have 120 days notice minimum; \$1500 single, \$2500 couple, minimum; extra for handicapped and senior citizens, at least \$1000; also landlords should help the tenants relocate.

Joseph Leeder: Anti condo conversions. An apartment is an apartment, a condo is a condo.

Doug Routh, 1264 N. Harper: There should be participation and consensus of the tenants in a conversion situation; \$2,000 to \$2,500 for relocation; Transportation should be provided for seniors who are forced to look for a place. Listing service should also be provided.

Alan Brayman, 1417 1/2 N. Hayward: Anti conversion; denies the public access to rent controlled housing.

Marvin Remault, 900 Hammond: Obvious that tenants should receive relocation benefits. Home should be a place of refuge. Question should be does the owner have the right to inconvenience tenants without any compensation.

Ed Mirapol, spoke in favor of conversions. State of California and Los Angeles County have regulations.

John King, 900 N. Hammond: Won't move for \$2500. Want a fair settlement.

Mayor Terrigno closed the public portion of the public hearing at 8:10 p.m.

Councilmember Heilman stated that there were two issues:

- 1. Compensation during conversion (construction)
- 2. Relocation benefits.

Councilmember Viterbi stated that the 3rd issue would be whether conversions would be permitted.

The City Attorney reported that under the County ordinance there were several steps that the owner must take. They would have to file a subdivision map, give notice of a minimum of 120 days, must pay moving expenses of \$500 plus relocation benefits of \$1500. In addition the owner must provide assistance in locating housing. When the council discusses a conversion ordinance, they will be considering those conversions that were in process at the time the city was incorporated as well as new conversions. Also there are already non-eviction clauses in the draft rent control ordinance.

ACTION: To receive the testimony and continue discussion to Item 13, Deferred Rent Control Concepts. By consensus of the Council.

Mayor Terrigno called a recess at 8:32 p.m.

The City Council reconvened at 8:50 p.m.

2. DRAFT RENT CONTROL ORDINANCE: Mayor Terrigno declared the public hearing open and announced that the council would receive expert testimony from CES for the first 20 minutes, and then 20 minutes expert testimony from West Hollywood Concerned Citizens and then proceed to individuals pro rent control (3 Minutes each) and then anti rent control.

The City Attorney gave the staff report on the Ordinance, and listed the following basic provisions: Definitions, list of property that is exempt from rent control, a Registration provision (annual), automatic rent adjustments (annual), limited vacancy decontrol, Rent Adjustment Board and Hearing Officers, Procedure for increases above and beyond the automatic increases, appeal procedures, grounds for evaluation of applications, Just cause evictions, and criminal and civil remedies for violation of the Ordinance.

Adam Teska, Professor at UCLA in the planning program who has done a number of studies on rent control and was asked to appear by CES, addressed the Council as the expert witness for rent control.

Grafton Tanquary, 25 year resident and property owner, addressed the Council as the expert witness against rent control.

Mayor Terrigno called a recess at 10:47 p.m.

The Council reconvened at 11:30 p.m

AUTHORIZATION FOR EXPENSES FOR CAPTAIN COOK TO ATTEND CON-TRACT CITIES SEMINAR: ACTION: To approve funding for Captain Cook to attend the Contract Cities Seminar in Palm Springs on May 30-June 2, 1985. This will include registration, hotel reservation, transportation and reimbursement for expenses.
- RELEASE OF BOND TRACT NO. 35373: ACTION: To approve the release of bond as recommended by the Department of Public Works.
- 8. RELEASE OF BOND - PARCEL MAP 14236: ACTION: To approve the release of bond as recommended by the Department of Public Works.
- 9. RENT CONTROL HOTLINE REPORT MARCH: ACTION: To receive and file.
- 10. CHRISTOPHER STREET WEST PARADE REQUEST: ACTION: prove street closures beginning at Santa Monica Boulevard and Crescent Heights, westward on Santa Monica Boulevard, utilizing the northern-most section where Santa Monica Boulevard separates. At San Vicente southward utilizing the southbound lanes only, and continuing south to Beverly Boulevard (utilizing full width of San Vicente between Melrose and Beverly).
- FUNDS FOR TEMPORARY STAFF SUPPORT: ACTION: To authorize the City Manager to spend up to \$10,000 for short-term staffing support through the end of the fiscal year. Motion Heilman seconded by Schulte. Hearing no objection it was so ordered. THIS ITEM WAS REMOVED FOR SEPARATE DISCUSSION BUT IS LISTED HERE FOR CLARITY.
- EXTENSION OF COMMUNICATION WORKS CONTRACT: ACTION: approve the extension of the Communication Works contract through the end of May and direct the City Manager to obtain cost estimates for the continuation of the services on a month to month basis.

UNFINISHED BUSINESS

13. DEFERRED RENT CONTROL CONCEPTS: The staff report was given by Ken Baar, the rent control consultant. On the question of co-ops, the City Attorney stated that, as a practical matter, a co-op is no different than a condominium and if it is rented, it is the same as renting a condominium. ACTION: To treat co-ops the same as a condominium in the Ordinance. Motion Viterbi seconded by Schulte.

Councilmember Albert asked the City Attorney when an abstention is proper.

The City Attorney stated that generally speaking, the Council-member has a duty to vote unless they have a conflict of interest which disqualifies them.

PROPOSED ACTION: To treat luxury units as \$1,000 for a one bedroom apartment, with staff to come up with comparable figures for two and three bedroom units. On vacancy to have de-control, re-control and they can't qualify as a luxury unit if rents raised after August 6, 1984. Motion Terrigno. Died for lack of a second.

The City Attorney stated that these units would be treated as non-exempt as there has been no vote to exempt.

ACTION: To put all units in West Hollywood under rent control unless specified as exempt. Motion Viterbi seconded by Schulte. Hearing no objection it was so ordered.

ACTION: Move that duplex's, triplex's, and four-plex's that were unoccupied on the effective date of the Ordinance be covered by the Ordinance. Motion Heilman seconded by Schulte.

The discussion then centered on the question of additional General Adjustments for owners who pay utilities. ACTION: To allow additional general adjustments of 1/2% per utility for owners who pay utilities. Motion Schulte seconded by Heilman.

PROPOSED ACTION: To allow 1/2% increase for insurance. Motion Schulte seconded by Viterbi. ACTION: To table this item. Motion Heilman seconded by Terrigno. So ordered.

ACTION: To set May 1, 1984 as the base rent date. Motion Schulte seconded by Albert.

AYES: Albert, Schulte, Heilman

NOES: Viterbi

ABSTAIN: Mayor Terrigno

Motion carried.

Discussion then centered on the first adjustment date and level of staffing and trained contract people required for processing.

ACTION: To table this item for one week and request staff to come up with a date. Motion Heilman seconded by Viterbi. Hearing no objection it was so ordered.

ACTION: To adopt fixed maintenance standards based on the housing survey and other research: Interior paint every 4 years, carpet and drapes every 7 years. Meet Uniform Building and Health and Safety codes adopted by the City of West Hollywood. Also the proper and adequate functioning of all plumbing and appliances, to include air conditioning, elevators, and heating if provided. Motion Mayor Terrigno seconded by Schulte.

ACTION: That the tenant can waive the right for painting, drapes, and carpeting in writing when they come due. Motion Heilman seconded by Schulte.

ACTION: That the initial registration has to state the services that are currently provided and that those items do not become lost if the unit becomes decontrolled for any reason. Motion Mayor Terrigno seconded by Schulte.

Ken Baar reported that he would come back next with further information on traditional low rents and net operating income, survivorship, duplex evictions with 2 owners, relocation amount, and various other items.

The discussion then centered on the powers of the Rent Stabilization Board. ACTION: That the Board can make regulations and submit them to the City Council. The Council must veto within 45 days or they take effect.

RENT CONTROL ADMINISTRATION CONSULTANTS: ACTION: Subject to final reference checks of McAdams and Siembab, that the City Council direct the City Manager to work directly with McAdams and Siembab and Roger Libson in developing a detailed work plan and contract for services with the City in developing the Rent Control administration. Motion Schulte seconded by Albert. Hearing no objection it was so ordered
- 15. ASSUMPTION OF TITLE TO WEST HOLLYWOOD PUBLIC PARKS: ACTION: That the City Council accept title, effective June 1, 1985, to the two parks currently owned by Los Angeles County within the City of West Hollywood. Motion Schulte seconded by Albert. Hearing no objection it was so ordered.
- 16. HISTORIC LANDMARK PRESERVATION LEGISLATION: Direction was given to the City Attorney to prepare some enabling legislation for Council consideration next week.

 ACTION: To approve the contract with Mariposa Landscape Company

 so ordered.
- 19. COMMUNITY GARDENS IN WEST HOLLYWOOD: Councilmember Schulte reported to the Council on the idea of Community Gardens. Requested approval and authority to go ahead on those lots that are acceptable. ACTION: Table for 2 weeks for further information.

DEMAND REGISTER NO. 13 RESOLUTION NO. 70: ACTION: To adopt Resolution No. 70, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD ALLOWING AND APPROVING FOR PAYMENT, DEMANDS PRESENTED ON DEMAN REGISTER NO. THIRTEEN", with the removal of warrant 1378, and with the City Manager to check warrant No. 1368 to be sure this is not a double billing. Motion Viterbi seconded by Mayor Terrigno. Hearing no objection it was so ordered.
- 27: COMMUNICATIONS: The City Manager reported that he wanted to schedule a study session on internal process and also a meeting with Caltrans. The City Attorney stated that the Council would need to schedule further sessions and allow enough time for the Rent Control Ordinance.
- 28: NON-AGENDA ITEMS: TAXI COUPON PROGRAM: The City Manager reported that this item was submitted on short notice due to the fact that St. Barnabus needed six-weeks in lead time in order to a avoid a disruption of service on July 1. ACTION: That the City Council authorize a six month extension of the taxi coupon program and commit up to \$170,000 to cover the contract cost. Motion Heilman seconded by Albert. Hearing no objection it was so ordered.

Michael Jirock, corner of Havenhurst and Fountain, spoke to the Council about the dangerous conditions at this intersection. The Council directed these comments to the traffic engineer.

29. CLOSED SESSION

At the hour of 3:10 a.m., Mayor Terrigno adjourned the Council to a closed session to discuss matters of potential litigation.

The Council re-convened at the hour of 3:40 a.m. and Mayor Terrigno announced that they had approved the lease with the County for the remainder of the City's stay at Plummer Park, and had approved the Santa Monica Boulevard site for City Hall.

ADJOURNMENT: The meeting was adjourned at 3:45 a.m. to a regular meeting on May 23, 1985 at 1:00 p.m. at Plummer Park, Fiesta Hall.
