CITY COUNCIL MEETING

CALL TO ORDER: The meeting was called to order at 7:22 p.m. by Mayor Heilman.

ZONING WORKSHOP:

The City Council reviewed pg. 47 thru pg. 91 of the Interim Zoning Ordinance Draft.

The next scheduled workshop will be October 24th 7:00 p.m. to handle process. Following that meeting will be a workshop on parking October 30, 7:00 p.m.

Planning subcommittee members, Viterbi and Schulte asked for authorization to hold a planning subcommittee meeting to consider business revitalization.

In addition Councilmember Viterbi asked that Human Services bring back an R.F.P., for discussion the following week, for a lobbyist to ensure that AIDS funding is protected and increased over the upcoming years at the funding discussions being currently held in Sacramento.

Councilmembers Schulte and Viterbi requested that Alternate Living for the Aging, the Schindler House and the Community Revitalization Program not be included in the allocated social services funds previously approved. Mark Winogrand stated that the Community Revitalization Program was not included in Social Service funding. Staff was requested to prepare a report and present it to the Council at the time these proposals are to be considered by the Council.
