2. Eligibility Requirements and Rental Rates for Inclusionary Rental Units: Report from Department of Community Development dated October 17, 1985 with recommendations for these units as required under Ordinance 76U which allows construction of new multi-family rental structures if the rental rates of 20% of the units (or 10% if less than 10 units) are established at a level which will make them available for low and moderate income persons or households.

The following people spoke on the subject:

Ron Shipton, 8718 Rosewood, West Hollywood, CA 90048 Asked how income for eligible persons was verified.

RECOMMENDED ACTION: To approve staff recommendations on eligibility requirements, rent levels, unit mix, maintaining unit affordability, and administering the program.

ACTION: Directed staff to come back in about four weeks with some further recommendations on items one and five. Also wanted to find out the impact of the City's median income vs. the County wide median income for establishing income eligibility. In addition, Council did not want to waive the 5% inclusionary requirement very low regardless of the subsidy. By consensus of Council so ordered.

3. Density Bonuses and Inclusionary Zoning for Construction of Affordable Housing: Comparative analysis of density bonuses and inclusionary zoning (regulatory tools designed to increase the stock of housing affordable to low/moderate income people) from the Community Development Department dated October 30, 1985.

The following people spoke on the subject during the public hearing:

Dr. Paul Verdier, 1134 Alta Lama Rd., #211, W.H. 90069 Had special interest in seeing a 12 unit active senior's apartment house program initiated.

Ron Shipton, 8718 Rosewood, W.H. 90048 Reiterated letter sent to Council.

Abbe Land, 1301 Havenhurst, W.H. 90046 Urged Council to adopt the Inclusionary Zoning and Density Bonuses that staff had recommended. She believed that restrictions should be made very strict. Also, Ms. Land felt that this legislation should be adopted very quickly.

RECOMMENDED ACTION: To approve staff recommendation to adopt the density bonus program and an inclusionary zoning requirement; to approve an "in-lieu fee" option for projects with 20 units or less, that nonresidential projects contribute to an Affordable Housing Trust Fund; to instruct staff to further research an "in-lieu fee" program and report back in 4 weeks and to further instruct staff to review the inclusionary zoning program as regards the permanent zoning ordinance.

ACTION: As directed by Council during approval of agenda, no voting would take place on this item at this time.

5. Funding Request - Schindler House: Report from Community Development Department dated October 30, 1985.

RECOMMENDED ACTION: To approve staff recommendation that Council approve the request in concept and instruct staff to obtain additional information and report back to Council in four weeks with specific recommendations.

ACTION: To approve staff recommendations. Motion Heilman second Schulte. Hearing no objection so ordered.

6. Ordinance 92 and 92 U - Extending Vacancy Increase Application Deadline.

RECOMMENDED ACTION: To waive further reading and adopt Ordinance No. 92U, "AN ORDINANCE OF THE CITY OF WEST HOLLYWOOD AMENDING ORDINANCE NO. 59U AND AMENDING THE WEST HOLLYWOOD MUNICIPAL CODE AND DECLARING THE URGENCY THEREOF".
