- 3. Social Services Funding Recommendations: The following persons spoke during the the public hearing:

Morris Grumer, 6506 Wilshire Blvd., W.H. 90048, representing the Jewish Vocational Services - responded to questions from Council concerning what the agency was able to do between now and June 30th, 1986. Stated that he hoped that start up would begin by January 1st, 1986.

Eric Rofes, 1213 N. Highland Ave., L.A. 90038, representing the Gay and Lesbian Community Services Center, asked for full level of funding.

Bob Butler, 6671 Sunset Blvd., #1578, L.A. 90028, representing Traveler's Aide, stated that with funding from the City they would be able to service at least 500 West Hollywood youths per year. Mr. Butler stated that previously they were handling approximately 150 West Hollywood youths per year.

Steve Oster, 8489 West 3rd St., representing the Triangle Project, summarized the services offered by the Triangle project which deals with placing gay and lesbian children in foster homes able to deal with their particular needs.

(Councilmember Terrigno arrived at this time - 8:10 p.m.)

David Glascock, 7045 Hawthorn, L.A. 90028, representing the Gay Protection Project, outlined the service offered.

John Hagar, 444 Lincoln, #319, L.A, 90291, also representing the Gay Protection Project, stated that 60% - 65% of the inmates housed in the gay housing units in the Hall of Justice give their address in West Hollywood. Also stated that the aim of the project was to address the problems from West Hollywood.

Gary Bess, 8405 Beverly Blvd., 90048, Director of the Free Clinic, outlined the services offered and stated that their program was volunteer intensive. Virtually all patient care was provided on a volunteer basis. Also stated that one out of five youth served in their high risk youth project are from West Hollywood.

Glenda Tusher, spoke in support of free clinic.

RECOMMENDED ACTION: That the City Council approve the following:

- 1. Approve the funding level, program concept, and minimum goals; authorize staff to negotiate the actual project description, scope of services, and budget documents for execution by January 1, 1986 of each of the following agencies:
 - A. Jewish Vocational Services for \$215,197 to provide a minimum of 400 recent immigrants with social and vocational services in a new project.
 - B. Los Angeles Free Clinic for \$60,000 to provide 3900 adults with counseling, legal, medical, and dental services as a program service expansion.
 - C. Los Angeles Free Clinic for \$102,805 to open a storefront center providing medical, psychosocial, casework, employment, counseling, and/or information and referral to a minimum of 600 Homeless Youth.
 - D. Traveler's Aid Teen Canteen for \$25,000 to provide outreach, referral, and/or family reunification to 250 youth.
 - E. The Triangle Project for \$25,000 to advocate for and place 15 (primarily Gay and Lesbian) youth in foster homes and provide training and education to increase the available foster homes.
- 2. Reserve \$77,300 for the Gay and Lesbian Community Services Center; \$50,000 for social services provision to Lesbians, and \$27,300 for administrative overhead for all their West Hollywood services, and authorize staff to submit a specific recommendation to the City Council in one month.
- 3. Table consideration of the Gay Protection Project proposal activity and authorize staff to submit a specific recommendation to the City Council in one month.
- 4. Approve the purchase of \$1,881 worth of educational materials for distribution by Project 10 of Fairfax High School.
- 5. Reserve the fund balance of \$295,560 for the Homeless Adult RFP and other unmet social service needs.
- 6. Deny the following proposals:
 - A. The Gay and Lesbian Community Services Center Homeless Youth proposal
 - B. The Gay and Lesbian Adolescent Social Services Homeless Youth proposal
 - C. The Ocean Park Community Center Homeless Youth proposal.
 - D. The Boris and Anna Shprit Day Care proposal.

PROPOSED ACTION: To approve staff recommendation with the following modification: "That we (the City of West Hollywood) hold in reserve the additional \$20,700 that the Gay and Lesbian Service Center requested, to bring their entire amount - that to be worked out between now and June 30th - for services to be justified between the director at the center and our Social Services Director. 4. Dames and Moore: Extension of Contract for Huntley Drive: RECOMMENDED ACTION: That City Council extend the contract with Dames and Moore for a part-time, as-needed basis at an estimated cost of \$2,600 per week for approximately 20-25 professional staff hours per week.

8. Budget: RECOMMENDED ACTION: For City Council to open public hearing on budget, take testimony and close the public hearing. Then to direct any changes to the proposed budget.

The following people spoke during the public hearing:

Sam Haws, 650 Westbourne Dr., #107, W.H. 90069, from Christopher Street West: Requested City to budget for Sheriffs at the Christopher Street West Parade for an estimated \$80,000 - \$90,000.

Ron Shipton, 8718 Rosewood, W.H., directed the Council's attention to Commissions in the budget and asked if Commissions wanted to start programs, where would they get the funding?

ACTION: At this time Council closed the public hearing and directed staff to come back in two months with analysis on Christopher Street West's request. In addition, staff was directed to bring to the next Council meeting guidelines for City Council and staff expenditures. Finally, staff was to come back to Council on November 21, 1985 with a resolution for adoption of the budget.

NEW BUSINESS

10. Logo: RECOMMENDED ACTION: That the City Council approve Option 1, authorizing staff to develop a Request For Proposal to hire a design consultant to assist the City Council in the refinement and selection of the City seal/logo.

ACTION: To approve in concept attachment D which was the logo summitted by Tomito Kako. Council asked that the top part of logo remain the same; however, asked that either another artist or Mr. Kako modify the bottom part of logo (the grape like cluster and 1984). In addition, direction was given to eliminate the zip code from the border and have another phrase replace California, USA at the bottom. Finally, Council authorized a budget not to exceed \$2,000 to complete logo and get it into final shape by the end of the year. Motion Viterbi seconded Schulte.

9. Median Strip Acquisition: RECOMMENDED ACTION: Will be discussed during the closed session; therefore it is recommended that the agreement be deferred until after the session which is on the agenda at the end of the meeting.

ACTION: There being no need to take this Item to closed session the Council moved to ratify approval of an agreement between the City and the County of Los Angeles whereby the County of Los Angeles agrees to continue with its efforts to acquire the title of the Santa Monica Blvd. median strip and upon acquiring that title to convey title to the City of West Hollywood. The agreement to also call for the County to use its best efforts to rescind its prior agreement with the California Department of Transportation which called for them to convey title to that agency. Motion Terrigno seconded Mayor Heilman. Hearing no objection so ordered.

11. Establishment of Historical Preservation Citizens
Committee - Task Force: RECOMMENDED ACTION: To create a citizen's committee to work with the City to devise and implement a historical preservation program.

ACTION: To direct staff to establish protections for historic sites for procedural purposes to be brought back to Council within the next thirty days. In addition, that staff lay the groundwork for Council to appoint a task force early in 1986. Motion Schulte second Mayor Heilman. Hearing no objection so ordered.

12. Criminal History Information - Resolution No. 124. RECOMMENDED ACTION: To approve Resolution No. 124, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD AUTHORIZING THE CITY TO ACCESS SUMMARY CRIMINAL HISTORY INFORMATION FOR EMPLOYMENT, LICENSING, OR CERTIFICATION PURPOSES".

The following people addressed the Council during the Public portion of Written and Oral Communications:

Jeff Richmond, 1316 1/2 N. Havenhurst, #7, W.H. 90046: Brought to the Council's attention action taken at a legislative update session run by the League of California Cities. His concern dealt with the League's position on Assembly Bill 403's provisions which prohibited insurers and employers from using the test as a screen for applicants. The League supports the insurance industry in seeking changes in those provisions.

Council's recommendation was to direct staff to draft a letter to be sent to the League and Representatives in Sacramento stating the position of the City Council on changes in these provisions. In addition, to develop and present a resolution to the appropriate policy subcommittee within the League. Finally, gave direction to ask the League and their lobbyist that when an issue arises dealing with AIDS that they specifically consult the Council due to the City's interest concerning the issue.
