MINUTES WEST HOLLYWOOD CITY COUNCIL

DECEMBER 20, 1984

CALL TO ORDER:

The meeting was called to order at 7:30 p.m. by Mayor Terrigno in West Hollywood Park.

APPROVAL OF AGENDA:

Item No. 20 moved to follow No. 1. Discussion of rent control hot line added to New Business.

ACTION: To approve agenda as amended. Motion Viterbi seconded Heilman. Hearing no objection it was so ordered.

ITEM 1: OFFICIAL SWEARING IN OF CITY TREASURER Mr. Viterbi directed the treasurer to open an account for the City in which to deposit the general revenue funds approximated at \$139,000 as of this date.

ACTION: To approve Resolution No. 30 to accept the proposal of the Bank of Los Angeles to open a line of credit for the city in the amount of \$100,000 in the name of the City of West Hollywood.

Motion Viterbi seconded by Terrigno.

AYES: Heilman, Viterbi, Mayor Terrigno NOES: None ABSTAINED: Schulte Motion carried.

ITEM 2: CITY ATTORNEY REPORT: EMPLOYMENT DISCRIMINI-NATION - RELIGIOUS HOLIDAYS The City Attorney introduced Ordinance No.15, "AN ORDINANCE OF THE CITY OF WEST HOLLYWOOD PROHIBITING DISCRIMINATION IN EMPLOYMENT ON ACCOUNT OF RELIGIOUS BELIEFS."
Ordinance 15 provides protection for employees who wish to take time off for sabbaths or other holidays and provides protection against discrimination based on religious beliefs.

The City Attorney also presented a memo explaining the extent to which protections are now provided by state and federal laws which cover situations of five or more employees. The ordinance of the City of West Hollywood goes further to cover situations of one or more employees.

ACTION: To recommend foregoing further reading and adopt Ordinance No. 15. Motion Viterbi seconded Schulte.

ITEM 3: (cont'd.) POTENTIAL NUISANCE -NIGHT CLUBS, NOISE AND TRESPASSING

They complained of late night noise, congestion, littering, and trespassing. Some of the suggestions offered were to change "no-parking" to "tow-away" zones, provide alternate parking in an office building parking lot (i.e. 9000 Sunset), and ask the clubs to post signs on their premises warning patrons of strictly enforced parking laws.

ACTION: To have an ordinance ready for next council meeting to convert Harratt and North Clark red zones into tow away zones. Motion Viterbi seconded Schulte.

FURTHER ACTION: Move to table the previous motion to the planning and public safety $% \left(1\right) =\left(1\right) \left(1\right)$ subcommittees and have them make recommendation to the City Attorney prior to the next Council meeting.

FURTHER ACTION: To direct the City Manager to communicate to the Road Commissioner the request that the area which is already NO PARKING TOW AWAY on North Clark, but is not painted red, be painted red as soon as possible.

FURTHER ACTION: To have the City Manager communicate to the owners of the clubs and restaurants the request that they install a sign notifying their customers that all parking and noise regulations are strictly enforced in the city. Councilmember Schulte recommended that motion be tabled for more consideration.

FURTHER ACTION: A request be sent to the Planning and Parking Subcommittee or the Public Safety Committee of the City Council to explore the possibility of establishing a uniform sign to put in the clubs to advise patrons that parking regulations are strictly enforced in the City. Motion Viterbi seconded Schulte.

EXEMPTION
AMENDMENT NO. 1
REMODELING CAP.

As stated by Ms. Browne, this amendment would exempt entire remodeling of existing commercial projects provided that there is no increase in floor space, no change in the nature of the occupancy or type of use, and no change requiring additional parking under current applicable requirements. This also includes an amendment to Subsection A of Subsection 2. It removes the \$50,000 cap and adds the requirement that no change be made in parking requirements.

The following speakers addressed the council on this matter:

- 1. Joyce Goldschmidt, 814 South Westgate Ave., LA, spoke regarding the building at 155 N. La Peer recently acquired by her husband. Spoke for exemption.
- 2. Gregory Morton, 1230 Horn Ave. #618, spoke regarding change of use of his property at Hancock and Santa Monica which was formerly a nursery. He would like to convert it to other commercial use.

This consists of a minor change of building foot print for an existing building or structure solely for the purpose of providing access to the handicapped and if in line with applicable zoning and development standards.

Will allow construction of new multiple family residential structures where, one, zoning approval was received from the County of Los Angeles prior to November 29, 1984. Two, the structure will contain 15 or fewer units. And, three, the project is in compliance with all applicable zoning and development laws and standards. There are only three projects involved here all of which have

received zoning approval prior to November 29,

2. 7531 West Hampton Ave., 15 units, (plan check No. 7986).

3. 1016 N. Hancock Ave. 6 units, (plan check No. 7986). Demolition permit needed.

The owner of the Havenhurst property stated that his financial condition will be substantially jeopardized if these projects are not approved immediately. Mr. Ori Fogel, the developer on the Hampton property, stated that he thus far spent \$45,000 on this project and has a million dollar loan from the bank which is only guaranteed for a month. There is currently an empty building on the property.

Mr. Ron Stone advised the Council that a demolition permit would be required for the project on Hancock.

ACTION: To adopt Exemption Amendment No. 3 with inserts 1,2,3, and 4, and addition of "rental residential" and exemption 4. Motion Heilman seconded Schulte.

Motion carried.

The City Attorney stated that the City Clerk should type in item 1 through 4 into the ordinance and they would become Sections I,J,K, and M of Section 4 of Ordinance No. 9.

A recess was held and the meeting resumed at 9:15 p.m.

ITEM 6: EXEMPTION AMENDMENT NO. 4, SIGNS: ORDINANCE 17U ACTION: To adopt Ordinance 17U, "AN ORDINANCE OF THE CITY OF WEST HOLLYWOOD ESTABLISHING A MORATORIUM ON THE ISSUANCE OF SIGN PERMITS IN THE CONSTRUCTION OF NEW SIGNS IN THE CITY, DECLARING THE URGENCY THEREOF."

Motion Schulte seconded Viterbi. Hearing no objection it was so ordered.

Councilmember Schulte stated Subsection 4C - Fixed signs for new commercial establishments provided the sign conform to a wall.

Miti Schwartz, 1010 N. Palm Ave. #209, spoke regarding Splash on Sunset, 8909 Sunset. She would like to place a sign in place of an existing sign which is not flat. Exemption granted by Mr. Schulte.

ITEM 7: EXEMPTION REQUESTS -RENT CONTROL MORATORIUM ACTION: To adopt an exception clause on the subject of condominium sales where there existed a special lease agreement prior to the sale. The exception clause was stated by the City Attorney as follows: a) Rental units for which the owner had exemption to the eviction portion of the moratorium on eviction of a tenant from a single family building, condominium unit, or stock cooperative units, where the unit was a single family building, condominium, or stock cooperative when the entity was created; b) the tenant was provided notice in writing that the unit was going to be placed on the market for sale and the tenancy would be terminated upon sale; c) the tenant signed a written agreement separate and apart from any lease acknowledging the facts recited above; d) the unit has been sold or is in escrow and the new owner seeks in good faith to make the unit his own principal residence. This motion was moved by Mayor Terrigno and seconded by Councilmember Heilman.

The following persons spoke on this issue:1. Grafton Tanguary, 1287 N. Crescent Heights spoke to clarify some points in the exemption.

2. Ed Meripol, 1328 N. Havenhurst Drive, asked whether his condominium conversion units could be sold, having been previously approved by the state and county.

3. Alice Nunn, 8844 Rosewood, stated her hardship situation. To avoid bankrupcy, she would like to lease her house and live in the back apartment currently occupied by tenant.

ACTION: To have City Attorney write an ordinance as soon as possible to attempt to protect people under the moratorium, yet afford some aid to Ms. Nunn. Motion Terrigno seconded Heilman.

The following speakers spoke in general about the rent control:

- Herman Bachofner, 335 S. Almont Dr., Beverly Hills, stated that he had bought a building in July and must depend on rental increase to pay expenses.
- 2. Arnold Rubin, 17437 Palora, Encino, CA, stated that his building fell out of escrow because the prospective buyer could not afford it upon the rent roll-back. Also stated that he sent a letter to Council.
- 3. Betty Katz, 423 N. Palm Dr., #207, claimed that landlords who have not raised rents in years are the ones suffering the most.
- 4. Budd Kops, 969 N. Larrabee St., asked how he could recoup damage done to an apartment if he can't raise rent.
- 5. Wade Prince, 1260 N. Laurel Ave., asked if the eviction moratorium includes eviction of resident managers. In response Ms. Browne stated that someone who is hired as a manager is considered an employee. In that case the owner must give him written notice, but if the manager refuses to continue his duties, he may be evicted. This is not applicable if they were a tenant previous to being a manager.
- 6. Amel Amel, 6372 West Sixth St., stated that there was much renovation done to the apartments and now cannot get an increase in rent to offset those costs.

ACTION: To have the City Attorney draft an ordinance that would authorize the City of West Hollywood to do any outside contracting for printing services where the cost is greater than \$100.00. Hearing no objection it was so ordered.

Mayor Terrigno asked the City Manager to prepare a report and the City Attorney to check if it is in violation of any state or federal laws regarding other services to be contracted with union shops.

ITEM 9: ADMINISTRATIVE REPORT ON PERSONNEL SYSTEM. ACTION: To approve compensation for Adam Moss and Dori Stegman be set at \$1,800 per month and be retroactive to December 6, 1984 as a 60-day position. Hearing no objection it was so ordered.

Mr. Bien gave a brief summary of and recommended the implementation of a merit personnel system which incorporates the six federal guidelines presented in a report given to the council.

ACTION: Proposal be sent to the Personnel Committee to work out details and come back to the full Council after the first of the year when it will be adopted with or without modifications. Motion Heilman seconded Viterbi. Hearing no objection it was so ordered.

There was a discussion among the Councilmembers about the general direction, goals,
and plan for the city. Mr. Bien suggested
setting a special meeting just for the
purpose of such a discussion and Mr. Schulte
asked the City Manager to draft a report
for the attention of the community and
the City Attorney and to bring a list
of suggested planning consultants.

ACTION: That City Hall be closed on December 24th and 31st as well as Christmas and New Year's Day, and that it be a paid holiday. Motion Viterbi seconded Schulte. Hearing no objection it was so ordered.

The first and third Thursdays in January in West Hollywood Park, and the second and fourth Thursdays in Plummer Park.

The City Manager reported that he met with representatives of the Los Angeles County Transportation Commission to discuss the distribution of Proposition A funds. They informed him of the need to have the mayor execute a Statement of Assurance and Understanding regarding receipt and use of the funds.

ACTION: To have the City Attorney check the statement and have it signed within four to five days. Motion Mayor Terrigno seconded Schulte. Hearing no objection it was so ordered.

Councilmember Heilman requested this item be put on the agenda and stated his concern about the way the Council had reached its decision with regard to the City Council Committees. Councilmember Heilman asked someone to make a motion to reconsider. Mayor Terrigno stated that the minority cannot make a motion and moved on to the next item.

The City Attorney stated that the 45-day moratorium on building will expire on January 13, 1985, and that to extend it, PUBLIC HEARING SET FOR the Council will have to hold a public hearing with notice given.
