- Name of firm or individual.
- Address of principal place of business and all offices and corresponding telephone numbers.
- The number of years your organization has been in business under the present name.
- The number of years the business organization has been under the current management.
- A resume of the owner or the firm anticipated to provide services to the City.
- At least three (3) references of clients whom the General Contractor has provided construction services for accessory dwelling units and/or residential

- projects. Include client contact information, name, email, phone/ mobile number and a description of services provided.
- List and describe projects similar to what is being requested in the RFQ that
  general contractor has worked on and include the project information and
  address and the general description and timeframe of the project. Also include at
  least one photo of each project and overall construction cost/bid of the project.
- Proposed hourly rate and/or fee schedule to provide on-call services to the City.
- Contractor License information.
- Proof of no pending lawsuits nor outstanding liens.
- Proof of Bonding/Insurance as outlined in the insurance section below.
