 - A. FINAL HOUSING ELEMENT UPDATE: Final Environmental Impact Report (FEIR). Previously heard as Draft Environmental Impact Report (DEIR) during the November 22, 2021 HPC meeting.

STAFF RACHEL DIMOND briefly provided an update to the FEIR after receiving comment from the Commission and members of the public. The discussion consisted of information concerning the following topics:

Item 10.A. Commissioners Questions To Staff:

Members of the Commission, Staff and Rincon Consultants discussed recommended changes to the DEIR addressed during the November 2021 meeting concerning proposed Mitigation Measures, more specific to MM CUL-2a - Archaeological Resources Assessment.

Item 10.A. Public Comment: None

Item 10.A. Commissioner Comment:

COMMISSIONER LEVIN addressed concerns with the need for MM CUL-2a stating there is no justification for the measure and said it imposed a burden, without a useful benefit. He discussed components such as Phase 1 Pedestrian Surface Survey to locate any surface cultural materials which, is not needed due to the lack of archeological resources found and/or documented in the City.

He said he supports Mitigation Measure MM CUL-2b which states:

Unanticipated Discoveries: If cultural resources are encountered during ground-disturbing activities associated with individual development projects under the Housing Element Update, work in the immediate area shall be halted and an archaeologist meeting the Secretary of the Interior's Professional Qualification Standards for archaeology in either prehistoric or historic archaeology shall be contacted immediately to evaluate the find.

COMMISSIONER DUBIN said he supports previous comments by Commissioner Levin concerning the proposed measures potential to be a burden to all housing element projects within the City.

MEMBERS OF THE COMMISSION, STAFF RACHEL DIMOND AND RINCON CONSULTANT SUSANNE HUERTA discussed process and procedures concerning the selection of measures for DEIR and FEIR's such as MM CUL-2a to ensure all parties concerned are in compliance with state regulations.

Susanne Huerta stated the research consists of a record report only and is required to complete the report accurately. The general consensus of the HPC

is to recommend removal of the measure to City Council and the City undergo an Archeological Resource Survey instead.

Action: Motion to adopt Draft Resolution No. HPC 22-157 as amended with the recommendation to remove Mitigation Measure **MM CUL-2a**, maintain **MM CUL-2b**, of Draft Resolution No. HPC 22-157 and recommend the City consider undertaking a Citywide, Archeological Resource Survey as proposed under **MM CUL-2a**.

Motion by Commissioner Levin second by Commissioner Davidson and Motion passes on roll call vote 7/0 in favor of the project.
