Any final determination by the Business License Commission may be appealed, an such appeal must be filed within fifteen (15) calendar days after the Planning Commission action. This appeal shall be made in written form to the City Clerk's Office, accompanied by tan appeal fee.

The City Clerk, upon filing of said appeal, will set petition for a public hearing before the City of West Hollywood's City Council at the earliest date.

If you challenge any City of West Hollywood decision in court, you may be limited to raising only those issues you or someone else raised at the public hearing described on this agenda, or in a written correspondence delivered to the Business License Commission at, or prior to, the public hearing.
