Boardmember Juhn stated that she looked forward to working with the Board and was happy to see that the Board is working on issues that are important to her.

Boardmember de Silva mentioned that she will be travelling to Greece and Italy. She also stated that she will be continuing her college education.

Boardmember Moore noted that the Board had made a lots of progress this evening. She noted that the next Woman's Advisory Board meeting is September 22, 2022, is

also Women in Business Day. She also reported that that her podcast Talkshoplive is producing a day of content regarding women owned businesses on September 22, 2022. She is looking forward to seeing Board members at the Women's Equality Day pop-up this Saturday, August 27, 2022.

Boardmember Payton expressed her appreciation to the Recreation Division. She commended the opening ceremonies and beautiful facilities at the new Parks and Recreations Center. She encouraged Boardmembers to check out the facilities. She stated that she looked forward to seeing the Boardmembers this Saturday.

Chair Field discussed the Public Safety meeting she attended and addressed the difficulty of people speaking about intimate issues publicly, but that it helps others to feel less alone. She mentioned that California Senate Bill SB-1245, The Los Angeles County Abortion Access Safe Haven Pilot Program, was doing well. She also welcomed new Boardmember Juhn.

Chair Field welcomed back Larissa Fooks, Staff Liaison for the Women's Advisory Board.

11.ITEMS FROM STAFF:

Larissa Fooks, Staff Liaison, thanked the Board for the welcome back. She mentioned that subcommittee follow up will need to be added to the next Agenda. She reported that two bills will be up before the Legislature next week and August 3¹, 2022 is the last day for Legislature to pass any bills. She stated that September 30th is the last day for the Governor to sign any bills that have been passed by the Legislature. She encouraged Boardmembers to continue their advocacy. She concluded by mentioning that she will have materials and additional information to share regarding Domestic Violence Month that is in October.

Andi Lovano encouraged meeting attendees to make public comments at this time.

Jessica Mosher Felizzola, West Hollywood, expressed interest in the topics brought up by the Board. She also asked about Latina representation on the Board. City Staff responded that they would investigate that for her.
