TELECONFERENCE MEETING

- 1. CALL TO ORDER Chair Blood called the meeting to order at 6:00 PM.

D. PUBLIC COMMENT

Kerri Balbone, Public Safety Commission Liaison, thanked those who attended the Public Safety Commission's most recent meeting on bike scooters and mobility issues and spoke about what the vendors are doing to improve public safety.

Danny Hang, West Hollywood resident, thanked the Board, staff, Mayor and Councilmembers for being able to serve on the Disabilities Advisory Board.

A. TITLE: VISION ZERO ACTION PLAN TASK FORCE

SUBJECT: The Disabilities Advisory Board received a presentation from Bob Cheung, Senior Transportation Planner, on the Vision Zero Action Plan and selected a representative for the task force.

ACTION: Received report and selected Boardmember Friedman as the task force representative, with Boardmember Semonco as an alternate. **Approved by roll call vote.**

B. TITLE: DISABILITIES AWARENESS MONTH

SUBJECT: The Disabilities Advisory Board discussed the October televised meeting, service awards, and vaccination event. Doug Nguyen, Transportation Program Administrator, provided voting guidelines and instructions.

ACTION: Approved award guidelines, nomination form, and timeline. Discussed and approved theme and format for televised meeting, and vaccine event including voter registration activity.

6. PUBLIC COMMENT

7. ITEMS FROM BOARD MEMBERS

Boardmember Dore spoke about attending the Public Safety Commission's meeting, along with Boardmember Friedman. She spoke about scooters and their negative impacts on the mobility of people living with disabilities. She mentioned the budget and the allotment of funds to support people living with disabilities. She encouraged the Board to attend the Human Services Commission meeting.

Boardmember Friedman motioned to adjourn in honor of Ruth Williams. She mentioned that she attended the Public Safety Commission, Human Services Commission, and Transportation Commission meetings and brought up the issue of scooters and mobility.

Boardmember Nash spoke about the Pride celebration and the cost for admission at the festival site. He mentioned that he would like to see the cost dropped or done away with entirely. He spoke about the traffic congestion around the Pacific Design Center. He spoke about a Public Works issue.

Boardmember Semonco spoke about crowd control for festivals and large scale events and brought up an issue with MTA drivers not asking if she needs help in getting up the ramp. She spoke about attending the Women's Advisory Board meeting.

Boardmember Smith thanked the Board for their comments and spoke about the new County department for aging and disability.

Boardmember Watts spoke about a law on rent stabilization and affordability. He seconded the motion to adjourn the meeting in honor of Ruth Williams.

Chair Blood thanked the presenters, staff and Boardmember Friedman for volunteering to the be the task force representative. He thanked Danny Hang for his service on the Board. He mentioned a new movie starring Vanessa Burghardt, who is living with autism, and the

awareness that this brings to entertainment for those living with disabilities. He mentioned comments made by Lizzo that were received by many as derogatory toward people with disabilities and the apology that followed. He spoke about his involvement in the Pride Parade and moved to adjourn in honor of Ruth Williams.

8. ITEMS FROM STAFF

Derek Murray, Social Services Program Administrator, spoke about the Human Services Commission meetings in July that will cover RFP, social services, funding and other big decisions the Commission will make. He mentioned that those meetings will be held July 12th, July 19th and July 26th. He spoke about the increase in fentanyl overdose deaths and mentioned the purchase of 8,000 fentanyl testing strips for Pride. Due to the widespread presence of fentanyl in other drugs, he encouraged anyone who uses recreational drugs to get them tested for fentanyl. He asked the Board to adjourn in memory of Carlos Katana Rios, a West Hollywood resident and long-time HIV prevention advocate.

9. ADJOURNMENT

The Disabilities Advisory Board adjourned in memory of Ruth Williams and Carlos Katana Rios to its next meeting, which will be held at 6:00 pm on Wednesday, July 27, 2022, via teleconference.
