#### Los Angeles County Energy Program (LACEP):

The group discussed how local cities might contribute to the program and noted that Solar Santa Monica's program is a model for the larger LACEP program. LACEP essentially is a regional program but product delivery is local, which is why local community oversight is so important.

Staff was directed to obtain more information clarifying the roles of the County, utility companies, local communities and other participants. Staff was also directed to obtain more information about funding available for use by cities and COGs.

Staff contacted the appropriate county representatives and sent a written report to the Committee (included as Section 7. Receive and File Item B below). LACEP staff hopes the WSCCOG will take an active role in marketing outreach and funding is available to assist in that effort.

# SB 375, California's Sustainable Communities Strategy (SCS) and Climate Protection Act:

At its June 24, 2010 meeting, SCAG and several other MPOs submitted a joint recommendation to the California Air Resources Board (CARB), to set greenhouse gas (GHG) reduction targets under SB375.

SCAG's recommendation included analysis of five scenarios developed through its model, which range from 6%-10% reductions by 2020 and 3%-12% by 2035. SCAG recommended a target range that reflected Scenarios Two and Three (i.e. 7%- 8% reduction by 2010 and 5%-6% reduction by 2035), relying upon the adopted 2008 RTP with additional measures that can be achieved with existing funding. CARB agreed.

WSCCOG jurisdictions' current planning efforts and existing programs are more proactive in targeting GHG reduction than many other regions. The Westside Cities' Planning staff group will continue to participate in the collaborative process for development of the SCS.

## Continued Discussion of Sustainability Work Program 2010-2012:

Staff was requested to meet prior to the August meeting to review, revise and prioritize the work program. Staff developed a first draft on June 28, 2010 and will refine it prior to the August meeting.

C. June 14, 2010 and July 6, 2010 Draft Meeting Notes, Report and Recommendations from the COG **Transportation Committee** and Related Items

<u>30/10 Initiative</u>: No consensus was reached on a recommendation and it was noted that one elected representative of the committee (Council Member Brien) was unavailable to participate in the discussion. Staff coordinated a conference call on July 6, 2010 for all of the elected representatives on the committee for further review/consideration. Recommended for discussion by the full Board at July 15, 2010 meeting.

Measure R: The status of the 3% contribution is a work-in-progress and an ongoing item that the committee will continue to monitor and agenda for review as appropriate. There is no schedule defined but it is possible that one may be available by the August committee meeting.
