**CALL TO ORDER:** Mayor Meister called the meeting to order at 6:01 p.m.

**PLEDGE OF ALLEGIANCE:** Shannon Morton led the Pledge of Allegiance.

### REPORT OF CLOSED SESSION AGENDA:

City Attorney Langer reported that the Closed Session was called to order at 5:30 p.m. She stated that no members of the public spoke under public comment. The City Council discussed the one item of business on the posted agenda and took no reportable action.

## **APPROVAL OF AGENDA:**

Staff requested that Item 2.N. be Tabled to the November 21, 2022 City Council meeting.

Councilmember Erickson requested that Items 4.A. and 5.B. be moved to the Consent Calendar as Items 2.Y. and 2.Z., respectively.

Motion by Councilmember Erickson, seconded by Mayor Meister to approve the November 7, 2022 Agenda as amended.

## **ADJOURNMENT MOTIONS:**

Mayor Meister requested that the meeting be adjourned in memory of Leslie Jordan and Ljilyana Mijujlic.

Mayor Pro Tempore Shyne requested that the meeting be adjourned in memory of Dawn Williams and Becky Lincoln.

Councilmember Horvath requested that the meeting be adjourned in memory of the Honorable Rosalind Wyman and the Mass Shooting Victims of Raleigh, North Carolina: Gabriel Torres, 29; James Thompson, 16; Mary Marshall, 34; Nicole Connors, 52; and Susan Karnatz, 49.

Councilmember D'Amico also requested that the meeting be adjourned in memory of Leslie Jordan.

#### PRESENTATIONS:

Mayor Pro Tempore Shyne presented a Proclamation to Pastors Josh Johnson and Michael Popham of InVision LA.

### 1. PUBLIC COMMENT:

MISS TIGER, WEST HOLLYWOOD, spoke to honor Leslie Jordan, her nomination of Leslie Jordan for the Rainbow Key Award last year, and in opposition to Item 4.A.

ADAM DARVISH, WEST HOLLYWOOD, spoke in support of Items 2.U., 2.W., and 2.X.

STEVE MARTIN, WEST HOLLYWOOD, spoke of his memories of Leslie Jordan and to encourage everyone to vote tomorrow.

WEST SEEGMILLER, WEST HOLLYWOOD, spoke about the event that Free WeHo Coalition is hosting on Friday, December 9<sup>th</sup> at Plummer Park - Fiesta Hall entitled, "WeHo Uncensored".

CHRIS BALDWIN, WEST HOLLYWOOD, spoke about the contract on the agenda this evening for the Women's Freedom Festival. She also commented on including the LGBTQ+ Commission with the review and approval of the affinity groups for Pride 2023.

VIRGINIA FOUT, ON BEHALF OF THE ELTON JOHN AIDS FOUNDATION, spoke to thank the City for the approval of Item 2.M.

SUSAN MARKHEIM, WEST HOLLYWOOD, spoke about noise emanating from the One Hotel and Ziggy Hotel.

JOYCE HEFTEL, WEST HOLLYWOOD, spoke about the noise affecting the Fountain View Condominiums from the One Hotel and Ziggy Hotel.

LYNN RUSSELL, WEST HOLLYWOOD, spoke about the letter that she sent to Jennifer Newsom regarding Councilmember Horvath's campaign for Los Angeles County Board of Supervisors.

#### COUNCILMEMBER COMMENTS AND MEETING ATTENDANCE REPORTS:

Councilmember Erickson requested that staff reach out to Susan Markheim and Joyce Heftel regarding their concerns about the noise emanating from the hotels adjacent to their condominiums. He mentioned issues along Harrat Street and requested that staff meet with the neighborhood group to address them. He reported his attendance at the Community Forum on Prop 1. He spoke at an event at Cal State Northridge on the history of West Hollywood. He attended the Public Transportation Service Corporation meeting, volunteered at Project Angel Food, the Community Safety and Well Being meetings, the Contract Cities Executive Board meeting, the SCAG Energy and Environmental Committee, the SCAG Regional Committee, the Trans Visibility March Torch Awards/Rally/March, and the TransVagina Diaries. He requested an additional adjournment in memory of Aaron Carter. He requested that staff place an item on the agenda to posthumously award a Rainbow Key Award. He shared that he will host another "Saturdays with John" at Plummer park on Saturday, November 12 at 10:00 a.m. He wished good luck to the candidates on the November 8<sup>th</sup> ballot. Lastly, he spoke about civility in politics and encouraged everyone to vote.

Councilmember D'Amico commented on Item 5.B. and thanked his colleagues for their work on affordable housing in the City. He expressed his excitement about West Hollywood Pride, noting that he was honored to serve on the City Council Pride Subcommittee since he was elected to the City Council. He shared his experience walking the City on Halloween. He requested that City staff bring forward an item to the next City Council meeting to discuss the impacts to businesses along Melrose due to the Streetscape Project. He agreed with Councilmember Erickson's comments on elections and their purpose.

Mayor Pro Tempore Shyne reported her attendance at the Laurel House Subcommittee meeting, the Community Forum on Prop 1, the Disabilities Service Awards, the Extreme Collection Ribbon Cutting, the Arts dedication event for the Parallel Perpendicular, as well as the National Trans Visibility March/Awards/Torch lighting. She thanked her colleagues for supporting Item 2.U. She reiterated the direction on the affinity groups and the inclusion of the LGBTQ+ Commission in the planning of West Hollywood Pride 2023. She also commented that JJLA's sponsors should not use the term "Official" in their programming. She provided an update on the protests in Iran. She concluded her comments by reading a letter that was submitted to President Biden from Iranian women in government.

Councilmember Horvath spoke about the upcoming Veteran's Day Event and apologized that she won't be able to attend. She reported her attendance at the Prop 1 Town Hall, the Trans Visibility March and Awards, and the TransVagina diaries. She joined Mayor Pro Tempore Shyne in Beverly Hills protesting Iran. She also attended the SCAG Transportation Committee, the Contract Cities Board Meeting, the retirement celebration for Los Angeles County Fire Chief Osby, and the National League of Cities Forum on the CVS Prescription Drug Program. She requested that staff bring an item to a future City Council meeting regarding noise complaints at the hotel locations

mentioned during Public Comment and how staff is addressing them. Finally, she wished all of the candidates on the November 8<sup>th</sup> ballot good luck.

Mayor Meister reported her attendance at the Laurel House Subcommittee meeting, the Great Shakeout, the El Pollo Loco Ribbon Cutting, the Great White Café on Melrose Ribbon Cutting, the 25<sup>th</sup> Anniversary of Melrose Trading Post, the Disability Service Awards, the Kids Fair, the dedication for Parallel Perpendicular, the CERT graduation, the West Hollywood Elementary School Halloween parade, the LA Regional Mayors Roundtable on Infrastructure, the SCAG CEHD meeting, the Sanitation District Personnel Committee meeting, and the National Trans Visibility Torch Awards. She mentioned Item 2.M. and requested that City staff try to keep the West Hollywood Dog Park open during large scale events. She mentioned several upcoming events in the City. She requested that UDAS staff as well as a sound expert visit the hotels mentioned during Public Comment and provide recommendations to mitigate noise. She requested that at a future City Council Finance and Budget Subcommittee meeting that staff provide a cost analysis on a reduced Halloween event as well as have the Arts Division look at spooky art along Santa Monica Boulevard to add to the Halloween ambiance. Lastly, she wished everyone good luck on Election Day.

#### **CITY MANAGER'S REPORT:**

City Manager Wilson requested that City Clerk Crowder provide information on voting locations and Vote by Mail drop box locations for the public. City Clerk Crowder provided the location of the three (3) Vote Centers in West Hollywood. She also provided the locations of the three (3) Vote by Mail drop boxes in the City, as well as encouraged members of the public to contact the City Clerk's Office if they have any questions on Election Day.

City Manager Wilson responded to Council inquiries. He shared that the City has reopened the pools at the ARC; however, he noted upcoming closures at the facility due to holidays. He congratulated the 22 community members who completed CERT training. He further shared that in October, 153 employees completed the bystander training and in total nearly 2,100 employees have completed the training. He mentioned that November is Transgender Awareness Month and provided information on the events the City is hosting in honor of it.

### FISCAL IMPACT ON CONSENT CALENDAR:

City Clerk Crowder stated that the fiscal impact on the Consent Calendar with the removal of Item 2.N. and the addition of Items 4.A. and 5.B. is \$1,063,946 in expenditures, \$46,916 in revenues, and (\$29,158) in waived fees.
