CALL TO ORDER: Mayor Meister called the meeting to order at 6:04 p.m.

PLEDGE OF ALLEGIANCE: Assemblymember Rick Zbur led the Pledge of Allegiance.

A. RESOLUTION DECLARING THE RESULTS OF THE NOVEMBER 8, 2022, CONSOLIDATED MUNICIPAL ELECTION [J. JIMENEZ, M. CROWDER, L. MORALES]:

SUBJECT: The City Council is requested to adopt a Resolution declaring the results and accepting the official canvass and official statement of votes cast from the Los Angeles County Registrar--Recorder/County Clerk for the Consolidated Municipal Election held November 8, 2022.

City Clerk Crowder declared Lauren Meister, Chelsea Byers, and John Heilman elected as Members of the City Council to a full term of four years and requested that the City Council adopt a Resolution accepting the official canvas and

statement of votes cast from the Los Angeles County Registrar-Recorder/County Clerk.

ACTIONS: Declare Lauren Meister, Chelsea Byers, and John Heilman elected as Members of the City Council to a full term of four years; and 2) Adopt Resolution No 22-5575, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD, CALIFORNIA, ACCEPTING THE LOS ANGELES COUNTY REGISTRAR-RECORDER/COUNTY CLERK'S OFFICIAL CANVASS AND OFFICIAL STATEMENT OF VOTES CAST FOR THE CONSOLIDATED MUNICIPAL ELECTION HELD ON NOVEMBER 8, 2022, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW". Motion by Councilmember Erickson, seconded by Mayor Pro Tempore Shyne, and approved.

B. COUNCILMEMBER COMMENTS:

Councilmember Erickson congratulated the incoming Councilmembers and Mayor Meister on her reelection.

Mayro Pro Tempore Shyne congratulated Councilmembers Heilman and Byers, and Mayor Meister on her reelection.

Mayor Meister congratulated Councilmember Heilman and Byers on their election.

C. LAUREN MEISTER, CHELSEA BYERS, AND JOHN HEILMAN WILL BE ADMINISTERED THE OATH OF OFFICE:

City Clerk Crowder administered the Oath of Office to Councilmembers Chelsea Lee Byers and John Heilman. Michael Willens administered the Oath of Office to Councilmember Lauren Meister.

City Clerk Crowder stated for the record that Councilmember Byers and Councilmember Heilman were voting members and placed their name plates accordingly at the Dias. Councilmembers Byers, Erickson, Heilman, Mayor Pro Tempore Shyne and Mayor Meister constituted a quorum.

D. NEWLY ELECTED COUNCILMEMBER COMMENTS:

Councilmember Byers thanked all present, her family participating on Zoom, her teachers for their support, City staff, and colleagues. She expressed gratitude to her partner Austin, and all who assisted her in her campaign.

Councilmember Heilman thanked the voters for giving him the opportunity to serve the community. He thanked City Clerk Crowder for her support and guidance during the election. He thanked Supervisor Horvath and Councilmember D'Amico for their service to the City.

Mayor Meister thanked her sister and family, her best friend Michael for swearing her in, as well as her campaign team, volunteers, and the voters. Mayor Meister responded to a comment made by one of her colleagues at the last City Council meeting regarding her core values. Mayor Meister stated her core values for the record. She noted the value of having diverse opinions and working together towards consensus.

The City Council reconsidered this portion of the agenda after Councilmembers Byers and Heilman were seated at the Dias.

City Clerk Crowder stated that there were no changes from staff.

Mayor Pro Tempore Shyne requested Items 4.B. and 5.A. be moved to the Consent Calendar, as Items 2.V. and 2.W. respectively. She also requested that Items 4.C., 4.D., and 4.E. be combined into one Item for discussion.

M. ELLIE ALYESHMERNI, ON BEHALF OF THE IRANIAN AMERICAN JEWISH FEDERATION, spoke in support of Item 2.U.

ADAM SIDMAN, WEST HOLLYWOOD, spoke in support of Item 2. K.

NOOSHIM MESHKATH, UNKNOWN, spoke in support of item 2.U.

ANNIE JUMP VICENTE, WEST HOLLYWOOD, provided comments concerning an incident with law enforcement and expressed safety concerns as a Transgender woman.

SHARON N., BEVERLY HILLS, spoke in support of Item 2.U.

CHAD KROGER, WEST HOLLYWOOD, spoke regarding ideas of things to acknowledge in the City.

MARIAH DARLING, WEST HOLLYWOOD, expressed concern regarding the incident involving Annie Jump Vicente.

RENA GOLDMAN WEST HOLLYWOOD, spoke on police issues and requested the City Council address root causes by investing in the community.

JONATHAN HARLING, WEST HOLLYWOOD, commented on concerns regarding the lack of resources for mental health issues, police incidents, and unhoused community members.

ANDY SHORT, LOS ANGELES, spoke regarding the new sober New Year's Event, "Vibe". He invited the community to attend and thanked the City for their partnership and collaboration.

JORDAN DAVID, WEST HOLLYWOOD, spoke regarding reducing Deputies in the City and increasing resources for unhoused community members.

JULIAN RICH, LOS ANGELES, expressed disagreement with the public's demeanor towards the Transgender community, requested that Deputies be held responsible, and demanded the City Council reimagine public safety.

SIBYL ZADEN, WEST HOLLYWOOD, congratulated the newly installed Councilmembers and thanked the outgoing members for their service. She also spoke regarding her involvement with the City throughout the years.

DIMITRI KERMANI, WEST HOLLYWOOD, congratulated the new Councilmembers and informed the community about a police academy available for individuals interested in receiving a comprehensive experience with law enforcement.

DANNY HANG, WEST HOLLYWOOD, congratulated the new Councilmembers and spoke in support of Item 2U.

GENEVIEVE MORRILL, WEST HOLLYWOOD CHAMBER OF COMMERCE PRESIDENT/CEO, congratulated newly elected Councilmember Byers, welcomed Councilmember Heilman back, and congratulated Mayor Meister on her reelection. She also spoke about the need for relationships amongst City staff, government entities, and businesses to move the City forward.

NICHOLAS ROYBAL, WEST HOLLYWOOD, spoke regarding the need for kindness.

RACHEL NAGANT, LOS ANGELES, spoke on issues involving the Transgender community, Los Angeles Sheriff's Department gangs, and accountability of police officers.

JONATHAN WILSON, WEST HOLLYWOOD, congratulated the new Councilmembers and thanked them in advance for their support of business owners. He requested that the recommendations and direction regarding the Social Justice Task Force move forward.

JACKIE STEELE, WEST HOLLYWOOD, spoke regarding the incident with Annie Jump Vicente. She also welcomed and congratulated newly elected Councilmembers.

WEST SEEGMILLER, WEST HOLLYWOOD, spoke regarding Annie Jump Vicente's incident as well as, privacy issues with surveillance cameras.

JAMES DEAN LESTRANGE, UNKNOWN, spoke regarding the incident with Annie Jump Vicente and questioned why this matter was not addressed.

RUSTY WIGGS, WEST HOLLYWOOD, encouraged communication and self-reflection to uplift the City and disseminate a positive message.

DUANE PAUL, UNKNOWN, requested accountability for Annie Jump Vicente's incident.

ADAM DARVISH, WEST HOLLYWOOD, congratulated the incoming Councilmembers and thanked all of the candidates that ran for office in the November 8, 2022 General Municipal Election.

COUNCILMEMBER COMMENTS AND MEETING ATTENDANCE REPORTS:

Councilmember Byers reported her attendance at the AB 1234 Ethics Training hosted by the City Attorney and City Clerk and thanked them for a comprehensive training. She also spoke in support of Item 2.U and raising awareness so that conversations can continue.

Councilmember Erickson reported attending the Grand Opening of the Sunset Spectacular, Contract Cities Board of Directors meeting, the Los Angeles for a New Alliance Event, and the West Hollywood Staff Appreciation Event. Additionally, he thanked Mayor Pro Tempore Shyne for Item 2.U. noting that he recently attended the West Coast Democratic Leadership event in Israel. He wished everyone happy holidays. He commented on a few Consent Calendar items. He congratulated his nephew for being Student of the Week.

Mayor Pro Tempore Shyne wished everyone Happy Holidays. She reported her attendance at the Grand Opening of the Sunset Spectacular, the Human Rights Speaker Series *Roots of Peace*, the West Hollywood Staff Appreciation Event, the installation of Los Angeles Mayor Karen Bass, the City Council Homelessness Subcommittee meeting, and the memorial services for former Historic Preservation Commissioner Ed Levin. She acknowledged the public comments by Annie Jump Vicente and Mariah Darling. She made various requests to the Los Angeles County Sheriff's Department regarding Ms. Vicente's arrest. Additionally, she clarified that she is an Iranian Woman of Color. She requested that the City Manager respond to Jonathan Wilson's Public Comment regarding the recommendations from the Social Justice Task Force. She concluded her comments by providing an update on Iranian women's freedom in Iran in tandem with support for Item 2.U and read the resolution into the record.

Mayor Meister commented on attending the Combatting Ageism event with Dr. Paul Nash, the Human Rights Speaker Series *Roots of Peace*, the staff appreciation party, the Business Community Focus Group regarding the Holloway Project Homekey, Grand

Opening of the Sunset Spectacular, the Westside Cities Council of Governments (WSCCOG), the Sanitation District 4, and the Schmitty's Bar Ribbon Cutting. She mentioned several Consent Calendar items. She wished everyone happy holidays. She invited the community to attend the sober free New Year's Eve event "Vibe. She concluded by requesting an update on when the crosswalk will be completed at Doheny and Elevado.

CITY MANAGER'S REPORT:

City Manager Wilson congratulated Mayor Meister for her reelection. He also congratulated Councilmembers Byers and Heilman on their election to the City Council. He responded to the inquiry regarding the Social Justice Task Force item, noting that the City Clerk will bring an Item at the January 23rd City Council meeting creating the Social Justice Advisory Board, and the City Attorney will bring an Item providing an update on the recommendations from the Task Force. He commented that the crosswalk at Doheny and Elevado should be completed by the end of the week. He congratulated Human Resources Manager Sue Schumacher and Transportation Engineering Technician Eric Millsap on their retirements from the City.

SUBJECT: The City Council will consider a request to co-sponsor "Ladies of Courage" organized by Eye Poet LLC on March 25-26, 2023 from 2 p.m. to 10 p.m. at West Hollywood Park as part of Women's History Month programming. Ladies of Courage is an interactive installation featuring artwork and performances, including projections on walls and buildings, music, spoken word, and dance.

Events Services Supervisor Megan Reath provided background information as outlined in the staff report dated December 19, 2022.

ANNIE JUMP VICENTE, WEST HOLLYWOOD, requested that the City consider allowing bicycles inside the event, consider options for the homeless community, and allow public transit along Santa Monica Boulevard to continue during Pride weekend.

The City Council discussed the various options presented by City staff.

Councilmember Erickson thanked staff and noted his support of Options 2 and 3.

Councilmember Byers thanked staff for presenting robust options, and stated she envisioned the closure of Santa Monica Boulevard with accessibility to bike riders and requested that the City collaborate with Metro to reroute those who utilize public transportation accordingly. She also suggested co-sponsorship events like CicLAvia to attract more people.

Councilmember Heilman expressed concern with the budget and requested bike access be separate from pedestrian walkways for safety purposes. He indicated his support for Option 3 and requested that staff and JJLA pursue sponsorships to offset the cost to the City.

Mayor Pro Tempore Shyne spoke in support of hosting the free Friday night event, including the Santa Monica Boulevard closure, and directing staff to seek sponsorships.

Mayor Meister asked if Robertson Blvd. and La Peer would not be part of the Pride footprint due to construction. If not, she was supportive of Option 3.

Event Producer Jeff Consoletti of JJLA spoke about the street closures and the footprint for Pride 2023.

ACTIONS: 1) Proceed with Option 2 as outlined in the Staff Report; 2) Provide a free Friday night option; and 3) Authorize the Director of Finance & Technology Services to allocate \$5,448,900 from the unallocated General Fund Reserves to account 100-3-50-52-535013. **Motion by Mayor Pro Tempore Shyne, seconded by Councilmember Erickson, and approved.**

4.B. DISCUSSION REGARDING RESUMING TELECONFERENCE MEETINGS FOR THE CITY'S COMMISSIONS AND ADVISORY BOARDS [D. WILSON, L. LANGER, J. JIMENEZ, M. CROWDER, L. MORALES]:

4.C. SEMI-ANNUAL COMMUNITY SAFETY UPDATE [D. RIVAS, W. MOULDER, D. SMITH, C. SCHROEDER, C. PLANCK, L. ISENBERG]: SUBJECT: The City Council will receive an update on community safety activities, including year to date crime data from January to November 2022; progress of the Block by Block Security Ambassador Program; collaboration between social services outreach and law enforcement; and progress on training for the West Hollywood Sheriff's Station and Block by Block Security Ambassadors.

*Items 4.C, 4.D and 4.E were discussed as a joint item.

Director of Community Safety Danny Rivas, West Hollywood Sheriff Station Captain Bill Moulder, and Vice President of Block by Block David Aguilar provided background information as outlined in the staff report dated December 19, 2022.

Councilmember Erickson requested pickpocketing crimes be escalated to the FBI. Mayor Pro Tempore Shyne inquired about the differences in a misdemeanor sexual assault crime versus a felony sexual assault crime. Captain Moulder provided clarification on how this is determined. Councilmember Heilman expounded on the clarification under California law.

JACKIE STEELE, WEST HOLLYWOOD, spoke regarding the memo from the Public Safety Commission.

ANNIE JUMP VICENTE, WEST HOLLYWOOD, expressed concern that the City Council combined the items. She also spoke regarding her recent incident with Sheriff's Deputies.

ARJAN TIMMERMANS, WEST HOLLYWOOD, spoke regarding the recent training that he attended that provided him a different viewpoint of law enforcement.

EDD HOLMAN, WEST HOLLYWOOD, inquired where the Block by Block security ambassadors patrolled since he did not see them around his neighborhood. He requested that they be more present throughout the community.

JONATHAN HARLING, UNKNOWN, expressed concern with Block by Block as well as Sheriff's deputies and the recent incident involving Annie Jump Vicente.

YOLA DORE, WEST HOLLYWOOD, commented on the City's unsuccessful attempt for a West Hollywood Police Department in the past as well as, the need for additional resources to keep the community safe.

SHANE NASH, LOS ANGELES, spoke regarding the need for clarification on the statistics noted in the attachments to the staff report for this Item.

ACTIONS: The City Council directed the following: 1) Reach out to the FBI for assistance with pickpocketing in the City; 2) Provide the Santa Monica Rape Treatment Center Pamphlet to victims of sexual assault; 3) Increase foot patrols on the westside of the City; 4) Create a communication system with security guards at nightlife establishments and Block by Block; 5) Return with additional information on cameras at nightlife establishments; 6) Conduct quarterly meetings with nightlife establishments along with Sheriffs, City staff, and Block by Block; and 7) Return to the City Council after four months of monitoring the community safety contract staffing levels that go into effect January 1, 2023 to discuss any further adjustments. Motion by Mayor Meister, seconded by Councilmember Heilman, and approved.

The City Council took a separate vote as follows:

ACTIONS: 1) Proceed with reducing the number of Sheriff's Deputies by two (2) effective January 1, 2023, as previously directed; and 2) Direct Community Safety to return in April 2023 with a report and data for the City Council to review and determine Sheriff's Deputies staffing levels. Motion by Mayor Pro Tempore Shyne, seconded by Councilmember Byers and approved, noting the "no" votes of Councilmember Heilman and Mayor Meister.

City Clerk Crowder congratulated Councilmember Erickson and announced that the City Council Reorganization and Installation is scheduled for January 9, 2023.
