#### 7. PUBLIC HEARING

# A. AN APPEAL OF THE DENIAL OF MASSAGE PARLOR BUSINESS LICENSE #MSP-004681 BY DONGMEI CHEN DBA LYMPHATIC DREAMING HEALTH & BEAUTY LLC AT 7900 SANTA MONICA BLVD, SUITE 200, WEST HOLLYWOOD, CA 90046

SUBJECT: The West Hollywood Business License Commission shall conduct a public hearing to consider an appeal of the denial of Massage Parlor Business License Application #MSP-004681, for Dongmei Chen, owner of Lymphatic Dreaming Health & Beauty LLC, to be located at 7900 Santa Monica Boulevard, # 200, West Hollywood, CA 90046.

Chair Vulin opened the public hearing and asked for the Commission's disclosures.

Business License Commission Secretary, Falyn Kingi, informed the Commission that all notices were posted at the City's three legally required posting locations and mailed to occupants within a 500-foot radius of the business.

Code Enforcement Supervisor, Yessica Benitez, and Major Crimes Bureau Investigator, Michelle Hauser, provided background information as provided in the staff report dated December 6, 2022.

ADAM BROWN, APPLICANT'S ATTORNEY, briefly explained that it was not his client's intention to mislead or deceive the City of West Hollywood during the application process. He stated that the allegations made against DONMEI CHEN were a misunderstanding due to a language barrier and asked that his client be given a second chance.

SETH MANDERS, APPLICANT'S HUSBAND, provided a heartfelt explanation of their mishaps and acknowledged the importance of moving forward with better record keeping. He shared his health history and how massage therapy has helped improve his health. He requested that his wife be given an opportunity to operate a women's only massage parlor.

DONMEI CHEN, APPLICANT, spoke about her profession and the benefits of massage therapy. Lastly, she asked for a second chance and promised to comply with the current regulations.

Commissioner Hang asked for clarification on the APPLICANT's work experience, licenses and questioned if she had received help when completing the business license application. DONME CHEN, APPLICANT, and her husband responded.

Commissioner Eng requested that the APPLICANT, explain how she received massage certification but not a license through California Massage Therapy

Council. SETH MANDERS, APPLICANT'S HUSBAND, explained and responded.

Vice Chair Eisenberg asked Major Crimes Bureau Investigator, Michelle Hauser, if she was aware of the language barrier between her and the applicant during the investigation. Major Crimes Bureau Investigator, Michelle Hauser, stated that she was aware of the language barrier and confirmed that a certified translator was present.

The Commission continued to discuss in detail the possible various dialects of Mandarin, the application process, inconsistencies in the application, and the background investigation.

Commissioner Yusupov asked about the background investigation process and the renewal process for the massage parlor business license. Major Crimes Bureau Investigator, Michelle Hauser, and Director of Community Safety, Danny Rivas, responded.

The Commission asked clarification questions regarding the background investigation to both the applicant and Major Crimes Bureau Investigator, Michelle Hauser.

Commissioner Yusopov motioned to reverse the denial decision made by City staff and approve the issuance of the Massage Parlor Business License for Dongmei Chen. Vice Chair Eisenberg seconded the motion.

**ACTION:** Adopt the revised Resolution No. BLC22-0011 to reverse the denial of a Massage Parlor Business License and issue the Massage Parlor Business License for Dongmei Chen. **Motion by Commissioner Yusupov, seconded by Commissioner Eisenberg and unanimously approved.**
