## A. Transgender Day of Remembrance (TDOR) Event Debrief

### B. Response to Nighttime Safety Study Session

The board received a comprehensive response to questions raised during the Nighttime Safety Study Session held on August 22, 2022.

Staff provided the overview of the staff report that was included into the package.

**Member Brown** talked about specifics of assaults targeting Trans community and said that the consequences need to be more intense

**Member Nash** commented on the number of hours law enforcement personnel is supposed to spend on sensitivity training and suggested the increase up to 24 hours.

**Public Speaker: Mariah Darling**, West Hollywood resident spoke regarding safety issues experienced by Trans Community in the City of West Hollywood and talked about the law enforcement response to Trans Women in danger.

**ACTION**: Received and filed. No action taken.

## A. <u>Proposed LGBTQ+ Suicide Memorial Review Process Appointees</u>

The Board considered appointing up to three members to work with the Public Facilities Commission Ad Hoc Committee developed to gather more precise and detailed information on the Council proposed LGBTQ+ Suicide Memorial. **Helen Collins**, Facilities and Field Services Division Manager provided a background information about the memorial.

**ACTION**: Chair Nash,Vice Chair Ruiz, Boardmember Alexander volunteered to participate in the process of gathering more precise and detailed information on the proposed LGBTQ+ Suicide Memorial. Motion to approve by Chair Nash, seconded by member Brown. Motion passed.

The Board was supposed to consider a list of resource presenters to visit TAB monthly. Vice Chair Ruiz prepared the list of organizations.

Boardmember Brown said that the board needs to know the demographics of the Trans community in West Hollywood and specific needs of this community and then talk about resourses.

Board Member Luna spoke about social services contracts.

Chair Shane suggested that the board should first invite Social Services representatives to talk about the demographics and needs of the Trans and LGBTQI+ communities in the City of West Hollywood.

**ACTION**: Motion to invite Social Services representatives to speak about Trans Community by Boardmember Kacy, seconded by Boardmember Brown. Motion passed by a roll call vote.

### C. PrEP/PEP Access & City Hearing

The Board considered appointing a representative to work with City staff on an upcoming hearing to address issues with PrEP/PEP access to be held in January.

Hernan Molina, Governmental Affairs Liaison for the City of West Hollywood, provided the background information on the city involvement in various initiatives concerning prevention and treatment of HIV thought the years and about making PrEP and PEP readily available and accessible to various groups of population.

Chair Nash, Vice Chair Ruiz and Member Brown volunteered to represent the board to work with City staff on an upcoming hearing to address issues with PrEP/PEP access to be held in January.

Member Robinson made a motion to approve, seconded by member Kacy. Motion passed by the roll call vote.

**ACTION**: Review the attached staff report and appoint one person from the Transgender Advisory Board to assist staff with the upcoming hearing to discuss issues with PrEP/PEP access.
