John Keho, Director, Planning and Development Services Department stated at the last City Council meeting on Monday, April 3, 2023, the City Council approved an agreement with Francis Krahe & Associates (FKA) to provide a lighting study, analyzing the proposed billboards on Sunset Boulevard. At the next City Council meeting on Monday, April 17, 2023, the appeal of 1317 N. Crescent Heights Boulevard will be heard.

- 11. NEW BUSINESS.

A. Overview Of State Housing Laws.

Isaac Rosen, Acting City Attorney provided an overview of recently enacted state housing laws, how it impacts general law municipalities, and the Planning Commission's purview under state and local.

He spoke and detailed the overarching posture and intent from the state legislature, existing housing laws, history, and changes of the Housing Accountability Act (HAA)/ SB330, ministerial regulations, and current 2023 housing laws impacting Planning Commission discretions.

He presented examples of various court interpretations, recent ministerial approvals, density bonus law, expounded on AB 2334 (Base Density Study and Increased Incentives), AB 1551 (Commercial Density Bonus Returns), AB 2234 (Post Entitlement Permit Shot Clock), AB 2011 and SB 6 (Residential in Commercial Zones), and AB 2097 (Further limits on local parking).

The commission questioned and requested further clarification regarding housing advocates, AB 2334 regarding unlimited maximum density, and dwelling units per acre calculations, AB 1551 regarding residential in commercial zoning, and public noticing requirements, AB 2234 regarding

time limits on city staff review for applications requesting post entitlement permits, and AB 2011 regarding design review hearings.

The commission asked about exemptions for rent regulated cities, mitigatable adverse impacts, objective standards regarding the Housing Accountability Act and SB 330, AB 2097 regarding accessible ADA parking. Shot Clock deadline dates, Housing Accountability Act and historic preservation, compliance with the on-line database dashboard, establishment of an on-line developers' library, definitions of how projects are deemed complete, and questioned the objective standard requirements regarding projects that are EV or ADA compliant.

Chair Jones opened public comments for Item 11.A.

JAMES WENDELL, WEST HOLLYWOOD spoke regarding the current housing crisis, affordable housing, and rent control units.
