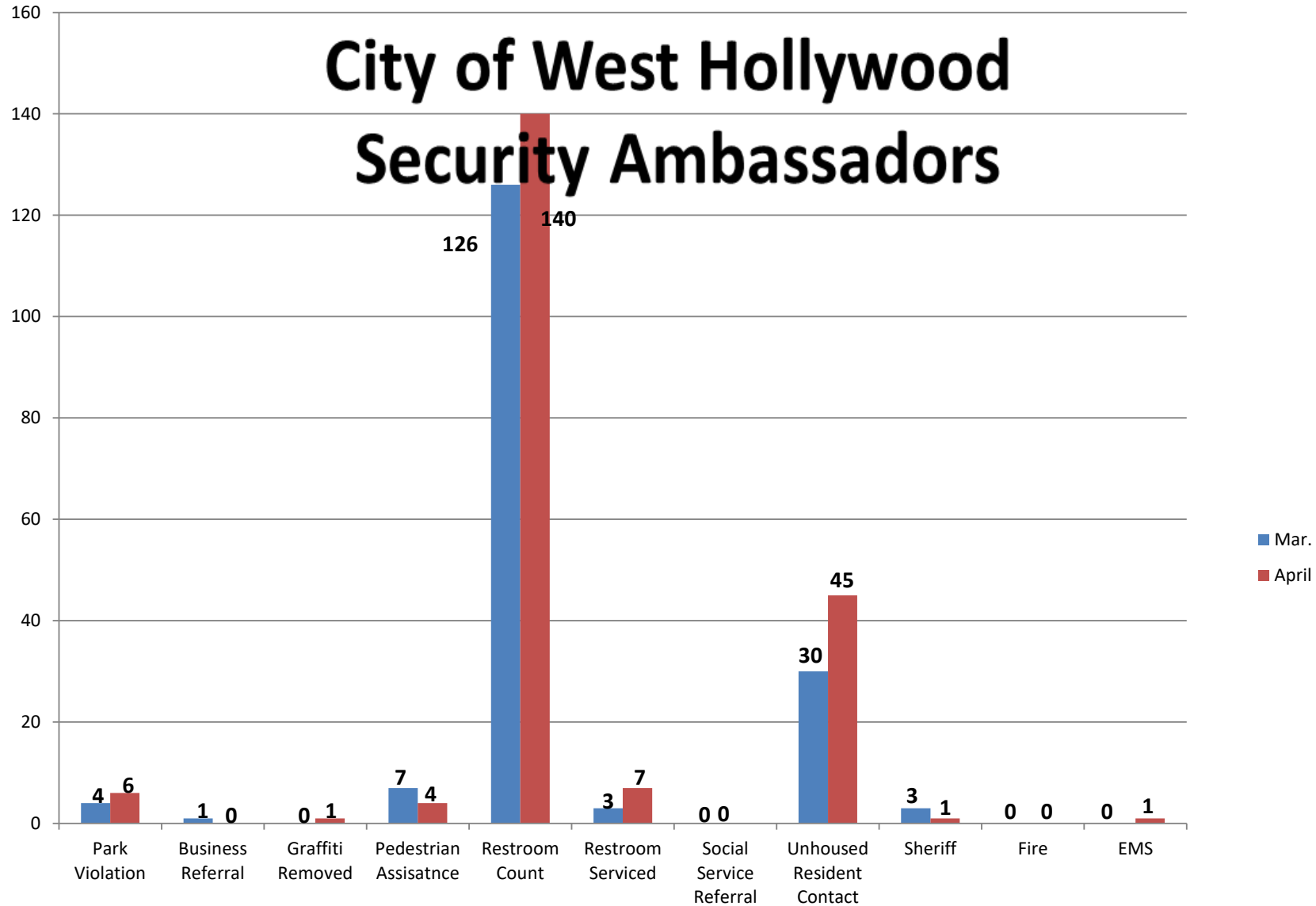
**Sunset Blvd. - March 2023 vs April 2023**

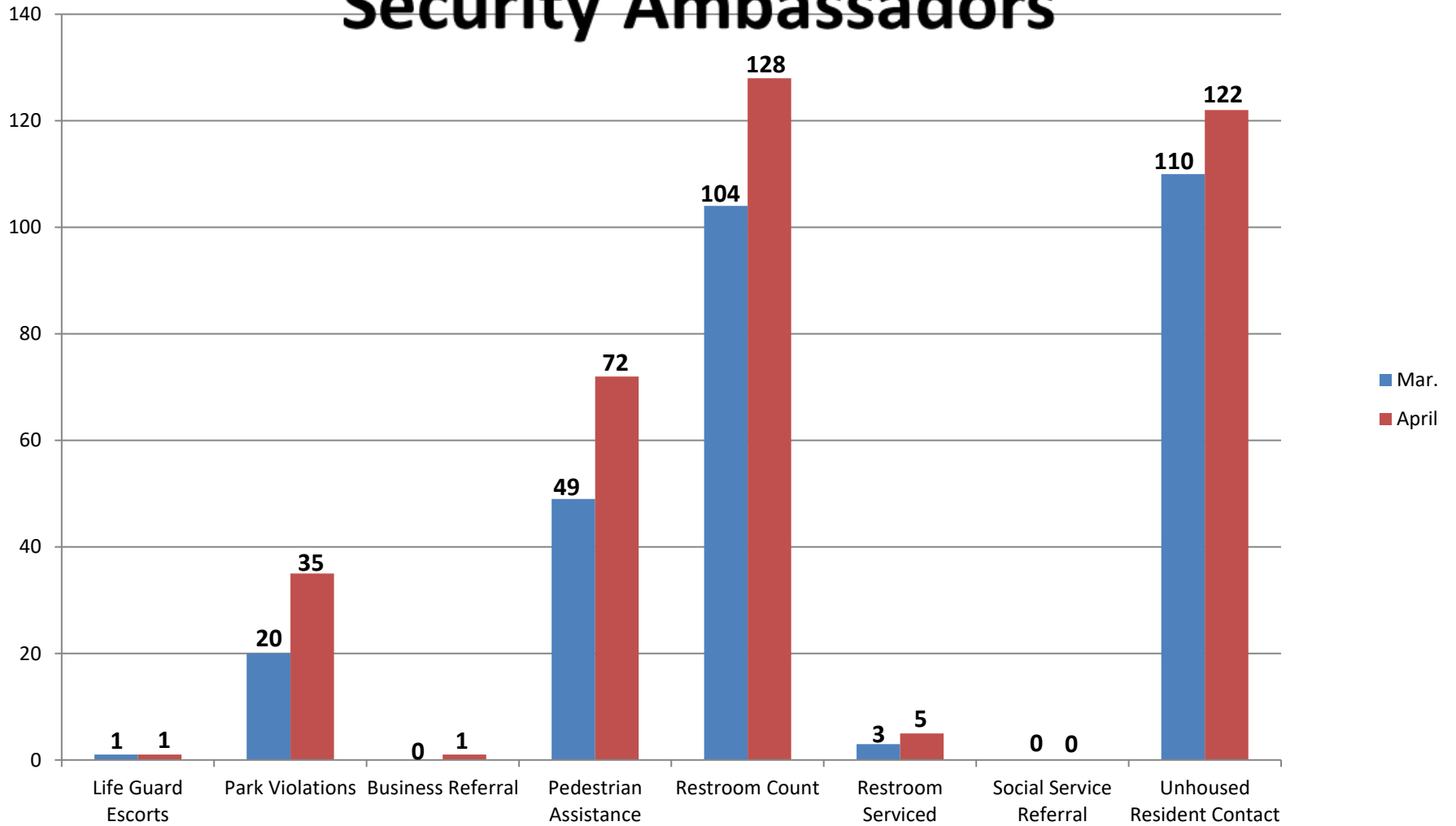

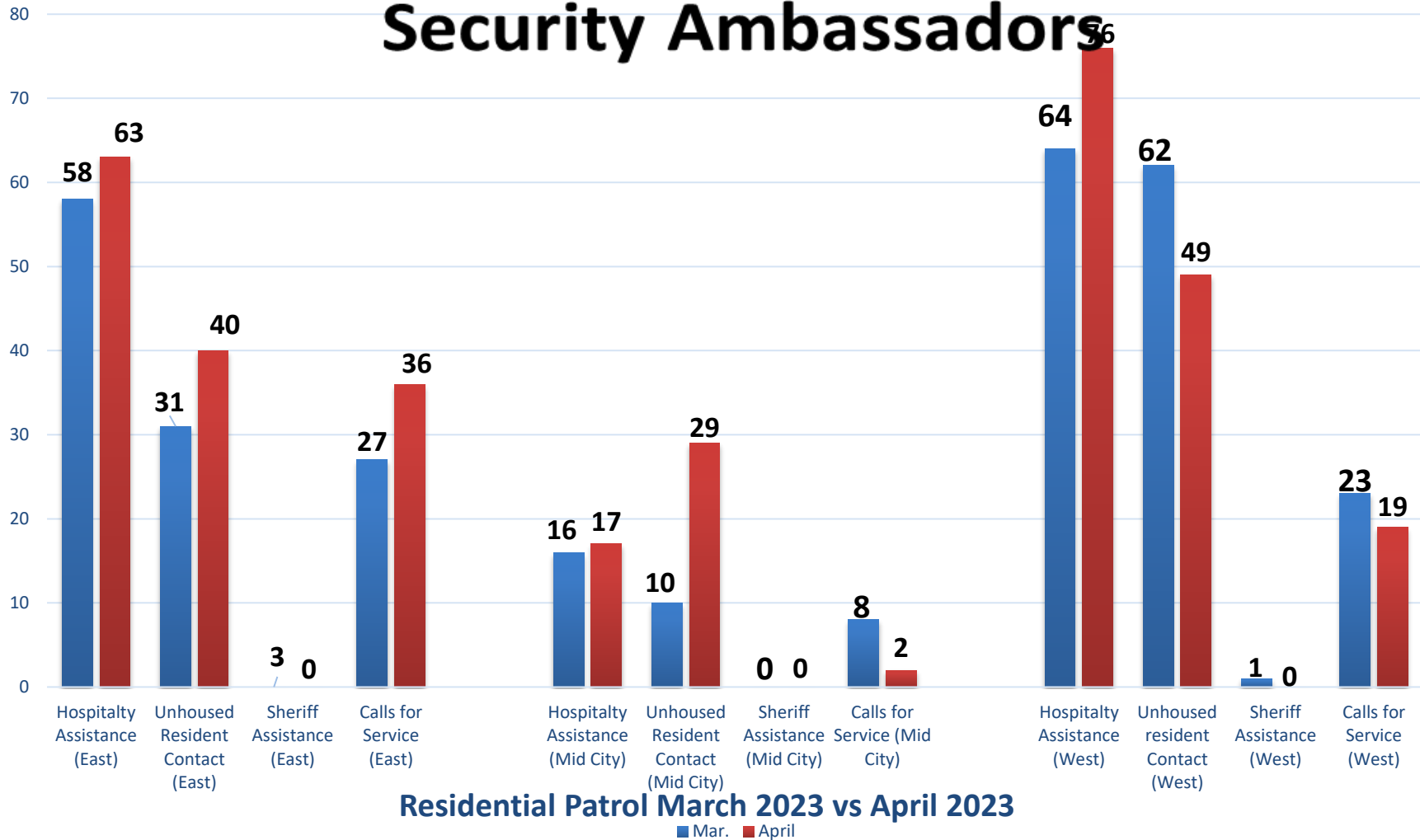

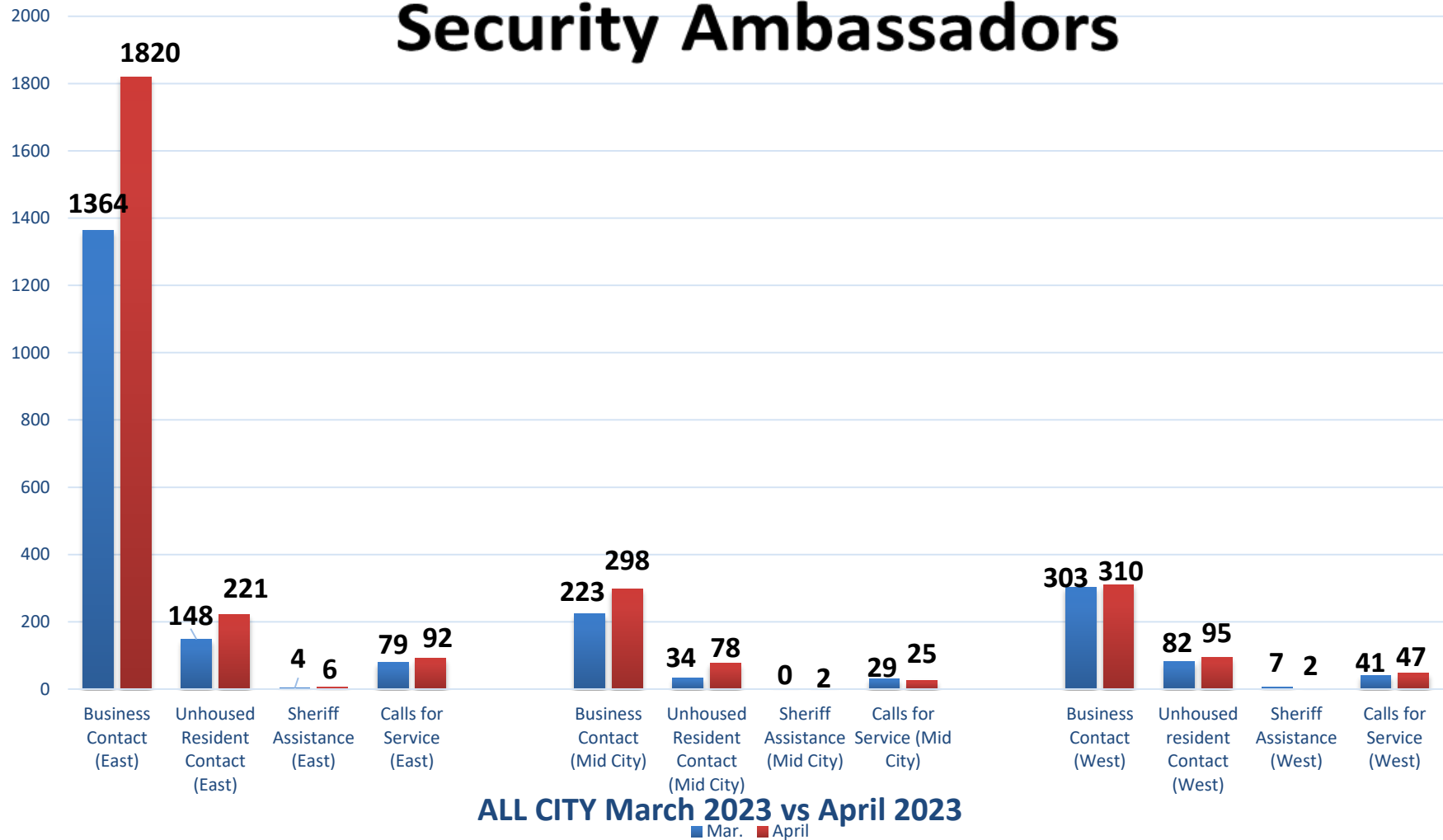


**West Hollywood Park / ARC - March 2023 vs April 2023**

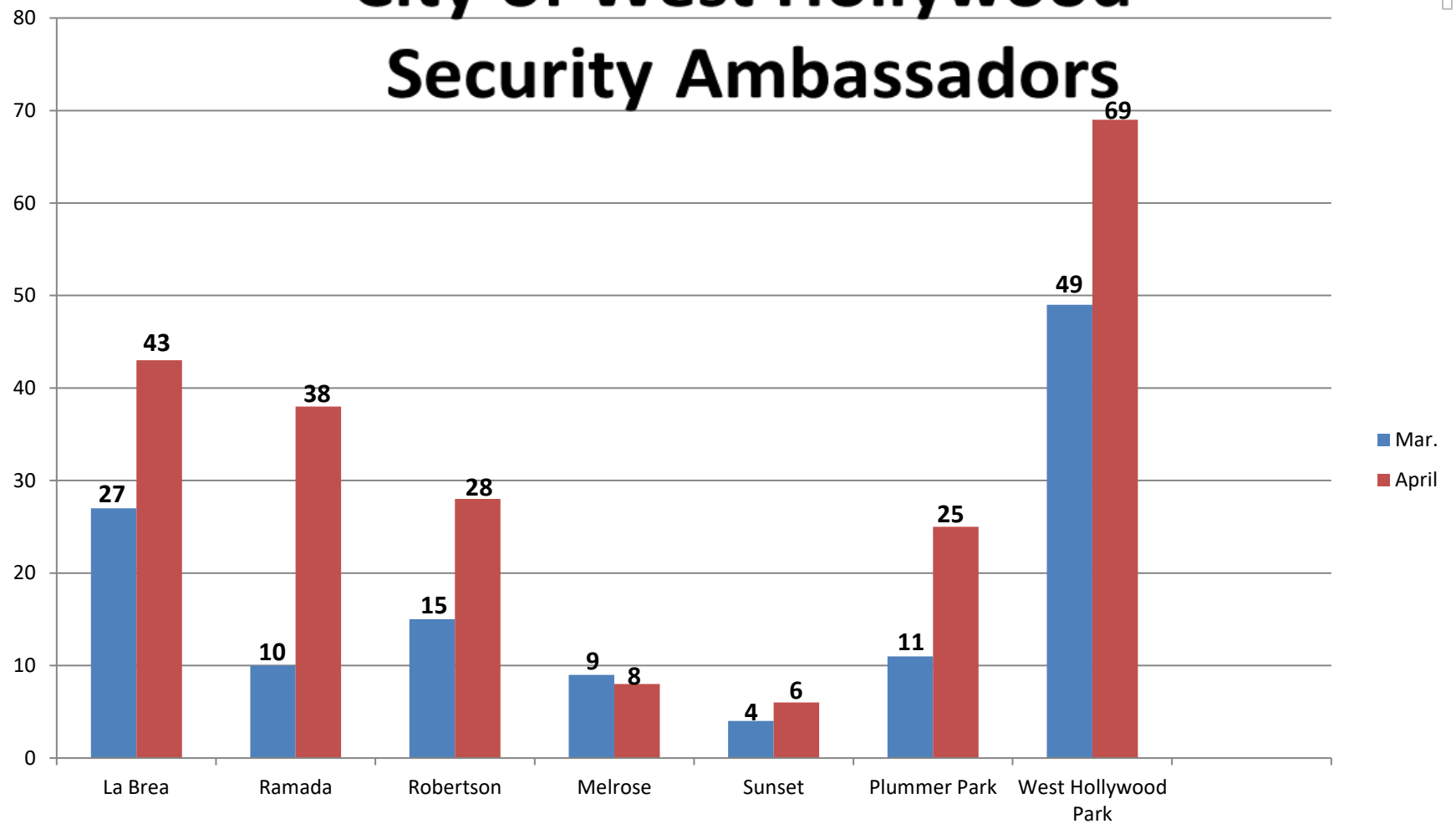

### Response Times

#### Call 1

- Incident Type: Unhoused Resident
  - Location: Plummer Park
  - Date/Time of Incident: 04/03/2023 / 02:05am
  - Sheriff Response: Yes
  - Called: 02:05am
  - Arrived: 02:15am
- \*Assisted with two noncompliant sleepers in park after hours.

#### Call 2

- Incident Type: Auto Break in
  - Location: Santa Monica Blvd.
  - Date/Time of Incident: 04/03/2023 / 11:22am
  - Sheriff Response: Yes
  - Called: 11:24am
  - Arrived: 11:45am
- \*individual walking down SM Blvd breaking car windows.

#### Call 3

- Incident Type: Injury to Person
  - Location: Ibiza Nail & Spa Services
  - Date/Time of Incident: 04/07/2023 / 07:30pm
  - Sheriff Response: Yes
  - Called: 07:35pm
  - Arrived: 07:41pm
- \*Individual struck by vehicle, Fire was also called. Minor injury.

#### Call 4

- Incident Type: CFS
  - Location: Weho Wash
  - Date/Time of Incident: 04/14/2023 / 06:40am
  - Sheriff Response: Yes
  - Called: 06:45am
  - Arrived: 08:44am
- \* RP stated female individual refusing to relocate from property. Female individual is a paying customer. Sheriffs were called 6:45am. Sheriffs did not arrive. Female individual left at 7:55am. Female individual was driving away attempting to hit RP's vehicle with RP's kids inside the car. Female individual then got out of the car with what seemed to be a pole or a baton and look like she was attempting to attack the RP. We placed another call to the Sheriffs at 7:57am updating them on the situation. Dispatch advised that the Sheriff had arrived and didn't see anything and asked if we were able to see the officer. I informed them

that unfortunately we didn't see any Sheriffs passing through at the time even though we were by the entrance. We were able to deescalate the situation were both parties ended up leaving before Sheriff arrived at 8:44am.

  - Sheriff Response: Yes

  - Arrived: 6:55pm
- \* Upon making contact with (1) unhoused, was advised of loitering and advised of possible relocation. Unhoused was noncompliant. Sheriff were called. Sheriff assisted in removal of unhoused for loitering. Unhoused departed 8240 SMB, & last seen heading East Bound on SMB.

#### Call 6

- Incident Type: Assault
  - Location: West Hollywood Park

- \*While patrolling the perimeter of WeHo Park I observed and heard a women screaming at the kids playground area. I proceeded to run over to the screaming lady where I made contact, she then yelled that "A man is touching my kids" , I immediately made contact with said person to prevent any further incidents, called it in on radio, requested Sheriff on scene. Sheriff arrived on seen almost immediately, they then arrested the suspect, and the victim pressed charges. We then escorted victim back to their vehicle.

#### Call 7

- Incident Type: Unhoused Resident
  - Location: 7-Eleven Hayworth
  - Date/Time of Incident: 04/21/2023 / 12am
  - Sheriff Response: Yes
  - Called: 12:05am
  - Arrived: 12:13am
- \* Made contact with an aggressive, unhoused who was asked to relocate. He was being noncompliant, and was becoming verbally aggressive. My partner and I, stood by and kept our distance, since it seemed as if he could get physical at any point. We advise him that he needed to relocate due to the business placing a call in regards to him getting aggressive with both customers and residents. We kept making contact and he ended up relocating westbound on Santa Monica and Hayworth. We advised Sam 3 to place a call to LASD, which was placed at 12:05am. Sheriffs arrived to the scene at 12:13am. Made contact with the business and advised to place a call to Sheriffs if individual came back.

### Call 8

- Incident Type: Assault
  - Location: Santa Monica Blvd and San Vicente
  - Date/Time of Incident: 04/21/2023 / 7:10pm
  - Sheriff Response: Yes
  - Called: 7:14pm
  - Arrived: 7:29pm
- \* Upon our patrol B-7 & I observed on SMB and San Vicente (SV) a (1) Male Pedestrian with a walking stick was crossing the crosswalk. As he was crossing and walking with his stick he then hit the white Hyundai. He proceeded to hit the hood of the car a couple more times after the motorist had honked at him, the driver then proceeded to get out of the car and then started an argument with the (1) Male Pedestrian. The (1) Male Pedestrian & the motorist proceeded to assault each other. We then advised S-4 to place a call to LASD regarding the incident. Upon making contact (1) Male Pedestrian jumped on-top of the vehicle (on-top of the drivers hood), and the driver drove-up a little while he was on the vehicle. Contact was made and verbal commands were used to attempt to deescalate the situation between the two. LASD & LAFD arrived on scene 7 minutes after the incident occurred, LASD made contact with the pedestrian and then the driver, the (1) Male Pedestrian got aggravated & began to assault LASD, they then arrested the individual, and took over the scene and allowed the motorist the white Hyundai to depart. Nothing further to report.
