A. **AN APPLICATION BY HEART WEHO, LOCATED AT 8911 SANTA MONICA BOULEVARD, FOR AN EXTENDED HOUR BUSINESS LICENSE TO OPERATE UNTIL 4:00 A.M. ON SATURDAYS AND SUNDAYS**

SUBJECT: The West Hollywood Business License Commission shall conduct a public hearing to reconsider the application for an Extended Hour Business License to operate until 4:00 a.m. on Saturdays and Sundays, for an existing nightclub known as Heart WeHo, located at 8911 Santa Monica Boulevard.

RECOMMENDATION: Adopt Resolution No. BLC23-0002, "A RESOLUTION OF THE BUSINESS LICENSE COMMISSION OF THE CITY OF WEST HOLLYWOOD APPROVING EXTENDED HOUR BUSINESS LICENSE NO.

EXT-004735 TO ALLOW HOURS OF OPERATION OF A NIGHTCLUB TO BE EXTENDED UNTIL 4:00 A.M. ON SATURDAYS AND SUNDAYS FOR THE BUSINESS KNOWN AS HEART WEHO LOCATED AT 8911 SANTA MONICA BOULEVARD.”

Any final determination by the Business License Commission may be appealed, and such appeal must be filed within fifteen (15) calendar days after the Planning Commission action. This appeal shall be made in written form to the City Clerk's Office, accompanied by an appeal fee.

The City Clerk, upon filing of said appeal, will set petition for a public hearing before the City of West Hollywood's City Council at the earliest date.

If you challenge any City of West Hollywood decision in court, you may be limited to raising only those issues you or someone else raised at the public hearing described on this agenda, or in a written correspondence delivered to the Business License Commission at, or prior to, the public hearing.
