# CITY OF WEST HOLLYWOOD ARTS AND CULTURAL AFFAIRS COMMISSION MINUTES November 4, 2004

## I. APPROVAL OF MINUTES – September 23, 2004

Commissioner Haibach moved that the Arts and Cultural Affairs Commission approve the minutes of September 23, 2004. Commissioner Sherman seconded the motion and the motion carried unanimously.

### II. UNFINISHED BUSINESS

## A. Study Session with City Council

The Commission felt that the study session with the City Council, held September 27, 2004, helped establish a positive base of communication between Council and the ACAC. As a result of the study session and pursuant to Mayor Duran's suggestion, staff and members of the Commission were directed to develop a set of guidelines that would assist the Commission in its development and review of various events within its purview.

#### B. Art on the Outside

Staff gave an update of the Robert Indiana exhibition indicating that initial commitment had been received via the Paul Kasmin gallery to install an exhibition of the "Love" sculptures and other work as part of the Art on the Outside program. Commissioners indicated that they would inform their respective Council members about the exhibition, and be present at the November 15 Council meeting.

The Chair requested that staff e-mail commissioners the November 15, staff report to Council.

#### C. 2004-2005 Arts Grants

Members of the Arts Grant Committee reported on the meeting held Thursday, October 28 and presented funding recommendations regarding the 23 grant applications received. The Committee noted that two organizations were not eligible and two organizations' proposals were not recommended for funding.

Commissioner Sherman moved that the Arts and Cultural Affairs Commission approve the recommendations as presented by the Arts Grant Committee and direct staff to take the recommendations to City Council for final approval. Commissioner Denenberg seconded the motion and the motion unanimously carried.

The Commission expressed considerable interest in marketing the grant program and suggested that the Commission 1) host a reception with City Council, 2) invite grantees to the City's 20<sup>th</sup> Anniversary Street Fair Celebration on December 5, 3) develop a postcard listing all grantees and their websites as applicable, include grantees in the City's newsletter and 4) develop an arts and cultural events calendar.

Staff will follow-up on all suggestions and report back to the Commission.

#### D. Urban Art Subcommittee

Staff reported that the Sunset Marquis had decided not to work with the original artist Christian Muller. The project will need to start again and present a new group of artists for the Urban Art Subcommittee's review.

## E. Christopher Street West (CSW)

Bonnie Smith, Festival and Events Specialist in the Recreation Division reported that City Council will consider approving the development of a Christopher Street West Task Force at its December meeting. The task force would consist of representatives from CSW, the Arts and Cultural Affairs Commission, Chamber of Commerce, Convention and Visitors Bureau and Santa Monica Boulevard businesses. The task force would address policy, developmental and economic issues relative to LA Pride.

Commissioner Haibach expressed interest in serving on the task force and suggested that the task force report back to the Commission.

#### III. NEW BUSINESS

# A. Temporary Exhibition Proposal "International Male" Building on Holloway

Staff introduced local businessman John Sedlar who presented a concept for a temporary exhibition - celebrating Latin culinary arts and history through photography - at the old International Male building, in February or March of 2005. The exhibition "Comidas Prehispanicas" or Elements of the Pre-Columbian Kitchen would provide insight into the culinary traditions of Pre-Columbian Mesoamerica. Many of the photographs planned for the West Hollywood exhibition are now on display at the Tamale Museum in San Juan Capistrano.

It was the consensus of the Commission to support the project.

## IV. ITEMS FROM STAFF

Staff reviewed dates for upcoming Commission meetings due the holiday schedule.
