

IMPORTANT INFORMATION ABOUT THE CITY OF WEST HOLLYWOOD'S SOLID WASTE SERVICE CHARGES FOR FISCAL YEAR 2023-2024 (THIS IS NOT A BILL)

Dear Property Owner/Tenants,

Athens Services has been providing solid waste collection services to customers in West Hollywood since 2004. On July 1, 2023, under the terms of the contract, Athens Services is allowed to adjust the rates for solid waste services (trash, recycling, and organic waste collection) by an inflationary (Consumer Price Index or CPI) adjustment and supplemental adjustment. The City Administrative Fee applied to all residential properties will also be adjusted, as follows:

CPI Adjustment: The rates shall be adjusted by the annual percentage change March to March in the CPI for Trash and Garbage Collection (CUUR0000SEHG02), U.S. City Average (not seasonally adjusted), as determined by the U.S. Department of Labor Statistics ("Trash CPI"), plus 1%. The change in the Trash CPI from March 2022 to March 2023 was 6.67%, and plus 1%, results in a CPI adjustment of 7.67%.

Supplemental Adjustment: Beginning July 1, 2023, a supplemental adjustment of 10.4% will be applied to provide organic waste collection services and programs required by regulations promulgated by CalRecycle to implement SB 1383 (Chapter 395, Statutes of 2016). The supplemental adjustment plus the CPI adjustment results in a total adjustment of solid waste rates by 18.07%.


Administrative Fee: Beginning July 1, 2023, the City's Administrative Fee for residential properties shall be adjusted based upon the annual percentage change January to January in the CPI, All Urban Consumers for the Los Angeles-Long Beach-Anaheim, CA Metropolitan Area (not seasonally adjusted), up to 10%. The 2023-2024 Administrative Fee CPI was 5.7707%, which results in \$1.355 per unit per month.

Effective July 1, 2023, Athens Services will increase the rates for solid waste services in West Hollywood by 18.07%. Single-family residential customers (parcels with 4 units or less) have their solid waste service charges, including the Administrative Fee, placed on their property tax bill; while multi-family residential properties (with 5 or more units) pay the annual Administrative Fee and are billed monthly directly by Athens Services for the services used.


