

CITY OF WEST HOLLYWOOD INVITATION TO BID <u>ADDENDUM #1</u> FOR

SAN VICENTE BLVD. AND ROSEWOOD AVE. STREET IMPROVEMENTS CIP 2305

All changes, additions and/or clarifications detailed in this Addendum, and previously issued Addenda, are hereby incorporated into the Bidding Documents for the above-stated project, and modify the original document. Bidder shall acknowledge receipt of Addendum prior to bid submission.

This Addendum is issued prior to the bid opening date to inform bidders of revisions to the Bidding Documents, which may or may not contain changes that are materially substantial to the Bid, and all is hereby made a part of the Contract Documents. In case of a conflict between Bidding Documents and this Addendum, this Addendum shall govern. All requirements contained in the Contract Documents shall apply to this Addendum, and the general character of the work called for in this Addendum shall be the same as originally set forth in the applicable portions of the Contract Documents for similar work, unless otherwise specified under this Addendum, and all incidental work necessitated by this Addendum as required to complete the work shall be included in the bid, even though not specifically mentioned in this Addendum. The balance of the contract documents shall remain unchanged.

This Addendum shall take precedence over all other conditions, specifications and requirements as stated in the Notice Inviting Bids and Bidding Documents. Except as noted in this Addendum, and previously issued Addenda, all other provisions of the Notice Inviting Bids and Bidding Documents shall remain.

AGENCY INFORMATION

Item 1. Added New Line Item

The City added one (1) new line item + quantity to the list of bid items. Description: Design, Furnish, and Install Traffic Control. This information will also be shared in all public locations where bid notices are posted.

BIDDER QUESTIONS

Item 2. Sheet TS-01: The conductor schedule shows 2" & 3" conduits and conductors. Are they new? If so, What bid item do they go to? Also there are pull boxes on the plans. Are they new? If so, What bid item do they go to?
On sheet TS-01, the conduit and conductors are new and should be included in bid item #15. See Construction Notes on Sheet C1.2 for pull box information, legend and note 16.
