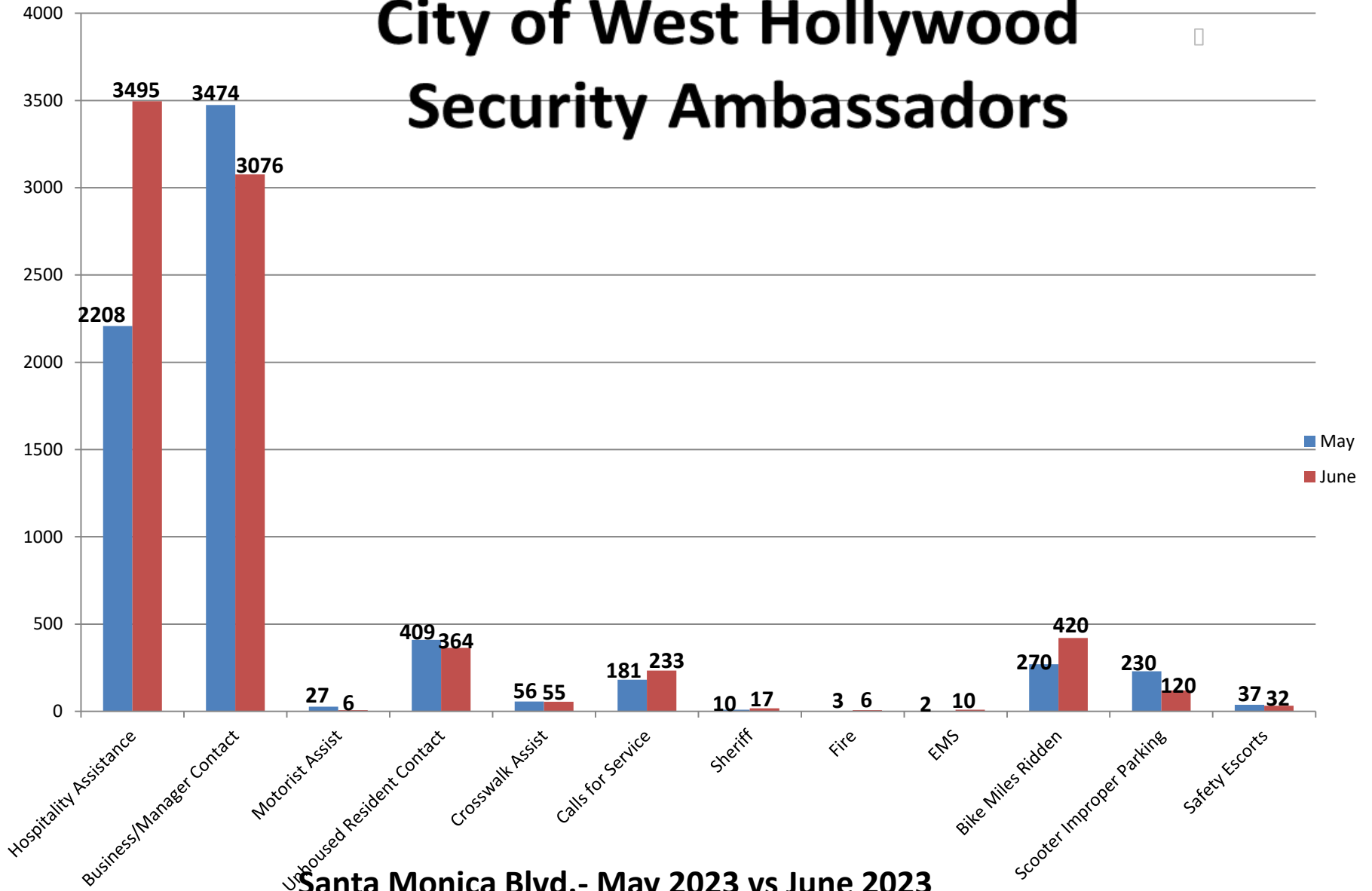
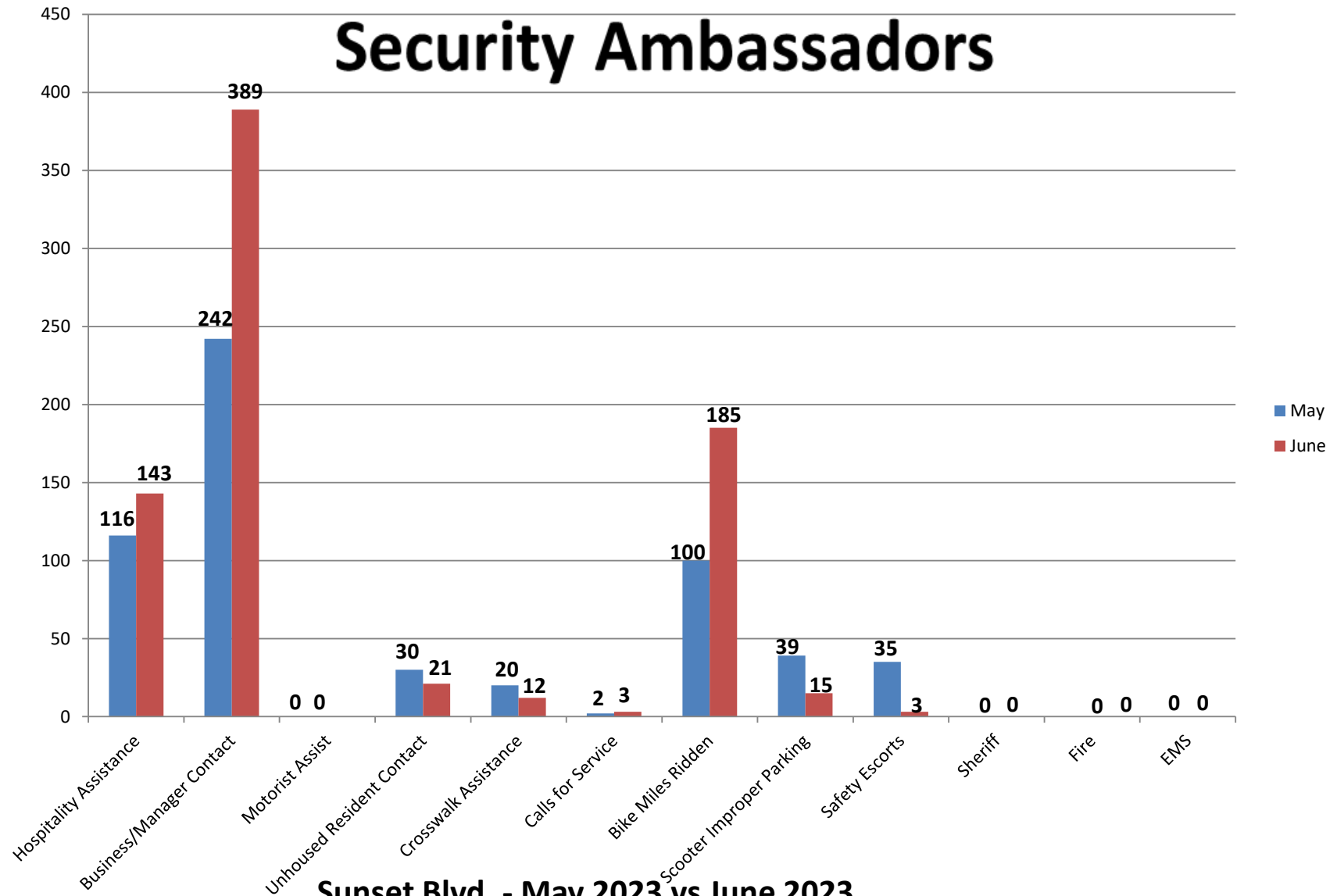

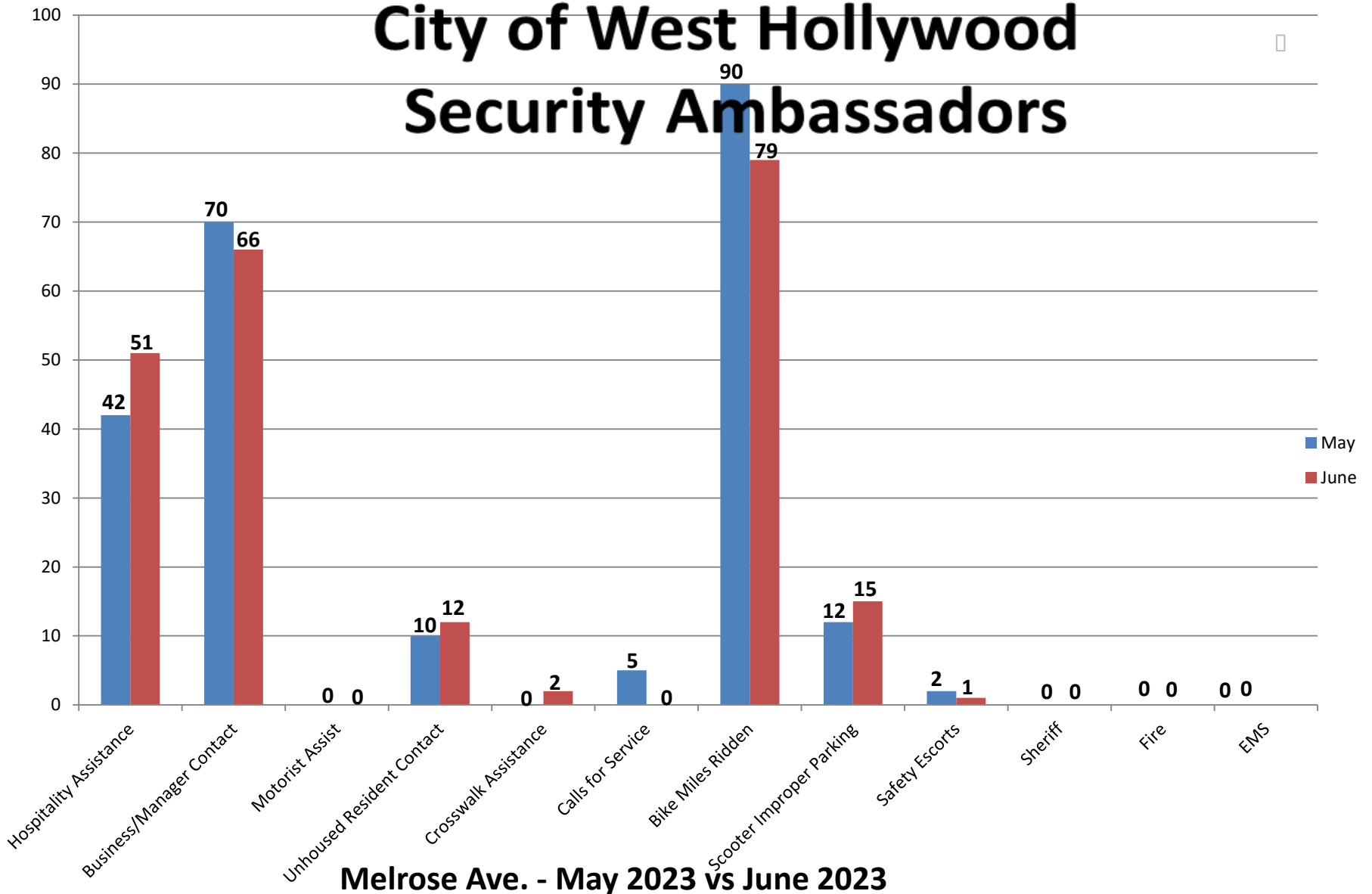
Santa Monica Blvd.- May 2023 vs June 2023

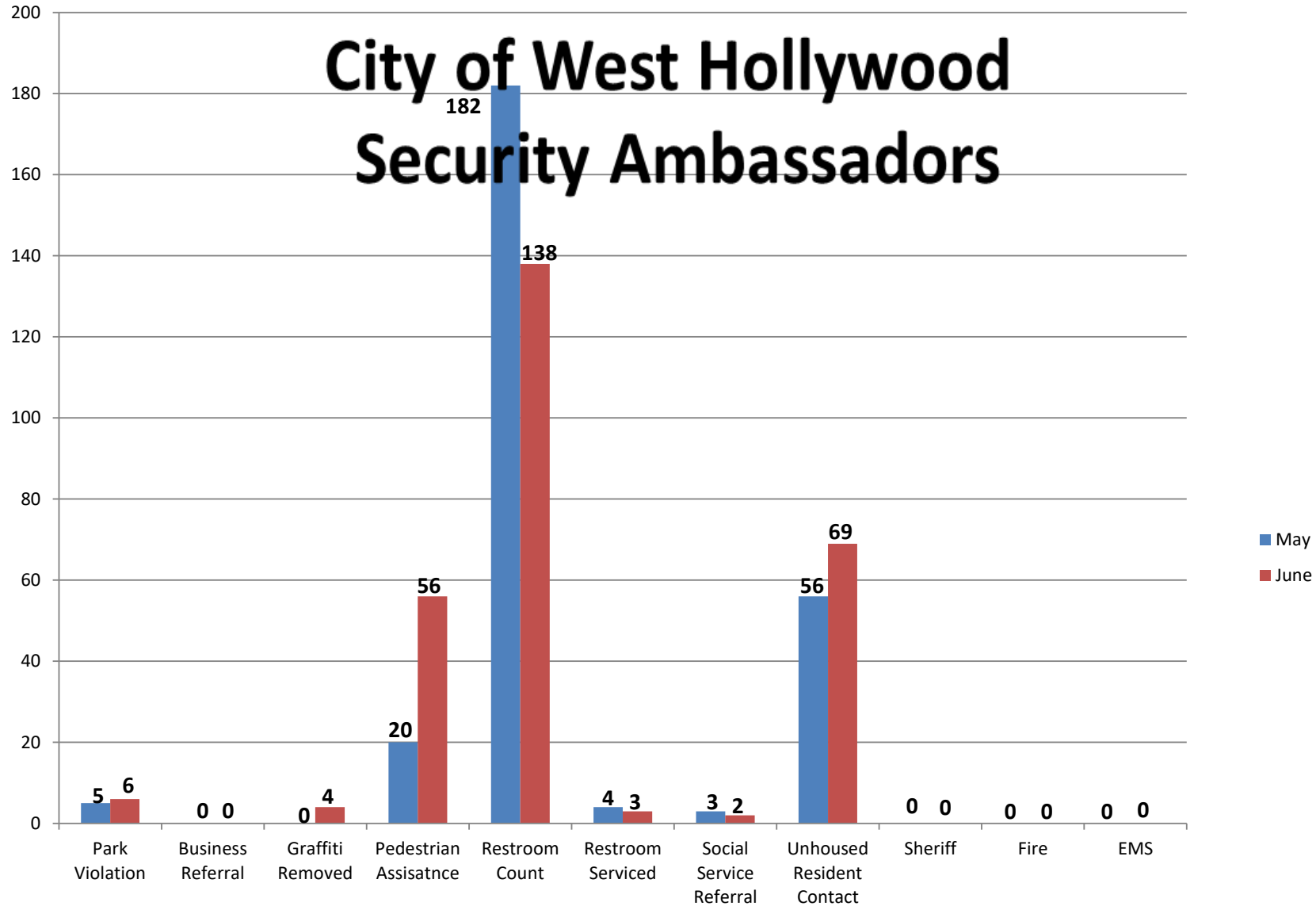


Sunset Blvd. - May 2023 vs June 2023

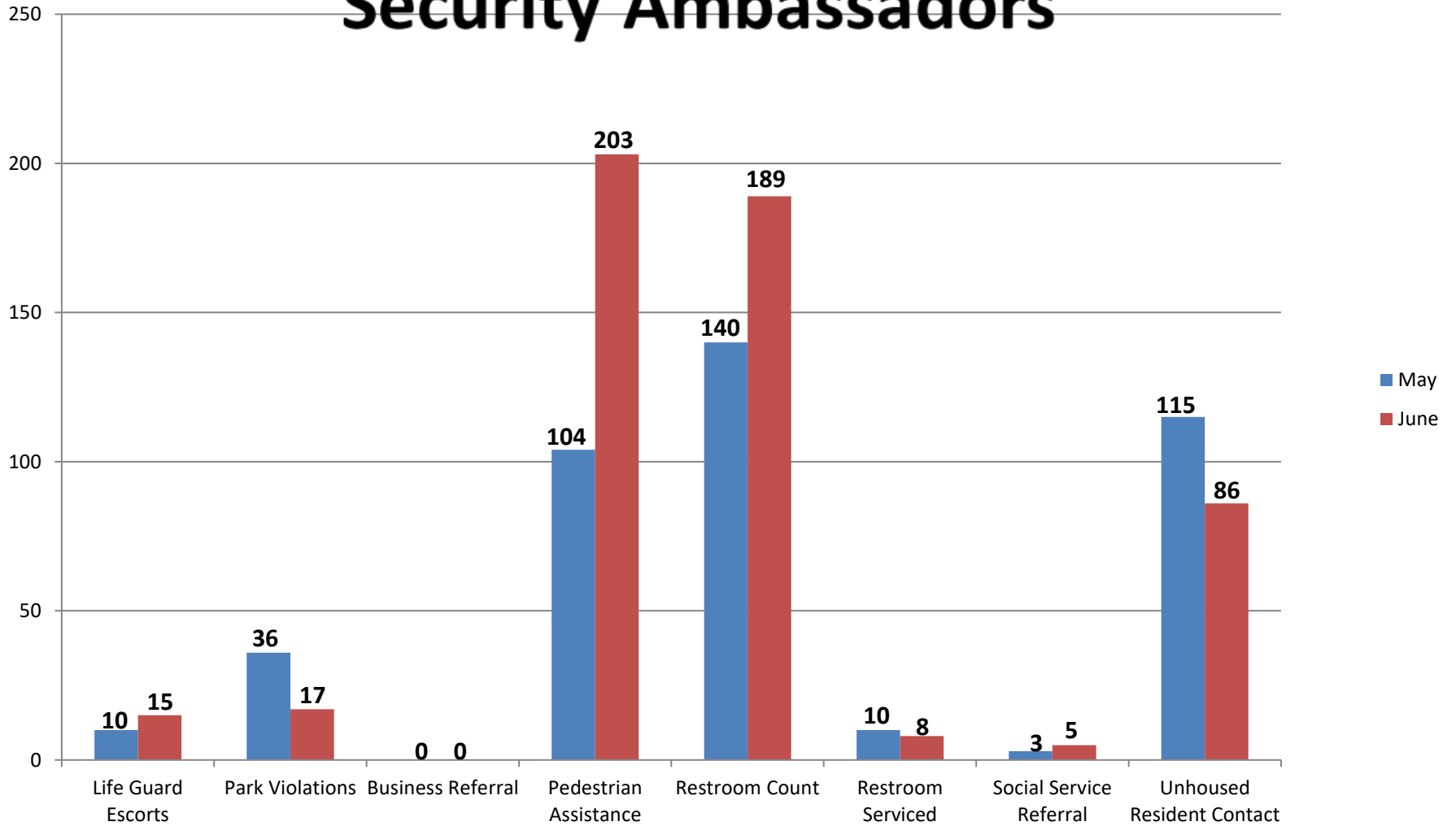

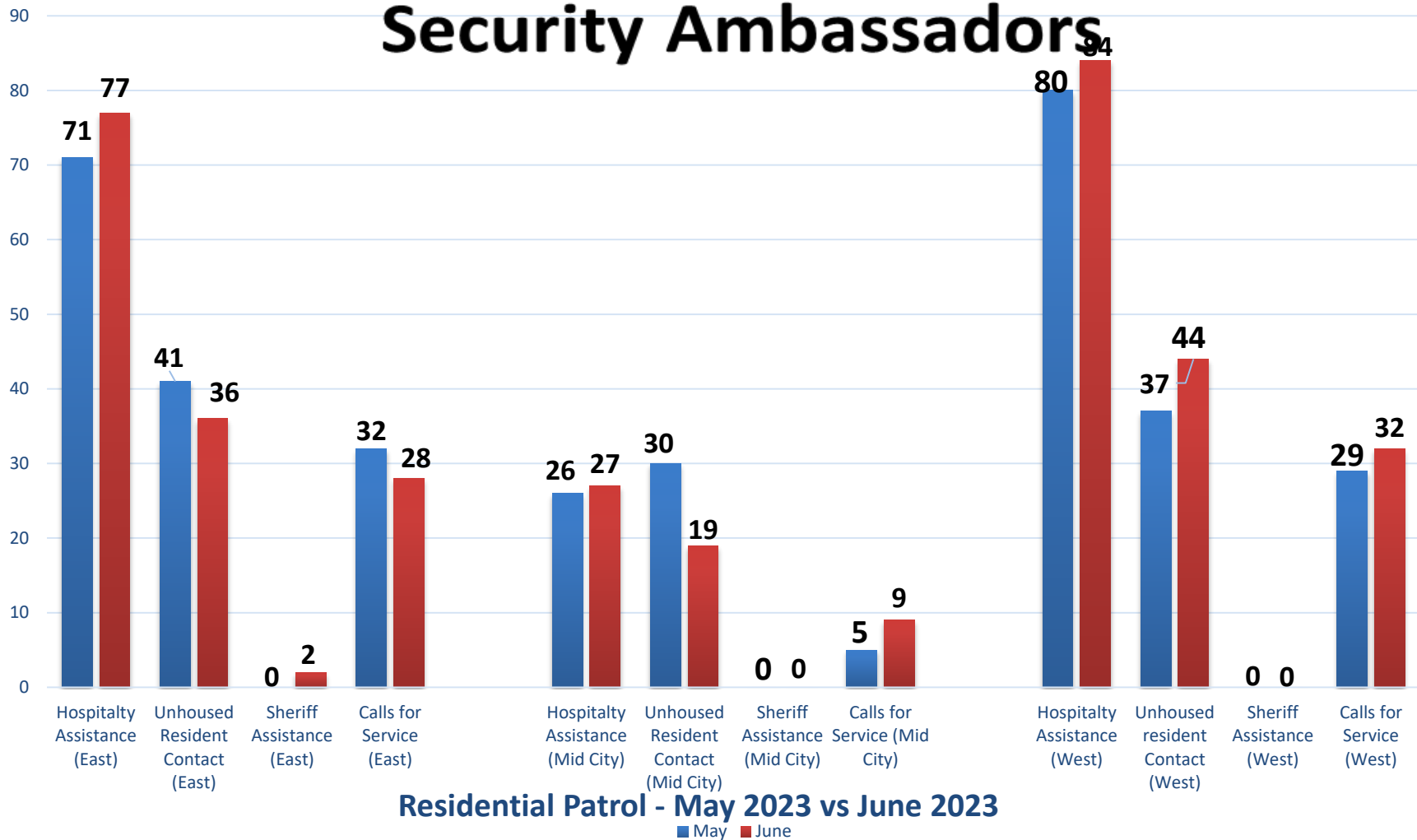
Plummer Park - May 2023 vs June 2023

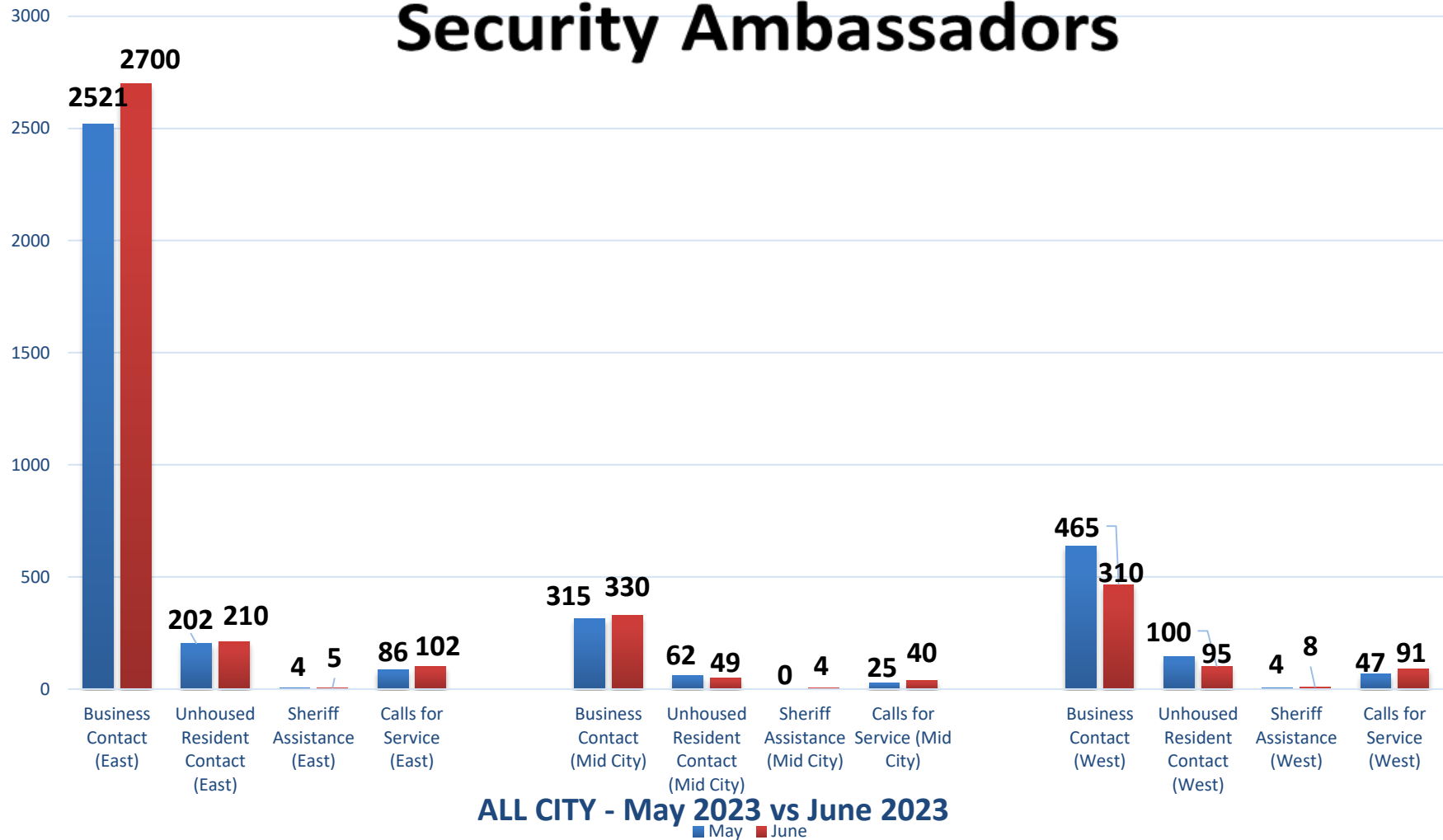


West Hollywood Park / ARC - May 2023 vs June 2023

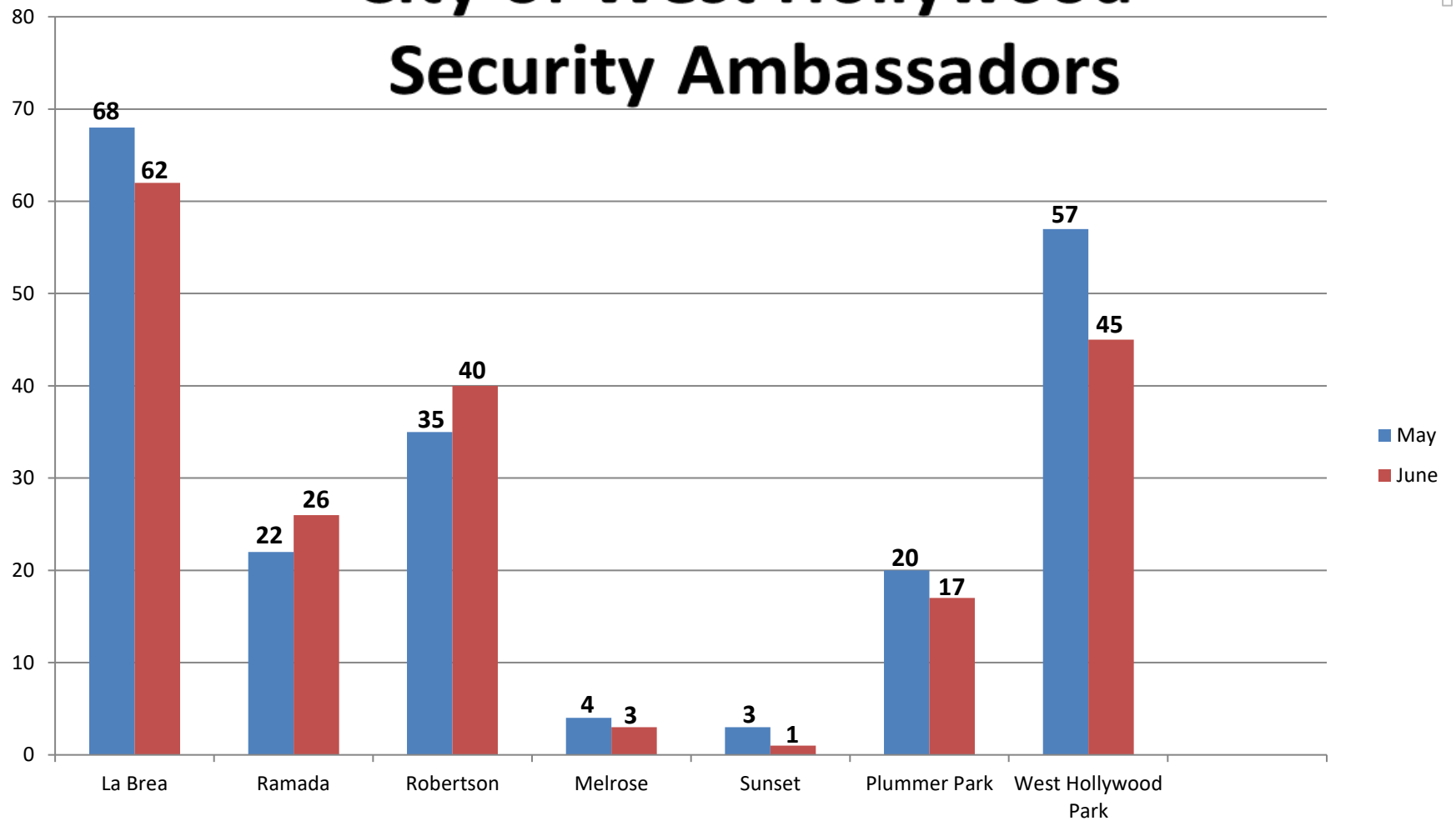
