A. DISABILITIES AWARENESS MONTH PLANNING

The Disabilities Advisory Board discussed Disabilities Awareness Month. The Board is requesting the City Council to participate in an activity in October. This activity would require the participants to navigate daily activities with mobility, vision, hearing, and other disabilities. City staff informed the Board that they will speak to the Community and Legislative Affairs Division about the request. The Board chose a theme for this year's events, which will be:

Past, Present, Future: Connecting and Empowering All. The Board discussed entertainment and catering for the Disability Service Awards. They decided not to form a subcommittee for planning purposes and chose to have a standing item at each meeting for planning.
