

RESOLUTION NO. 23-090

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD CERTIFYING THE ENGINEERING AND TRAFFIC SURVEYS CONTAINED IN THE 2023 TRAFFIC SPEED ZONE SURVEY REPORT IN CONFORMANCE WITH THE CALIFORNIA VEHICLE CODE.

THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The City Council finds and declares as follows:

- A. An Engineering and Traffic Survey as defined by California Vehicle Code Section 627 is a survey of highway and traffic conditions conducted in accordance with methods defined in the California Manual of Uniform Traffic Control Devices.
- B. California Vehicle Code Section 40802 requires an Engineering and Traffic Survey be prepared for each street segment every five, seven, or 14 years for the use of radar or other approved electronic devices to enforce speed limits.
- C. The Engineering and Traffic Surveys contained in the 2023 Traffic Speed Zone Survey report have been conducted on various streets within the City of West Hollywood by the City's Consulting Traffic Engineer in accordance with the requirements of the California Vehicle Code.
- D. The City Engineer reviewed the completed 2023 Traffic Speed Zone Survey report and agrees with the recommendations of the City's Consulting Traffic Engineer.
- E. The 2023 Traffic Speed Zone Survey recommendations from the City's Consulting Traffic Engineer were presented to the City's Transportation & Mobility Commission and Public Safety Commission.
- F. The City Council certifies that the Engineering and Traffic Surveys contained in the 2023 Traffic Speed Zone Survey conform with the California Vehicle Code

SECTION 2. The Speed Limit is established on the following street segments in accordance with Section 10.04.010 of the West Hollywood Municipal Code:

SECTION 3. All previous resolutions establishing speed limits on street segments within the City of West Hollywood are hereby rescinded and superseded.

SECTION 4. The City Clerk is hereby ordered to file certified copies of this Resolution and the Engineering and Traffic Surveys contained in the 2023 Traffic Speed Zone Survey report with the Los Angeles County Sheriff's Department and the Los Angeles County Superior Court.

SECTION 5. The speed limits established in Section 2 of this Resolution shall become effective upon posting of the speed limit signs.
