I. CALL TO ORDER

The Arts and Cultural Affairs Commission meeting was called to order by Commission Vice Chair Deaton at 5:00 p.m.

D. Approval of the Agenda:

F. Public Comment RON CORTEZ, West Hollywood, introduced himself as the liaison for the Arts and Cultural Affairs Commission for the LGBTQ+ Commission. Ron congratulated the City on the impressive installation event for Jen Cheng, new City Poet Laureate.

II. CONSENT CALENDAR

III. UNFINISHED BUSINESS

A. Arts Grant Program 2024 WeHo Artist Grant Application Review

The Commission will review, evaluate, and score applications received in response to the City's call for submissions for the WeHo Artist Grant and make funding recommendations.

ACTION:

The Commission directed staff to move this item back to the Performing Arts and Cultural Affairs Subcommittee for review, evaluation, and scores. **Motioned by Commissioner Faltz**, seconded by Commissioner Moreno-Freedman and approved unanimously.

B. Performing Arts and Cultural Affairs Subcommittee Report

The Commission received a report from Vice Chair Deaton on the Performing Arts and Cultural Affairs Subcommittee for its meeting held October 12, 2023 and considered ratifying recommendations proposed by the Subcommittee.

ACTIONS:

- 1) Received and filed the Performing Arts and Cultural Affairs Subcommittee Report.
- 2) Approved the Subcommittee's recommendation to approve the second year Arts Project Grant and third-year Organizational Development Grantees 2024 project proposals, and approval of the proposed projects by Saturday Night Bath Concert Fund and Pieter. **Motioned by Commissioner Faltz**, **seconded by Commissioner Gunther and approved unanimously**.
- 3) Approved the Subcommittee's recommendation to approve two finalists, Ruben Esparza and the LA LGBT Center, for the 2024 WeHo Pride Arts Festival Curator/Producer Request for Qualifications. **Motioned by Commissioner Lee, seconded by Commissioner Gunther and approved noting an abstain vote from Commissioner Faber due to his conflict of interest.**

C. <u>Urban Art Subcommittee Report</u>

The Commission received a report from Commissioner Moreno-Freedman on the Urban Art Subcommittee for its meeting held October 19, 2023 and considered ratifying recommendations proposed by the Subcommittee.

ACTIONS:

- 1) Received and filed the Urban Art Subcommittee Report.
- 2) Approved the Subcommittee's recommendation to approve the STAGE III Final Review of Urban Art Plan for the 1201 Detroit Street (Lexington Gardens) project.
- 3) Received and filed submissions in accordance with the Urban Art Policy and Guidelines.

All actions were combined and motioned by Commissioner Faltz, seconded by Vice Chair Deaton and approved unanimously.

D. Art on the Outside Subcommittee Report

The Commission received a report from Commissioner Faltz on the Art on the Outside Subcommittee for its meeting held October 26, 2023 and considered ratifying recommendations proposed by the Subcommittee.

ACTIONS:

- 1) Received and filed the Art on the Outside Subcommittee Report.
- 2) Approved the Subcommittee's recommendation to approve three (3) artist semi-finalists Tzasna Perez Espinosa, Melissa Fernandez, and Sarah Foelske to each develop a concept proposal for a series of three (3), temporary and site-specific vinyl banners for the West Hollywood City Hall Community Plaza. Motioned by Vice Chair Deaton, seconded by Commissioner Faber and approved unanimously.
- 3) Approved the Subcommittee's recommendation to approve the Commercial Business Mural proposal for 7141 Santa Monica Blvd. (Domain WeHo) and West Hollywood Muralist Roster application from Daniel Monteavaro (MONCHO1929). Motioned by Vice Chair Deaton, seconded by Commissioner Moreno-Freedman and approved unanimously.

A. <u>Design Update for the Laurel House Artist-in-Residence Renovation Project</u>
The Arts and Cultural Affairs Commission received a presentation from the Page &
Turnbull architectural team regarding the draft schematic design architectural plans for the renovation of the Laurel House and Park and provided feedback.

The Arts and Cultural Affairs Commission approved the draft schematic plans for the renovation of the Laurel House and Park. **Motioned by Commissioner Vice Chair Deaton**, seconded by Commissioner Faltz and approved unanimously.

Vice Chair Deaton thanked staff for their hard work. Vice Chair Deaton also shared her excitement for the Jen Cheng, Poet Laureate installation.

Public Art Administrator Marcus Mitchell shared that the 9x9 Mural *Peaches and Tea* by Rebekah Ressler will be installed in November.

Grants Coordinator Eva Angeloff invited the Commission to celebrate the 2023 WeHo Artist Grantees on December 13, 2023 at 6:00 p.m. at the West Hollywood City Council Chambers.

Arts Coordinator Mike Che thanked the Commissioners for attending the City Poet Laureate installation for Jen Cheng. Mike shared that Jen is offering a writing workshop: *Memorable Characters* on October 28 at the West Hollywood Aquatic and Recreation Center. Mike also invited the Commissioners to WeHo Reads x Literary Death Match on November 8 at the West Hollywood City Council Chambers. Mike also invited everyone to a special trilingual version of Drag Story Hour on December 16at the West Hollywood Library Community Meeting Room.

Arts Manager Rebecca Ehemann thanked the Commissioners for their feedback on the Laurel House schematic design architectural plans. Rebecca also shared that she attended the CODAworx Summit, a public art and art technology conference. While at the conference, Rebecca hosted the California Public Art Administrators Membership meeting of which she currently serves as Chair. Rebecca also shared that in next month's meeting, staff will be sharing the results of the Arts and Economic Prosperity 6. Rebecca concluded her comments by stating that all Arts and Cultural Affairs Commission meetings have been cancelled for the month of December due to lack of meeting agenda items.
