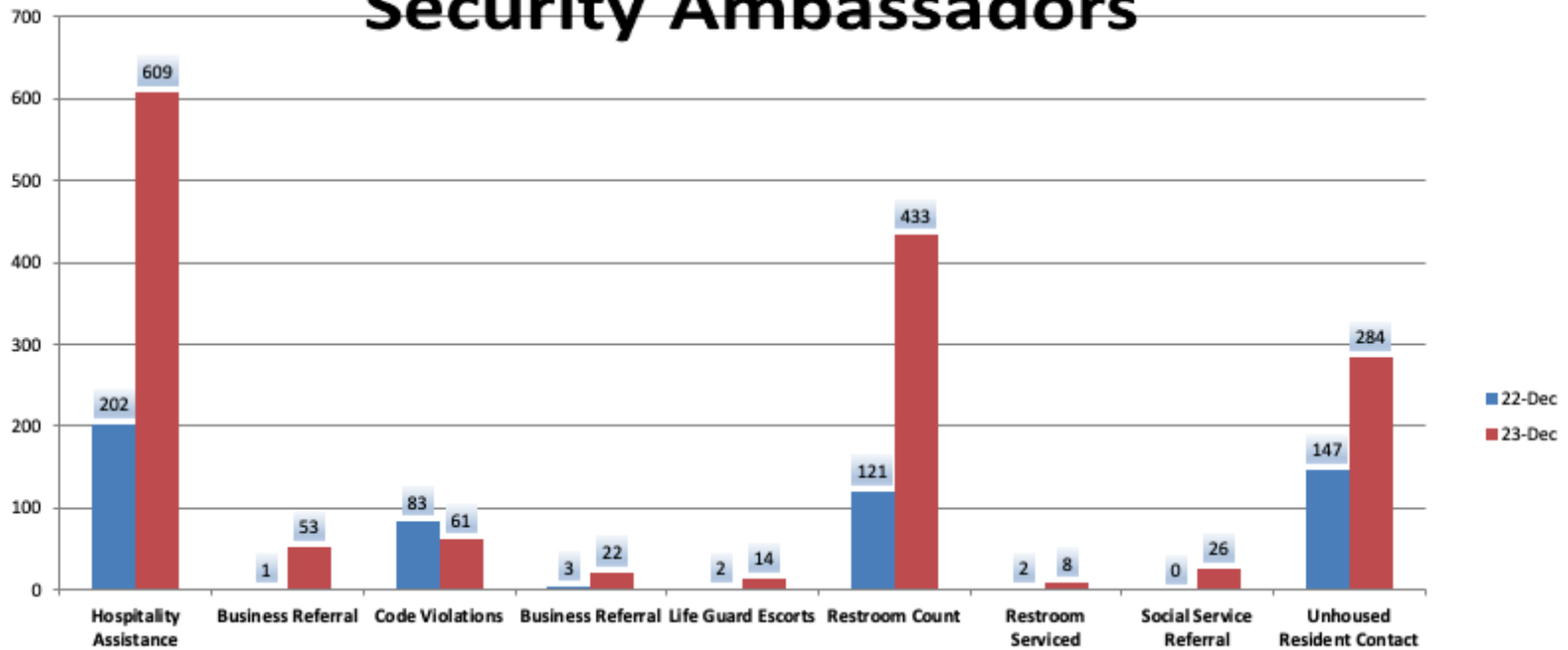

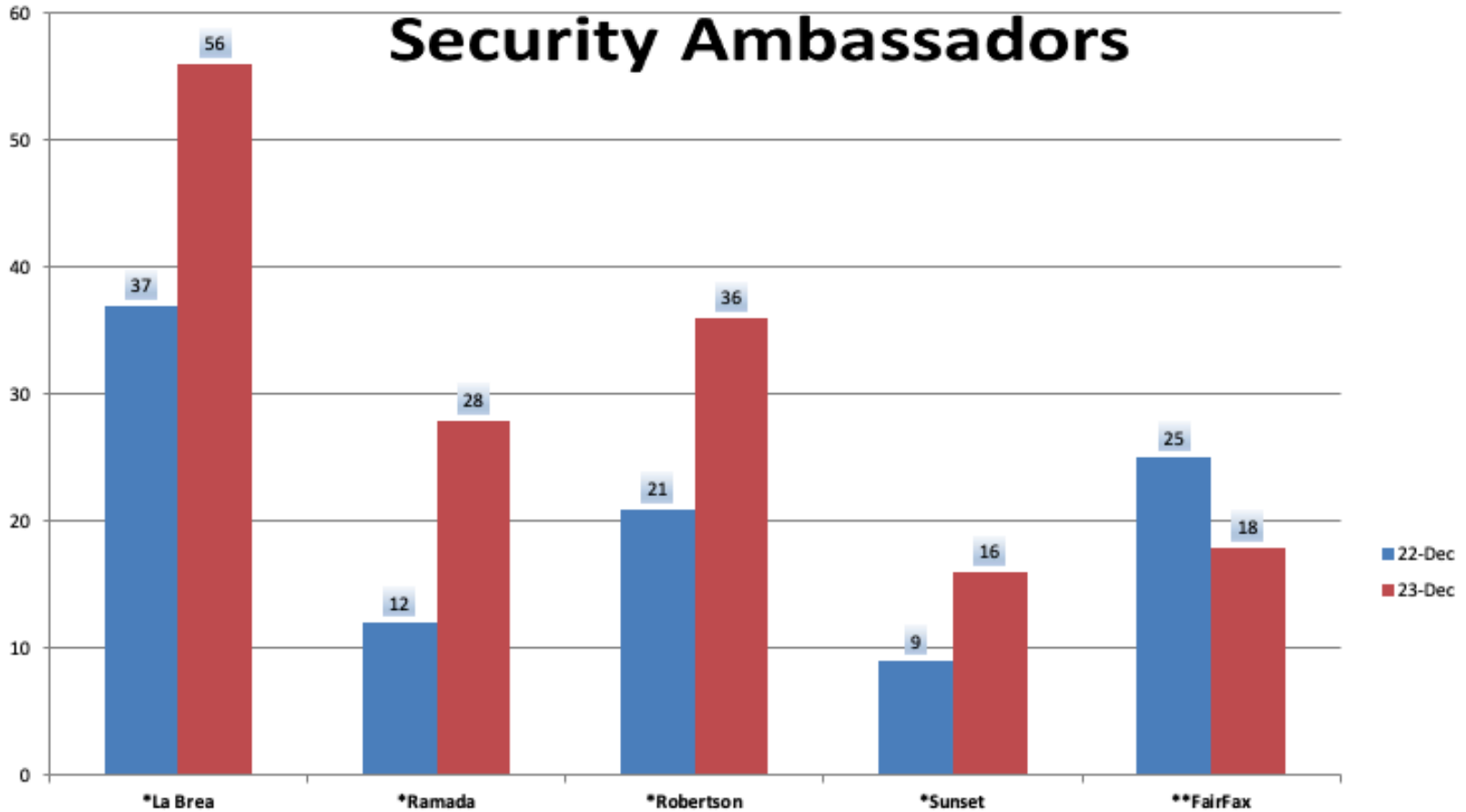
West Hollwood Park - DEC '22 vs. DEC '23

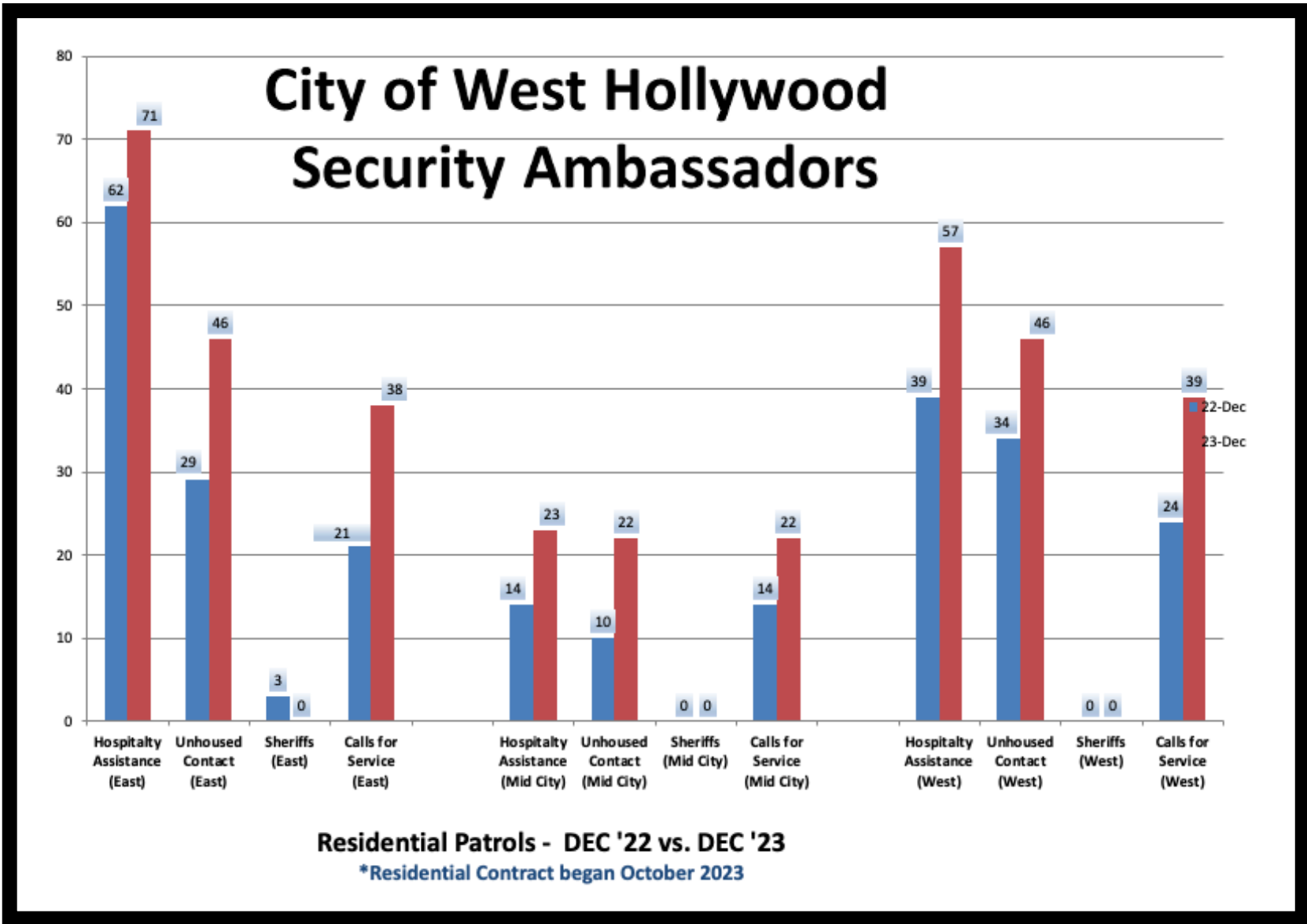

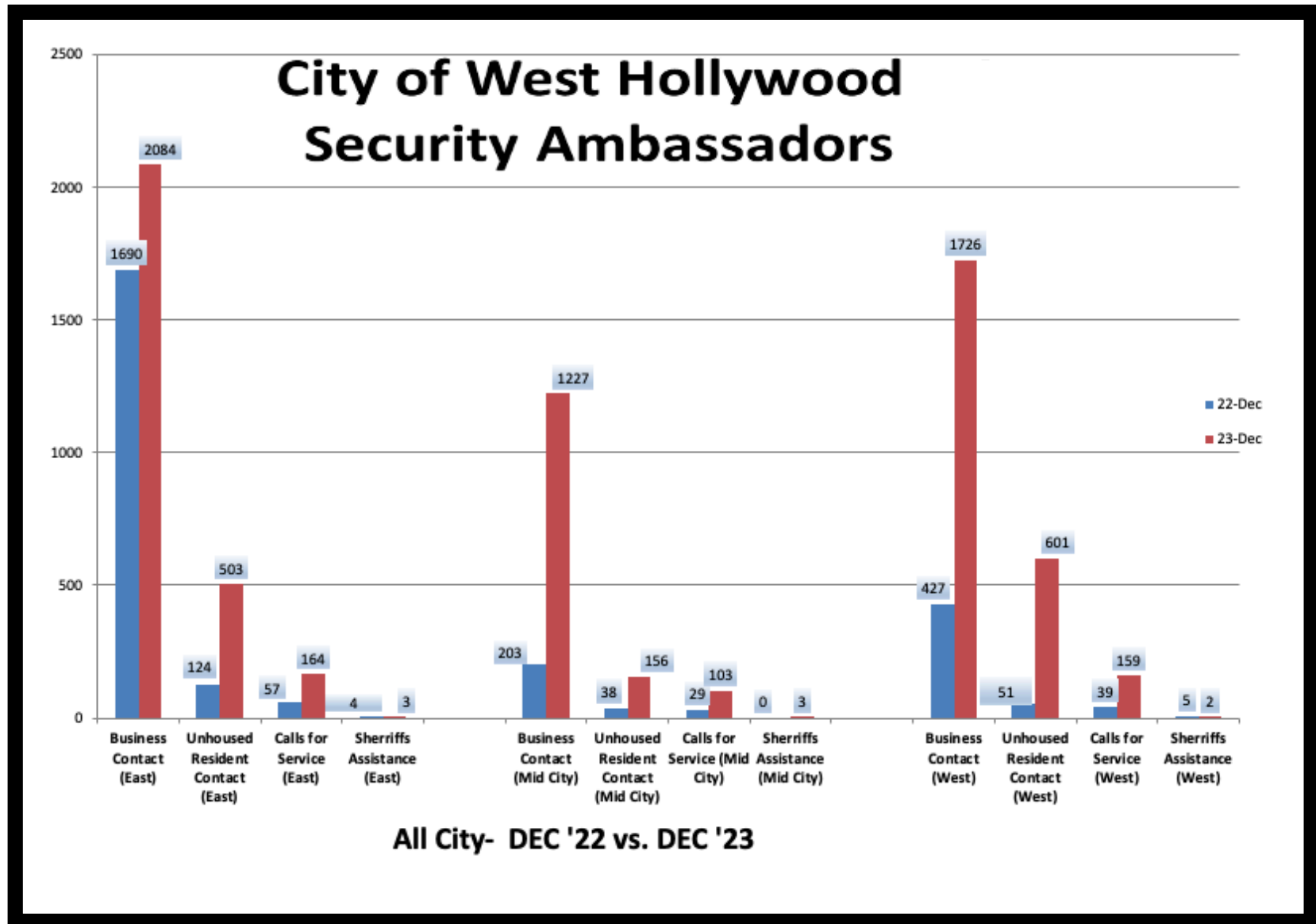
