A. EXPLORATION OF ALTERNATIVE AND ADDITIONAL PUBLIC RESTROOMS

The Human Services Commission received a presentation from Helen Collins, Facilities and Field Services Manager, regarding alternative and additional public restroom locations at existing facilities. Commissioners voiced their level of support and asked clarifying questions regarding safety, security and lighting.

ACTION: Received and filed.

B. UPDATE ON THE WEST HOLLYWOOD PILOT FOR GUARANTEED INCOME

The Human Services Commission received an update on the City's Pilot for Guaranteed Income from Diane Kahn-Epstein, Strategic Initiatives Supervisor, highlighting its aim of addressing financial insecurity and advocating for poverty alleviation through unconditional cash payments. Commissioners expressed support for the program and highlighted the positive impact on participants' lives.

ACTION: Received and filed.

C. HUMAN SERVICES COMMISSION 2024 WORK PLAN

The Human Services Commission reviewed the 2023 Work Plan and discussed its Work Plan for 2024. The Commission agreed to continue discussion of their Work Plan at their January meeting.

ACTION: Received and discussed.

Helen Collins, Facilities and Field Services Division Manager, provided an update regarding the Holloway Project.

6. PUBLIC COMMENT: None.

7. ITEMS FROM COMMISSIONERS:

Commissioner Williams shared her participation in the Warrior Awards and expressed a desire for fellow commissioners to share stories about West Hollywood on their social media, showcasing the services provided by the Human Services Division. She thanked Corri for her longtime dedication to the City.

Commissioner Borelli praised the Warrior Awards honorees, highlighting Dr. Cathy Reback. He expressed excitement for the Holloway Interim Housing Project and thanked Corri for her impactful work, mentioning initiatives like HIV/ZERO.

Commissioner Davis expressed sadness about Corri's departure and recognized her positive impact on the City. He requested adjournment in honor of Sibyl Zaden, acknowledging her contributions dating back to the 80s. Commissioner Davis thanked the Chair and Vice-Chair for the Warrior Awards and appreciated the meaningful stories shared.

Commissioner Palmieri mentioned the closing of McIntyre House. He encouraged RSVPs for the free New Years Eve sober event "VIBEZ" taking place at Plummer Park in Fiesta Hall, praised the Warrior Awards, and shared heartfelt sentiments about Corri leaving.

Vice-Chair Adolphson thanked staff for their hard work on the Warrior Awards, discussed her attendance at West Hollywood Day and encouraged awareness of the Human Services programs. She expressed gratitude for Corri's service to the City.

Chair Eyres expressed appreciation for staff's efforts in setting up the Commission for success with the Warrior Awards. Chair Eyres shared sentiments about Corri leaving and acknowledged her role in setting the City up for continued success.
