- 1. CALL TO ORDER Jasmine Duckworth called the meeting to order at 6:09 pm.
- 2. 5. APPROVAL OF THE AGENDA:

ACTION: Approve the meeting agenda of October 24, 2023. Motion by Advisory Board Member Wilson seconded by Advisory Board Member Washington and approved.

6. APPROVAL OF THE MINUTES:

ACTION: Approve the August 7, 2023 special meeting minutes. Motion by Advisory Board Member Wilson seconded by Advisory Board Member Demuir and approved.

7. PUBLIC COMMENT:

None.

8. NEW BUSINESS:

A. ELECTION OF CHAIR

Melissa Crowder, City Clerk, administered the election for the Chair of the Advisory Board. Board Member Jonathan Wilson nominated himself. There were no other nominations.

ACTION: Election of Board Member Wilson as Board Chair, approved by consensus.

B. ELECTION OF VICE-CHAIR

Melissa Crowder administered the election for the Vice-Chair of the Advisory Board. Board Member Wilson nominated Board Member Giselle Washington. There were no other nominations.

ACTION: Election of Board Member Washington as Board Vice-Chair, approved by consensus.

C. CITY OF WEST HOLLYWOOD HISTORY CONTEXT STUDY

The Social Justice Advisory Board received a summary report on the Historical Context Study prepared by Architectural Resources Group (ARG). ARG staff member Elysha Paluszek, explained the subject for the study, which aimed to examine historical discriminatory policies enacted in the West Hollywood area and how those policies, throughout history, created the economic, social, and spatial landscape of the West Hollywood area.

Paluszek also covered how data was collected, including finding primary and secondary sources in various historical records and archives, as well as conducting

two listening community sessions and collecting comments via a web form.

Paluszek described how the study covers three periods: 1600-1945, 1945-1984, and 1984 to the present. ARG researched general societal trends and legal policies that would have affected any groups of people in West Hollywood. Paluszek stressed that the document includes no recommendations on the enactment or support of future policies, as it is intended to be an informational document to provide context to the City and its decision makers.

Board Members asked questions about the research process and methodology.

Board Member Pier asked if ARG found any trends in social equality movements that progressed slower than others. Paluszek shared that issues related to equality in housing were particularly hard to track and quantify.

Board Member Luna asked if ARG had reached out to indigenous groups or historians that could help connect with those communities and collect information on the indigenous histories in the WeHo area. ARG indicated that they did not initiate contact with any of these groups for the purpose of this study.

Board Member Wilson asked what ARG would likely consider their focus if there was a second round of research to supplement this first study. Paluszek mentioned that herself, personally, would incorporate more of the social history of the West Hollywood Community, focusing on stories that were smaller and community-based rather than of significance to be printed in papers or other archival sources.

ACTION: Receive and file.

D. LEGISLATIVE AFFIARS PRESENTATION

The Social Justice Advisory Board received a presentation from Hernan Molina, Government Affairs Liaison, on the City's Legislative Priorities and reviewed the City's list of opposed/supported legislation.

Hernan reported that the California legislative session works in two-year sessions, and that they are currently in recess. He presented the board with a list of 45 bills in the California legislature that the City is tracking, as well as a list of the City's legislative priorities. Tracked bills include both supported and opposed bills, depending on their alignment with the City's core values and legislative priorities. Hernan asked if there are any glaring irregularities based on the City's list of tracked legislation, or any comments or feedback on the legislative priorities.

Board Member Wilson suggested supporting legislation that provides grant opportunities to support entrepreneurship from underrepresented communities.

Board Member Demuir asked how individuals and small groups from diverse communities can suggest initiating legislation to help the community. Staff member

Molina responded that other than trying to meet directly with representatives and their staff, working with other larger organizations that already do political advocacy work can help push forward new initiatives. Molina stressed that this time, during a California Legislative recess, is when elected officials are typically more able to listen to their communities about future laws and policies.

ACTION: Receive and file, provide input on the priorities.

E. REVIEW OF SOCIAL JUSTICE TASK FORCE RECOMMENDATIONS AND DISCUSS DIVISION/DEPARTMENT UPDATES AT FUTURE SOCIAL JUSTICE ADVISORY BOARD MEETINGS

The Social Justice Advisory Board reviewed the Social Justice Task Force's recommendations and discussed the prioritization of which City Departments/Division should be invited to future Advisory Board meetings to provide updates.

The Board debated on the priority of how they should move forward on implementation. The Board debated multiple strategies including: beginning on sections that may be faster to implement; beginning on sections that the community might feel is more important; or working with homelessness first as a kind of baseline that other aspects will build upon.

Board Member Wilson suggested that there should be more frequent meetings to follow through with implementations. Staff mentioned that the process of implementation of these policies will take a long time, and more regular meetings will not increase the pace in which the work will take place within each relevant division.

Board Member Luna suggested starting with Economic Development goals, as there is no body that reviews economic development policies, and therefore the board may have a larger impact on setting policy on those areas.

ACTION: By unanimous consensus, the Board decided to move towards implementing the policies in the following order: Economic Development, Public Safety, Homelessness.

9. ITEMS FROM STAFF

Staff Liaison, Jasmine Duckworth, announced that the Board will be asked to make liaison appointments to other City Board and Commissions at the next meeting. In addition, the Board will also discuss plans for the hosting of the City's Juneteenth celebration in 2024.

10. PUBLIC COMMENT

None.

11. ITEMS FROM ADVISORY BOARD MEMBERS

Advisory Board Member Luna expressed their gratitude and hope for the future.

Advisory Board Member Seperak talked about discrimination and community spaces that are lost and how that impacts the city.

Advisory Board Member Washington requested a progress report on the public safety item heard by the Board in August.

Advisory Board Member Wilson put forward a motion to request that City staff and the City Clerk put forth a process so that the Board can meet more than quarterly. The motion was seconded by Board Member Washington and approved unanimously.

Board Member Wilson also put forward a motion to request a special meeting between now and the January meeting. The motion was seconded by Board Member Seperak and approved unanimously.

Board Member Wilson also put forward a motion to request that the Center for Police Equity be invited to give a presentation to the Board that was given to the Public Safety Commission and City Council. The motion was seconded by Boardmember Luna and approved unanimously.

12. ADJOURNMENT
