2. CONSENT CALENDAR

A. APPROVAL OF MINUTES

ACTION: The Disabilities Advisory Board approved minutes of the October 18, 2023 meeting.

3. NEW BUSINESS

A. LEGISLATIVE PRIORITIES

The Disabilities Advisory Board received a debrief from staff on the City's Legislative Priorities.

Hernan Molina, Governmental Affairs Liaison, provided the Board with background information on Bills that the City has supported in the last year, legislative background information on some of the City's first ordinances, and specific regulations for persons living with disabilities such as, ADA modifications to include expanded protections and accessibility.

Board Member Watts questioned AB2449 and the City's understanding of it. Mr. Molina will follow up with Board Member Watts, directly.

Vice Chair Smith requested the City to provide more advocacy for persons living with disabilities in the healthcare industry.

Board Member Semonco shared her experience as a board member affected by AB2449 and dealing with healthcare facilities as a person living with disabilities.

Board Member Watts requested access to vaccinations in healthcare facilities. He was encouraged to bring this to the attention of Los Angeles County.

ACTION: The Disabilities Advisory Board provided feedback to staff for legislative priorities in support of persons living with disabilities.

4. UNFINISHED BUSINESS

A. DISABILITIES AWARENESS MONTH DEBRIEF

The Disabilities Advisory Board reviewed the 2023 Disabilities Awareness Month activities.

Staff provided an overview of the services and feedback from participants and providers of the Community Health and Wellness Event.

Board Member Nash noted the attendance for the Community Health and Wellness event.

Board Member Watts requested the Board return to having a subcommittee to assist with the event planning. He requested tree trimming to be completed beforehand to ensure the viability of the street banners. He requested the Board's inclusion in the design process of marketing materials.

Vice Chair Smith requested to have more information on Channel 10.

Board Member Schwartz requested to have the health event over the weekend at West Hollywood Park with the option of a food truck.

Board Member Mann supported the suggestions to host the event on a weekend, have a subcommittee, and to work with other boards and commissions.

Staff suggested the Board have an agenda item for a subcommittee and ways to commission for more funding for Disabilities Awareness Month events.

Board Member Nash requested news outlets be alerted.

Chair Dore requested the Board to use their connections to alert the public of the Disabilities Awareness Month events.

Chair Dore expressed her appreciation of the layout and Board participation at the Service Awards.

Board Member Nash shared the lack of space with the City step and repeat, chairs, and entertainment.

Board Member Schwartz shared his discomfort with the tables.

Chair Dore asked about the budget and was directed to address the Council. She requested the subcommittee to write a letter to the City Manager and asked to have a budget item to be on the agenda for January.
