the existing entitlements for a new nine-story and approximately 116,801-square-foot multi-use commercial building containing a private club (including lounges, dining rooms, outdoor terraces, ground floor art gallery, and rooftop deck), creative office, ground floor retail and restaurant with outdoor dining uses over a full valet operated underground parking garage with 279 parking spaces located at 8920 Sunset Boulevard for one year until April 1, 2024, and an ordinance to extend the term of the entitlements for this building at 8920 Sunset Boulevard for an additional

six months until October 1, 2024.
